1. DISCLOSURES OF INTEREST

- (4) Officers must disclose interests in accordance with Council Standing Order 44.

1. SUMMARY

The application is for the grant of a Premises Licence for the sale of alcohol for consumption off the premises.

2. BACKGROUND

2.1 The applicants

Mrs Jolita Dubniakoviene. A copy of the application is attached at Appendix 1.

2.2 The Premises

My Euro Basket, 125 Horton Grange Road, Bradford.

2.3 Proposed Designated Premises Supervisor

Mrs Jolita Dubniakoviene.

2.4 Application

The application is for the grant of a Premises Licence. The operating schedule describes the following as the relevant licensable activities applied for:-

• Sale of alcohol for consumption off the premises

Hours of licensable activities:

Monday to Sunday: 09.00 to 22.00

2.5 Steps proposed by the applicant to address the Licensing Objectives

a) Prevention of crime and disorder will be achieved by;

Drugs policies/notices. Provision of adequate lighting. Search policies.

b) Public safety will be achieved by;

Provision of emergency lighting. CCTV system outside.

c) Prevention of public nuisance will be achieved by;

Provision and use of a noise limiting device.





d) Protection of children from harm will be achieved by;

Proof of age scheme.

e) General – all four licensing objectives

Installing a suitable CCTV system. Staff training on licensing issues.

2.6 Relevant Representations Received

Responsible Authorities

West Yorkshire Police

In order to address the prevention of crime and disorder objective, the Police have requested that the following conditions are placed on the Licence;

- 1. CCTV will be provided in the form of a recordable system, capable of providing pictures of evidential quality in all lighting conditions. Cameras shall encompass all ingress and egress to the premises and all areas where the sale of alcohol occurs. Equipment must be maintained in good working order, be correctly time and date stamped and recordings be kept for a period of 28 days. The premises licence holder must ensure at all times the DPS or appointed member of staff is present on the premises and capable and competent at downloading CCTV footage in a recordable format, either DISC or VHS to the Police or Licensing Authority on request. The recording equipment and tapes/discs shall be kept in a secure room and endorsed by signature indicating that the CCTV system has been checked and is compliant. In the event of any failings of the CCTV equipment, the premises licence holder/DPS must report the failure to the Bradford District Police Licensing Officer and Local Authority immediately.
- 2. A Challenge 25 policy shall be in place during all licensable activities.
- 3. A refusals Register shall be in place and endorsed by all members of staff with date, time and details of refused product.
- 4. At all times the premises are open for licensable activities, members of staff must be able to communicate sufficiently to enable them to promote the four licensing objectives.

The applicant has agreed to the conditions being placed on the Licence.

Individual, Body or Business

Two representations and a petition have been received from Ward Councillors and individuals. The representations raise concerns of an increase in anti-social behaviour in the area should the application be granted.

The representations are attached at Appendix 3.

3. OTHER CONSIDERATIONS

Legal Appraisal

- **3.1** The Licensing Act 2003 requires the Council to carry out its various licensing functions so as to promote the following four licensing objectives:
 - a) the prevention of crime and disorder
 - b) public safety
 - c) the prevention of public nuisance
 - d) the protection of children from harm
- **3.2** The Council must also have regard to the guidance issued by the Home Office under Section 182 of the Licensing Act 2003. Regard must also be taken of the Council's statement of Licensing Policy for the District.
- **3.3** Where it is decided it is necessary to depart from the statutory guidance or the Licensing Policy on the merits of a particular case; then special reasons justifying this must be given that can be sustained.
- **3.4** Only "relevant representations" can be taken into account. In order to be "relevant" a representation must fairly relate to achieving a licensing objective. If it does not, it must be discounted.
- **3.5** Any licensing conditions that Members may propose attaching must also relate to achieving one of the licensing objectives; be tailored to the actual premises and style of licensable activity; must be reasonably achievable by the applicant and in his/her control.

Statement of Policy Issues

- **3.6** The following parts of the Licensing Policy are of particular importance; Part 4 (prevention of crime and disorder) and Part 6 (prevention of public nuisance).
- **3.7** The Annexes to the Policy sets out various types of model condition that could be considered.

4. OPTIONS

4.1 Members may:

- (a) Grant a premises licence as applied for subject to any mandatory conditions and the precautions specified in the operating schedule submitted.
- (b) Grant a premises licence subject to such additional conditions relating to achievement of the licensing objectives as members think fit; or
- (c) Refuse the application for a premises licence.
- **4.2** Should the applicant or any other party to the hearing feel aggrieved at any decision with regard to the licence or to any conditions or restrictions attached by Members they may appeal to the Magistrates Court.

1. SUMMARY

The application is for the grant of a Premises Licence for the sale of alcohol for consumption off the premises.

2. BACKGROUND

2.1 The applicants

Mr Ali Mohammedi. A copy of the application is attached at Appendix 1.

2.2 The Premises

K & H News, 122C Morley Street, Bradford.

2.3 Proposed Designated Premises Supervisor

Mr Ali Mohammedi.

2.4 Application

The application is for the grant of a Premises Licence. The operating schedule describes the following as the relevant licensable activities applied for:-

• Sale of alcohol for consumption off the premises

Hours of licensable activities:

Monday to Sunday: 07.00 to 00.00

2.5 Steps proposed by the applicant to address the Licensing Objectives

a) Prevention of crime and disorder will be achieved by;

A CCTV system will be in operation at the premises and recorded images shall be retained for a period of 28 days. Downloads will be provided to the police and other authorities upon reasonable request in line with the DPA.

A register of refusals of alcohol will be maintained at the premises. The register shall be examined on a regular basis by the duty manager/DPS and the date and time of each examination will be endorsed in the register. The register will be made available for inspection by the Police and other authorised officers of the Council upon reasonable request.

All alcohol & tobacco products will be purchased over the counter or from people calling at the shop.





All receipts and invoices (or copies) will be held on the premises and made available for inspection by the authorities on reasonable request.

b) Public safety will be achieved by;

The Premises Licence Holder is aware of their responsibilities in relation to current legislation.

An incident register will be maintained at the premises and made available to the authorities on request.

c) Prevention of public nuisance will be achieved by;

A CCTV monitor will be displayed in the shop in full view of customers.

A notice will be on display asking that the customers leave the area quietly and respect the local residents.

All staff at the store will be trained in how to manage any person who they suspect may create a public nuisance in the area of the store. Such people will be asked to leave the are quietley (if safe to do so) an entry will be made in the incident register.

d) Protection of children from harm will be achieved by;

The premises will adopt a 'Challenge 25' policy. This means that if a cutomer purchasing alcohol appears to be under the age of 25 they will be asked for proof of their age, to prove that they are 18 years or older.

Posters will be on display advising customers of the 'Challenge 25' policy.

The only forms of identification that will be accepted at the premises are a passport, photo-card driving licence or cards bearing the 'PASS' hologram.

Staff will be trained below making sales of alcohol in their responsibilities under the Licensing Act 2003. Training will be documented and made available to the Police and authorised officers of the Council upon reasonable request.

e) General – all four licensing objectives

In order to address the prevention of crime and disorder objective, the Police have requested that the following conditions are placed on the Licence;

- 1. CCTV will be provided in the form of a recordable system, capable of providing pictures of evidential quality in all lighting conditions. Cameras shall encompass all ingress and egress to the premises and all areas where the sale of alcohol occurs. Equipment must be maintained in good working order, be correctly time and date stamped and recordings be kept for a period of 28 days. The premises licence holder must ensure at all times the DPS or appointed member of staff is present on the premises and capable and competent at downloading CCTV footage in a recordable format, either DISC or VHS to the Police or Licensing Authority on request. The recording equipment and tapes/discs shall be kept in a secure room and endorsed by signature indicating that the CCTV system has been checked and is compliant. In the event of technical failure of the CCTV equipment, the premises licence holder/DPS must report the failure to the Bradford District Police Licensing Officer and Local Authority immediately.
- 2. A Challenge 25 policy shall be in place during all licensable activities.
- 3. A refusals Register shall be in place and endorsed by all members of staff with date, time and details of refused product.
- 4. All staff will be trained regarding their responsibilities under the Licensing Act prior to making sales of alcohol, Refresher Training will take place every quarter and all training will be documented and made available to the Authorities upon request.
- 5. At all times the premises are open for licensable activities, members of staff must be able to communicate sufficiently to enable them to promote the four licensing objectives.
- 6. A Personal Licence Holder will be on site at all times that the premises are open for Licensable Activities.

The applicant has agreed to the conditions being placed on the Licence.

The representation is attached at Appendix 2.

Individual, Body or Business

A representation has been received from a Ward Councillor. The representation raises concerns of an increase in anti-social behaviour in the area should the application be granted.

3. OTHER CONSIDERATIONS

Legal Appraisal

- **3.1** The Licensing Act 2003 requires the Council to carry out its various licensing functions so as to promote the following four licensing objectives:
 - a) the prevention of crime and disorder
 - b) public safety
 - c) the prevention of public nuisance
 - d) the protection of children from harm
- **3.2** The Council must also have regard to the guidance issued by the Home Office under Section 182 of the Licensing Act 2003. Regard must also be taken of the Council's statement of Licensing Policy for the District.
- **3.3** Where it is decided it is necessary to depart from the statutory guidance or the Licensing Policy on the merits of a particular case; then special reasons justifying this must be given that can be sustained.
- **3.4** Only "relevant representations" can be taken into account. In order to be "relevant" a representation must fairly relate to achieving a licensing objective. If it does not, it must be discounted.
- **3.5** Any licensing conditions that Members may propose attaching must also relate to achieving one of the licensing objectives; be tailored to the actual premises and style of licensable activity; must be reasonably achievable by the applicant and in his/her control.

Statement of Policy Issues

- **3.6** The following parts of the Licensing Policy are of particular importance; Part 4 (prevention of crime and disorder) and Part 6 (prevention of public nuisance).
- **3.7** The Annexes to the Policy sets out various types of model condition that could be considered.

4. OPTIONS

- 4.1 Members may:
 - (a) Grant a premises licence as applied for subject to any mandatory conditions and the precautions specified in the operating schedule submitted.
 - (b) Grant a premises licence subject to such additional conditions relating to achievement of the licensing objectives as members think fit; or





- (c) Refuse the application for a premises licence.
- **4.2** Should the applicant or any other party to the hearing feel aggrieved at any decision with regard to the licence or to any conditions or restrictions attached by Members they may appeal to the Magistrates Court.

Equipment must be maintained in good working order, be correctly time and date stamped and be kept for a period of 28 days. The premises licence holder must ensure at all time the DPS or appointed member of staff present on the premises and capable and competent at downloading CCTV footage in a recordable format, either DISC or VHS to the police or Licensing Authority on request. The recording equipment and tapes/discs shall be kept in a secure room and endorsed by signature indicating that the CCTV system has been checked and is compliant. In the event of any failings of the CCTV system, this shall also be recorded and in the event of technical failure, the premises licence holder/DPS must report the failure to the Bradford District Police Licensing Officer and the Local Authority immediately.

A check 25 policy to be in place during all licensable activities.

Refusals Registrar shall be in place and endorsed by all members of staff with date, time and details of refused product.

At the request of an authorised officer of the Licensing Authority of a Responsible Authority (under the Licensing Act 2003) any CCTV footage, as requested, will be downloaded immediately or secured to prevent any overwriting. The CCTV footage material will be supplied, on request, to an authorised officer of the Licensing Authority or a Responsible Authority viewing. A record will be kept of who has accessed the system, the reason why and when.

Provide adequate lighting.

b) Public safety will be achieved by;

In relation to age restricted sales the company will implement and maintain a refusals log system which will be regularly monitored in compliance with existing company policy.

Display Public Notices

Work with Police and local PCSOs in order to resolve any public issues.

The PLH/DPS will ensure that an Incident Report Register is maintained on the premises to record incidents such as anti-social behaviour, admissions refusals and ejections from the premises.

Litter collection in daylight hours.

c) Prevention of public nuisance will be achieved by;

The PLH/DPS will ensure that litter arising from people using the premises is cleared away regularly and that promotional materials such as flyers do not create litter.

2.6 Relevant Representations Received

Responsible Authorities

West Yorkshire Police

In order to address the prevention of crime and disorder objective, the Police have requested that the following conditions are placed on the Licence;

- 1. CCTV will be provided in the form of a recordable system, capable of providing pictures of evidential quality in all lighting conditions. Cameras shall encompass all ingress and egress to the premises and all areas where the sale of alcohol occurs. Equipment must be maintained in good working order, be correctly time and date stamped and recordings be kept for a period of 28 days. The premises licence holder must ensure at all times the DPS or appointed member of staff is present on the premises and capable and competent at downloading CCTV footage in a recordable format, either DISC or VHS to the Police or Licensing Authority on request. The recording equipment and tapes/discs shall be kept in a secure room and endorsed by signature indicating that the CCTV system has been checked and is compliant. In the event of any failings of the CCTV equipment, the premises licence holder/DPS must report the failure to the Bradford District Police Licensing Officer and Local Authority immediately.
- 2. A Challenge 25 policy shall be implemented.
- 3. A Refusals Register shall be in place and endorsed by all members of staff with date, time and details of refused product.

The applicant has agreed to the conditions being placed on the Licence.

The representation is attached at Appendix 2.

Individual, Body or Business

Seven letters, 12 pro-forma letters and a petition have been received from Ward Councillors and Individuals. The representations raise concerns of an increase in anti-social behaviour, criminal damage and noise and disturbance from intoxicated individuals who congregate in the area.

Included with Cllr Ahmed's representation is documentation of issues in the area.

A copy of the documentation is attached at Appendix 4. (In the interests of economy this document has been sent to Members of the Panel only.)

Legal Appraisal

 - a) the prevention of crime and disorder
 - b) public safety
 - c) the prevention of public nuisance
 - d) the protection of children from harm
- **3.2** The Council must also have regard to the guidance issued by the Home Office under Section 182 of the Licensing Act 2003. Regard must also be taken of the Council's statement of Licensing Policy for the District.

- **3.4** Only "relevant representations" can be taken into account. In order to be "relevant" a representation must fairly relate to achieving a licensing objective. If it does not, it must be discounted.
- **3.5** Any licensing conditions that Members may propose attaching must also relate to achieving one of the licensing objectives; be tailored to the actual premises and style of licensable activity; must be reasonably achievable by the applicant and in his/her control.

Statement of Policy Issues

- **3.6** The following parts of the Licensing Policy are of particular importance; Part 4 (prevention of crime and disorder) and Part 6 (prevention of public nuisance).
- **3.7** The Annexes to the Policy sets out various types of model condition that could be considered.

CCTV will be provided in the form of a recordable system, capable of providing pictures of evidential quality in all lighting conditions. Cameras shall encompass all ingress and egress to the premises and all areas where the sale/supple of alcohol occurs. Equipment must be maintained in good working order, be correctly time and date stamped and be kept for a period of 28 days. The premises licence holder must ensure at all time the DPS or appointed member of staff present on the premises and capable and competent at downloading CCTV footage in a recordable format, either DISC or VHS to the police or Licensing Authority on request. The recording equipment and tapes/discs shall be kept in a secure room and endorsed by signature indicating that the CCTV system has been checked and is compliant. In the event of any failings of the CCTV system, this shall also be recorded and in the event of technical failure, the premises licence holder/DPS must report the failure to the Bradford District Police Licensing Officer and the Local Authority immediately.

I write this letter in the capacity as Secretary of the Grantham Residents Association (GRA). I refer to the application for the Sale of alcohol for consumption off the premises Monday to Sunday 07.00 to 23.00 at the address above.

As Secretary I object strongly to this application on behalf of all the members of the GRA who are local residents directly affected by this application on the following grounds:-

The protection of children from harm

The site for the sale of alcohol is in close proximity of two large Dixons (Trinity and McMillan) secondary schools both also have nurseries attached. Both these schools are situated on Trinity Road close by. The area around Laistridge Lane is already festooned with used drug needles and drunks who are a hazard to the school children. The possible granting of this alcohol license which will permit the selling of alcohol will only exacerbated the problem.

Furthermore, there have already been altercations outside Baba Jaga on multiple occasions since opening recently with one incident requiring the attendance of the police. This will only get worse if an alcohol license is granted. We already have a problem with cheap availability of alcohol causing disorderly and threatening behaviour of drunks. School children both in the morning and at school closing time should not have to confront this.

The prevention of crime and disorder

The GRA was set up in early April 2016 due to the ongoing issue of excessive crime and drunk disorderly behaviour which is prevalent in area of Laisteridge Lane. Over the last two years residents who have lived in the immediate area have seen huge number of new people of east European extraction come to the area. As such there has been a massive increase in the availability of cheap east European alcohol from at least three shops locally. We regularly see drunks who conjugate around shops and houses near them and who regularly urinate, inject and deposit faeces where they see fit.

The GRA after having meetings with both Inspector Tom Horner, local councillors and our ward police officer Simon have drawn up an action plan to address this issue. If Baba Jaga is permitted to sell alcohol from 7am to 11pm this will only make it harder for all interested parties to combat drunkenness and the disorderly behaviour drunks cause.



Public safety

By far the greatest issue raised in meetings of the GRA is the intimidation residents feel from the drunks and drug addicts that they see on a daily basis on Laistridge Lane and surrounding streets. So much so, that the GRA and residents have petitioned the council to extend a PSPO (public safety protection order) which specifically prohibits the consumption of alcohol from the city centre to include Laistridge Lane and the rest of the local area covered by the GRA. We are backed in this by our local Ward Police Officer Simon and his team who have to deal with drunks on a daily basis in our area.

Huge efforts have been made through the GRA and the action plan created by Masood (our council ward officer) and Tom Horner our local inspector to tackle this intimidation by drunks. All this good work would be undone by granting another local shop in the middle of our area a licence to sell alcohol from 7am to 11pm. The licensing team must take notice of the problems we have in our area and not exacerbate them.

Prevention of public nuisance

Local residents who have lived all their lives in the locality felt powerless to tackle the huge increase substance and alcohol abuse. They setup the GRA to apply pressure to both the police and Bradford Council. The alcohol abuse as mentioned above results in local residents witnessing drunks urinating in public and exhibiting threatening behaviour to residents.

A lot of good work has been achieved in a small amount of time by the GRA. After constant pressure via the GRA, Bradford Council have installed 5 strategically placed CCTV cameras to tackle both drug and alcohol nuisance. The cameras will help police the area but if this license is granted then I am afraid the problems of drunks causing public nuisance will only get worse and negate the effect these cameras will have on reducing the problem.

Local residents regularly meet as the Grantham Residents Association to ensure the streets are a clean and safe environment not just for themselves but also for the huge number of both national and international students who study at Bradford University and the college.

What kind of image of Bradford will the Bradford Council licensing Team give to these students to take back home? If they have to endure threatening behaviour from drunks and addicts I am sure they will not talk proudly of Bradford. The council is doing its bit by providing cameras, investing in the city centre via the city park. The licensing team will undermine all our hard work if they grant a license. We therefore as a residents association strongly urge you to please reject this application to safeguard all local residents.

I wish to object to the alcohol licence application submitted by Baba Jaga, 15 Laisteridge Lane/ 2 Merton Road, Bradford, BD7 1QU/ Arian Karim as listed on the Bradford Council website that requests for the sale of alcohol for consumption off the premises Monday to Sunday 07:00 to 23:00.

On behalf of Bradford College and the local area, I object to the application on the following grounds:

Pollution

As it currently stands, we have a significant issue with regards to pollution caused by individuals who are purchasing alcohol from local convenience stores. It can be found that these individuals consume the alcohol they have purchased outside the premises and around the surrounding streets, failing to adequately dispose of their cans/bottles, and instead litter these on the floor/in bushes, etc. The approval of the above alcohol licence application would only worsen this situation and have a further disruptive impact on the local infrastructure. This is of particular interest to Bradford College, as frequent events are held for potential students, who come to view the facilities offered when deciding on an institution to continue their education. The build-up of litter such as the endless cans/bottles could prove detrimental to this process and acts as deterrence for those considering Bradford College and other local intuitions. This is of particular interest when considering the significant investment that has been made for the new college buildings and facilities.

The safeguarding of students

Bradford College currently has 24,000 students enrolled across the many courses we offer, and holds a duty of care for these students throughout the duration of their study. It is in the best interests of these students that the above alcohol licence application is not approved as the sale of such alcohol could pose a danger to their wellbeing. To illustrate, individuals that are purchasing/consuming alcohol from local convenience stores become very disruptive and sometimes abusive towards the local community, which is significant when considering those students who live in the local area and walk to College, as well as to students that decide to leave the campus during their breaks/lunches. Moreover, there is also a risk that alcohol may be purchased on the behalf of students by individual's entering the store, especially considering alcohol would be on sale from 7am before the students start college, without which would prevent a potentially significant issue.

I refer to the above matter. I understand that the above party has submitted an application for an alcohol license. I, on behalf of the local residents participating in the Neighbourhood Watch Scheme, object to this on the following grounds:

The prevention of crime and disorder

This area has been subjected to high levels of crime and disorder. We have an ongoing problem with drunks who regularly urinate, inject and deposit faeces where they see fit. We have several streets around the Laisteridge Lane area which are littered with 100's of syringes dropped onto pavements, children's play areas and this areas os now saturated with drunks and homeless people. This problem has become so widespread that Inspector Tom Horner and local councillors have had to draw an action plan to combat this. By providing a licence to a retail outlet to sell alcohol from 7am to 11pm will only further exacerbate the existing problem to the detriment of the local community.

Public safety

Laisteridge Lane and surrounding areas are subjected to problems with alcohol and substance abuse. It cannot be in the public's interest to further compound this by allowing the above shop to sell alcohol from 7am til late. There is also a primary school and another school being built only 20 yards away. Schoolchildren will inevitably come into close contact with drunk and disorderly individuals which will then become a safeguarding issue. Local residents are finding individuals who are intoxicated by drugs and alcohol, in their gardens, on street corners and outside local shops. By granting the licence the Council is putting the public at risk.

Prevention of public nuisance

We have already identified that this area is saturated with problems of crime, drugs and alcohol abuse. By providing alcohol from 7am to 11pm, instances of public nuisances will increase tenfold. Laisteridge Lane has already been identified as an alcohol exclusion zone and it would be against the grain to them grant this business a licence. In addition the Council are expending thousands of pounds on new CCTV to police the area. The granting of this licence would defeat the purpose of discouraging public nuisance.

The protection of children from harm

By granting the licence the Council will be placing hundreds of children at risk of real harm. The children in the area are already at risk from harm from the 100's of needles thrown on the ground by those injecting themselves and those that are drunk. We are seeing more and more drunks in the area which has increased by more than 80% in the last 2-3 years. By providing a licence to this shop, the Council is subjecting the school children and local children to significant harm.

Local residents are taking part in the Neighbourhood Watch Scheme to ensure the streets are safe not only for themselves but their children also. Bradford Council will be undermining this scheme by granting the application. We urge you to reject the application.


