40. MINUTES

43. THE CHARLES SEMON EDUCATIONAL FOUNDATION TRUST AND THE

ALLOCATION OF GRANT FUNDING

The Strategic Director of Children's Services submitted a report (**Document "I"**) which provided an update on the current position and intended grant allocations from The Charles Semon Educational Foundation Trust.

Established in 2003, following sale of a convalescent home and associated land, the income generated from this sale, as stipulated in the deeds of the then owners, was split between Bradford Girls School, Bradford Grammar School and the Local Education Authority. This report focused on the Local Education Authority element of the fund.

Information was provided on how the funding would be utilised to take identified young people on a residential trip/stay in line with the aims and objectives of the charity, the details of which were set out in the report.

In response to a question regarding the cost of providing the outdoor residential, it was stressed that this would be provided at a subsidised rate.

Members welcomed the proposed spending and that it would enhance the life experiences of some of the most vulnerable young people in the district, and it was therefore:

Resolved-

- (1) That members acknowledged and approved the proposals outlined in Appendix A to Document "I" for the allocation of grant funding from The Charles Semon Educational Foundation Trust for 2023-24 and 2024-25.
- (2) That members receive an updated report in February 2025 that reports back to the committee the outcomes from the proposal and that further outlines the intended allocation of grant funding from The Charles Semon Educational Foundation Trust for the future.
