**THE MODIFIED DEFINITIVE MAP AND STATEMENT FOR BRADFORD**

**PUBLIC FOOTPATH NO. 672 (BRADFORD SOUTHERN)  
BETWEEN HUDDERSFIELD ROAD AND WOODSIDE ROAD, WYKE, BRADFORD  
(MODIFICATION) ORDER 2023**

This Order is made by the City of Bradford Metropolitan District Council under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears to the council that the Definitive Map and Statement for Bradford require modification in consequence of the occurrence of an event specified in Section 53(3)(c)(i) of the Act, namely the discovery by the council of evidence which (when considered with all other relevant evidence available to them) shows: -

(i) that rights of way which are not shown in the map and statement subsist or are reasonably alleged to subsist over land in the area to which the map relates, being rights of way such that the land over which the rights run are public paths

There is no other local authority whose area includes the land to which the Order relates, and which the council would be able to consult. The City of Bradford Metropolitan District Council hereby orders that:

1. For the purposes of the Order the relevant date is 8<sup>th</sup> day of August 2023.
2. The Definitive Map and Statement for Bradford shall be modified as described in Part 1 and Part 2 of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the "City of Bradford Metropolitan District Council (Public Footpath No. 672 (Bradford Southern) at Huddersfield Road and Woodside Road, Wyke, Bradford (Modification) Order 2023".

Description of Public Right of Way to be added:

A public footpath in the former Urban District of Bradford as shown by a broken black line on the map annexed hereto, commencing at Huddersfield Road at Grid Reference: SE 1531 2717, (marked A) and continuing in a north west direction for 39 metres with a width of 1.8 metres and a surface of compacted earth and part paved to Woodside Road at Grid Reference: SE 1528 2720, (marked B).

To be identified as Public Footpath No.672, Bradford Southern. All distances are as measured electronically. There are 10 steps at the start of the footpath on Woodside Road. National Grid Reference: SE 1527SW

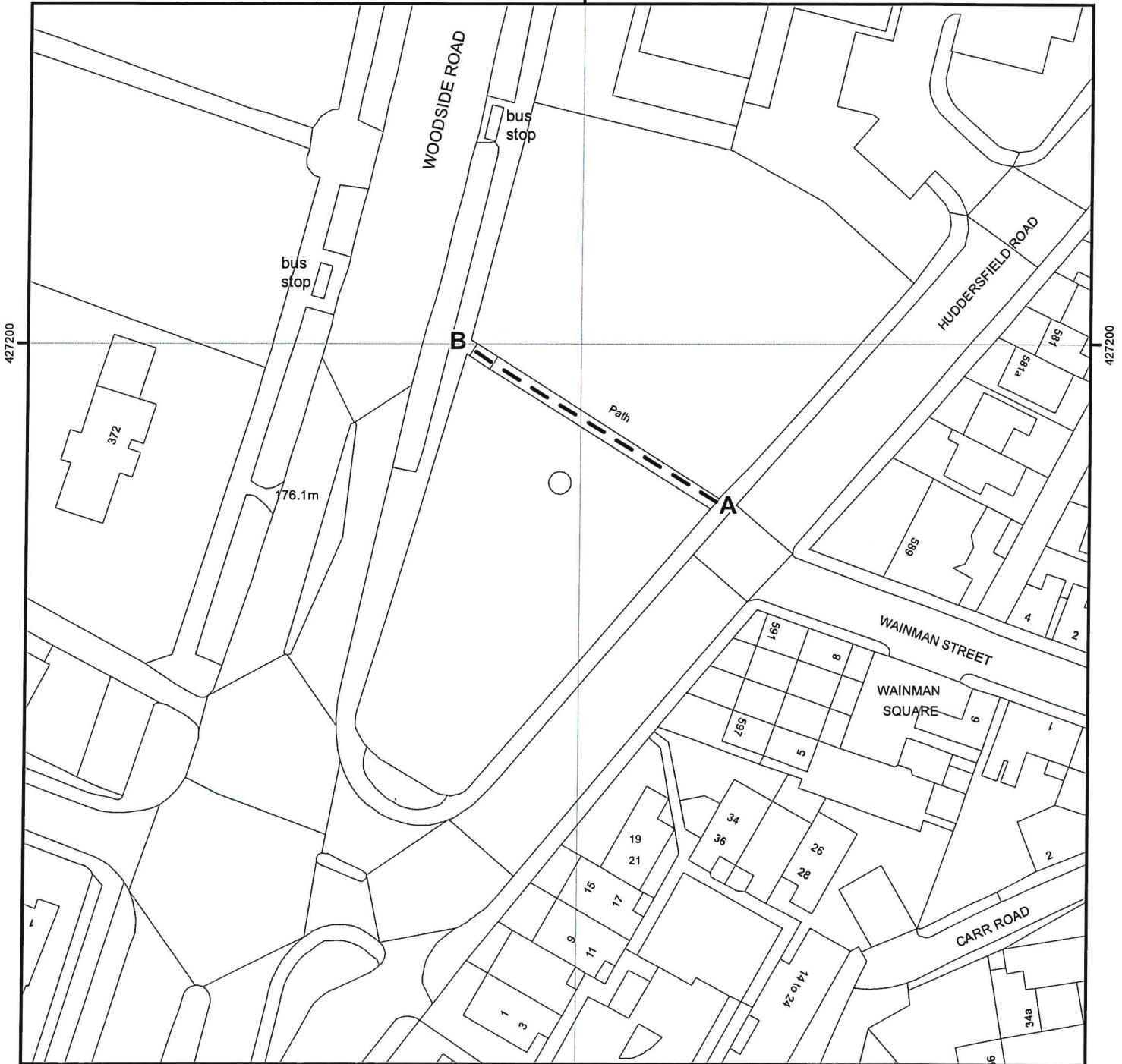

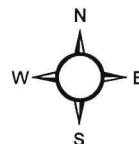
