PUBLIC PATH DIVERSION ORDER HIGHWAYS ACT 1980 – SECTION 119

PUBLIC FOOTPATH AT CRINGLES HOUSE FARM, BRADFORD ROAD, SILSDEN DIVERSION ORDER 2024

This Order is made by City of Bradford Metropolitan District Council ("the authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the occupier of the land crossed by the footpath described in paragraph 1 of this Order it is expedient that the line of the path should be diverted.

The applicant has agreed to pay any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

BY THIS ORDER

- The public right of way over land situated at Cringles, Bradford Road, Silsden shown by a bold black line on the map contained in this Order and described in Part I of the Schedule to this Order shall be stopped up after 28 days from the date of confirmation of this Order.
- 2 Notwithstanding this Order all statutory undertakers shall have the following rights over the land referred to in paragraph 1 namely the right to inspect, maintain, adjust, repair or alter any apparatus within the diverted footpath
- There shall at the end of 14 days from the date of confirmation of this Order be a public footpath over the land situated off Wyke Lane, Bradford, described in Part 2 of the Schedule and shown by bold broken line on the map contained in this Order.

SCHEDULE

PART I

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

A public footpath shown by a bold black line on the map annexed hereto, commencing at a plastic ladder stile at grid reference 404717 448457, (marked A) and continuing in an easterly direction for 167 metres with a width of 1.2 metres and a grass surface to grid reference 404883 448473, (marked B). Then after crossing Bolton Road the path proceeds from grid reference 404895 448473 (marked C) in an easterly direction for 83 metres with a width of 1.2 metres and a grass surface to grid reference 404974 448454 (marked D) being part of public footpath number 16 Silsden. Total distance 250 metres.

PART 2

DESCRIPTION OF SITE OF NEW PATH OR WAY

A public footpath shown by a long dashed line on the map annexed hereto, commencing at a self closing pedestrian gate at grid reference 404717 448457. (marked A) and continuing in a north easterly direction with a width of 2 metres and a grass surface for 131 metres to grid reference 404822 448536, (marked E), then continuing in an easterly direction with a width of 2 metres and a crushed stone surface for 72 metres to grid reference 404889 448558. (marked F). After crossing Cringle Lane and Bolton Road the path proceeds from grid reference 404915 448519 (marked G) and continues in an easterly then southerly direction with a width of 2 metres and a surface of grass and crushed stone for a distance of 106 metres to grid reference 404974 448454 (marked D) all being part of public footpath number 16 Silsden. Total distance 309 metres.

All distances are as measured on map.


