SUBJECT: Moorside Road/Whitaker Avenue, Bradford – Addition to the 2024-25 Bradford East Various Sites Traffic Regulation Order

MATTER FOR CONSIDERATION:

1. Approval for a Traffic Regulation Order for minor amendments to parking arrangements on various roads in Bradford East was granted by the Bradford East Area Committee on 14 March 2024.
2. An additional site in Bradford East has been identified as follows:
 - i. Moorside Road/Whitaker Avenue – Parking at the junction causes sightline and access issues. No Waiting At Any Time restrictions have been requested.
3. This decision seeks approval to add the Moorside Road/Whitaker Avenue junction to the 2024-25 Bradford East Various Sites Traffic Regulation Order.

FINANCIAL & RESOURCE APPRAISAL

A budget of £22,000 has been allocated by the Bradford East Area Committee as part of the 2024-25 Safe Roads programme. The additional site can be delivered within the existing budget.
