**Overview & Scrutiny Area:** 





#### 1. SUMMARY

This report provides an update on the allocation of Children and Young Peoples Community Chest Funding and Community Chest Funding. The report also outlines the process, criteria and timescales for the allocation of Youth Opportunities Funding and Area Action Planning Funding.

#### 2. BACKGROUND

The following reports were presented to the Bradford East Area Committee on 26th June 2014:

- Youth Service Report (covering Youth Opportunities Funding) Document A
- Area Action Planning Funding Document H
- Community Chest Budget Document F

A further report was presented to the Bradford East Area Committee on 17<sup>th</sup> September 2014 in relation to Youth Opportunities Funding and Area Action Planning Funding – Document O. The Bradford East Area Committee resolved that:

- (1) That a Grants Advisory Group made up of the Chair, Deputy Chair and a member from the other largest group represented on the Committee be established.
- (2) That the Bradford East Area Committee delegates decisions about the allocation of the Youth Opportunities Funding, Area Action Planning Funding, Community Chest Funding and Young Peoples Community Chest Funding, to the Area Co-ordinator, in consultation with the Grants Advisory Group. The decisions of the Area Co-ordinator should be reported to the Area Committee at its next available meeting.

## Children and Young Peoples Community Chest Funding and Community Chest Funding

The Grants Advisory Group held a meeting on 29 September 2014 to consider applications with the Bradford East Area Co-ordinator. At this meeting decisions were made about applications for Children and Young Peoples Community Chest Funding and Community Chest Funding. A list of organisations granted funding is attached as Appendix A (Children and Young Peoples Community Chest Funding) and Appendix B (Community Chest Funding). The Children and Young Peoples Community Chest Funding was fully allocated – total of £10,000. There is still some money available for allocation from the Community Chest Funding.

### Area Action Planning Funding and Youth Opportunities Funding

On 29 September 2014 the Grants Advisory Group also with the Bradford East Area Coordinator's Office to agree a process for allocating the above funding streams. In terms of the Area Action Planning Funding, the Grants Advisory Group and Area Co-ordinator agreed to call this Bradford East Communities Fund. Ward Members from across the Bradford East Area will be invited to put forward projects by contacting their Ward Officer who will complete an expression of interest form on their behalf. These expressions of interests need to be completed by the 31st October 2014. The Grants Advisory Group and





Area Co-ordinator will hold a meeting in early November 2014 to consider the expressions of interests. A total of £60,000 will be available. Only expressions of interest that are supported by Elected Members will be considered; groups cannot apply directly for this funding. Applications are invited for projects up to a maximum of £2,000. The Bradford East Communities Fund criteria is attached as Appendix C.

With regards to the Youth Opportunities Funding applications will be invited from early October 2014 with a closing date of 31st October 2014. The Area Co-ordinator and Grants Advisory Group, in consultation with some young people from Bradford East will consider applications in early November 2014. Groups will be able to apply for up to £2,000. An application form is attached as Appendix D and this also contains the criteria.

### 3. OTHER CONSIDERATIONS

There are no other considerations for this report.

#### 4. FINANCIAL & RESOURCE APPRAISAL

£20,000 Youth Opportunities Funding and £60,000 Bradford East Communities Fund is available to the Bradford East Area Committee for 2014/2015. This should be spent by 31<sup>st</sup> March 2015.

Staffing: Support will be provided from within the existing resources of Neighbourhood and Customer Services, other Council Services and partners.

#### 5. RISK MANAGEMENT AND GOVERNANCE ISSUES

There are no significant risks arising out of the proposed recommendations in this Report.

## GUIDANCE NOTES AND CRITERIA BRADFORD EAST AREA COMMUNITIES FUND

- 1. Applications will only be considered that are put forward by Elected Members on behalf of constituted groups/organisations that are based in and benefit communities living in the Bradford East Constituency area. This is a one-off funding stream that has been made available by the Bradford East Area Committee from October 2014 to March 2015.
- 2. Applications will only be considered that support the delivery of priorities identified in the Bradford East Ward Plans.
- 3. Priority will be given to applications that benefit areas of need which are evidenced by indices of multiple deprivation.
- 4. The maximum allocation from the Bradford East Area Communities Fund would not normally exceed £2,000 for any individual project. Any projects awarded funding MUST spend this funding and complete their project by 31 March 2015. Grants will be allocated on a one-off basis.
- 5. Where appropriate, an independent audited financial statement of the groups/organisations position will be required together with a copy of the constitution and/or rules, if this is the first application for financial assistance, or if the constitution has changed since you last applied for funding. Only groups that are constituted and have a bank account in their own name are eligible to be funded. If you do not provide all of the documents requested this is likely to delay your application being considered for funding.
- 6. Projects should not contravene Council Policy Guidelines in areas of equality of opportunity (i.e., no discrimination of membership on ground of sex, race, religion, occupation or opinion).
- 7. The organisation should be a non-profit making voluntary organisation where membership is open (i.e. no discrimination of membership on grounds of sex, race, religion, occupation or opinion).
- 8. Bradford East Area Communities Fund cannot be used to fund religious or political activities.
- 9. Bradford East Area Communities Fund cannot normally be used to enable fundraising for a secondary body, unless within the terms of a loss guarantee.
- 10. Grants may be used to complement other sources of funding, (e.g., Sports, Council, Arts Council, Yorkshire Arts). Bradford East Area Co-ordinator's Office expects organisations to make every effort to be self-supporting, and will give preference to such organisations
- 11. All funded projects must use Bradford Council's Neighbourhood and Customer Services logo and acknowledge on any publicity materials that the funding has been provided by Bradford Council through the Bradford East Area Committee.

- 12. Please note that some of the data collected as part of this funding bid is shared with internal and external partners. Projects funded could be publicised electronically, in funding reports or in the media. It is also possible that this information may be released in accordance with a Freedom of Information request.
- 13. All monies given to a project / organisation must be accounted for in full (e.g. copies of accounts and/or receipts detailing how the money was spent) and a short report on the project submitted by April 2015. (Any subsequent applications from a project / organisation will not be considered if this condition is not complied with).

Guidance on how to complete the application form

Application area	Explanation/Prompt		
Section 1.			
Name of organisation/Project	Fill in the organisation & activities full name and contact details		
Named Contacts	Write in your details, then the adult & their details that is supporting you in your activity.		
Section 2			
1. Description of your activity.	This is most important point of putting your argument across of why your activity should be funded. You need to consider all details of your activity, including what its about, who will be involved and what will they get out of it, why is your activity unique, why should your activity be funded? You can get creative with your description and show pictures or other things to explain or support your activity.		
2. How will you be involved?	This section needs to consider the roles and responsibilities of everyone involved, break this down as to who is doing what and when to achieve what you need to achieve.		
3. Activity start date and finish dates.	Write down when your activity will start, give an approximate date if you need to. Then write when your activity finishes, is it a day activity or longer. Write this down.		
4. How will you achieve this?	This section needs to show you have considered everything and planned out your activity. In this section explain/show how you will achieve your activity considering a timescale of what needs to happen when and who by. Consider where and when you will need support from others, dates and times, booking in certain activities, when and how; who is involved when and how, what will they achieve or gain from the activity, show how you have been cost affective; why is it value for money?, maybe some quotes and reasons why you chose the one you did; did you go for the cheaper option? Financial Breakdown	Please show a detailed breakdown of what the money you are applying for with a maximum amount of £2000.00 in total. In each item or activity specify when you intend on spending the money.

## **Background Information**

The Bradford East Youth Opportunity Fund (YOF) is part of the Early Intervention Grant held by Children's Services and handed to each Area Committee. It is available to increase 'things to do' for young people organised from within their local neighbourhood.

The broad aims of the Funds are to:

- Give a voice and influence to young people, particularly those facing disadvantage, in relation to things to do and convey a powerful message to young people that their needs and aspirations are important;
- Change the way local authorities and their partners provide activities for young people, and increase the responsiveness of providers to what young people want;
- Provide opportunities for young people to develop their confidence, knowledge, skills and abilities;
- Enable young people to gain recognition and accreditation for their participation;
- Increase the well being of young people through their engagement in activities that have a positive impact on their development;
- Increase young people's engagement with services and with decision making processes at local level;
- Offer young people the opportunity to develop projects that promote and increase entrepreneurial skills;

Applications must be completed by young people aged between 13 and 19 (up to 25 years for young people with disabilities).

Organisations must be working with young people in the constituency area with the support of an experienced adult to be eligible to apply.

Applications from organisations and services working with the following groups are particularly encouraged: Looked after young people, vulnerable young people and those at risk and NEET young people.
