#### 2. DISCLOSURES OF INTEREST

(Members Code of Conduct - Part 4A of the Constitution)

To receive disclosures of personal and prejudicial interests from members and co-opted members on matters to be considered at the meeting. The disclosure must include the nature of the interest.

An interest must also be disclosed in the meeting when it only becomes apparent to the member during the meeting.

#### Notes:

- (1) Members may remain in the meeting and take part fully in discussion and voting unless the interest is prejudicial. A personal interest is prejudicial if a member of the public with knowledge of the relevant facts would reasonably regard it as so significant that it is likely to prejudice the Member's judgement of the public interest. The Member must withdraw from the meeting if the interest is prejudicial unless a dispensation has been obtained from the Standards Committee.
- (2) Members in arrears of Council Tax by more than two months must not vote in decisions on, or which might affect, budget calculations, and must disclose at the meeting that this restriction applies to them. A failure to comply with these requirements is a criminal offence under section 106 of the Local Government Finance Act 1992.
- (3) Officers must disclose interests in accordance with Council Standing Order 44.

#### 3. INSPECTION OF REPORTS AND BACKGROUND PAPERS

Reports and background papers for agenda items may be inspected by contacting the person shown after each agenda item. Certain reports and background papers may be restricted.

Any request to remove the restriction on a report or background paper should be made to the relevant Strategic Director whose name is shown on the front page of the report.

If that request is refused, there is a right of appeal to this meeting.

#### 6. CONSERVATION AREA ASSESSMENTS

The Council as Local Planning Authority has a duty under the Planning (Listed Building and Conservation Areas) Act 1990 to periodically review the Districts Conservation Area boundaries, to identify other areas that may be suitable for designation and to prepare preservation and enhancement proposals where appropriate.

Conservation Area Assessments have been produced for Baildon Green and Eldwick Beck and a full consultation process has taken place in each area. The Strategic Director, Regeneration will present **Document "K"** which details the findings of the Assessments.

#### Recommendation -

- (1) That the Area Planning Panel (Shipley) recommend to the Shipley Area Committee:
- (i) That the Conservation Area Assessments for Baildon Green and Eldwick Beck be approved and used for the future management of the areas and their surroundings.
- (ii) That the proposed Baildon Green and Eldwick Beck Conservation Area boundary as set out in Appendix 1 and 2 be approved and formally advertised in accordance with the Planning (Listed Building and Conservation Areas) Act 1990.

- (iii) That the outcomes of the consultations as set out in Appendix 3 and 4 be accepted as a basis for future enhancement work.
- (2) That the Strategic Director, Regeneration be instructed to prepare and submit for such consideration as is appropriate, Draft Supplementary Planning Guidance as identified by the local communities and as resources permit.
- (3) That the Draft Supplementary Planning Guidance and any representations made following consultation be reported to a future meeting of the Area Planning Panel (Shipley).
