20. DISCLOSURES OF INTEREST

22. **PUBLIC QUESTIONS**

In accordance with the provision at Part 3B Para 6 of the Council's Constitution the following public question was presented:

"The Planning Officers work for the Department of Regeneration and Culture. Their salary is paid by council tax payers. Can the Panel inform the residents of Bradford why their Officers are not engaged in the regeneration of the 13,720 houses standing empty and the 270 derelict sites waiting to be regenerated?"

In response the Chair confirmed that a full written reply would be sent to the questioner in due course.

23. PLANNING APPLICATIONS AND ASSOCIATED MATTERS

The Strategic Director Regeneration and Culture presented **Document "C"**.

(a) Land at Bingley Road, Menston

Wharfedale

An outline application for up to 125 dwellings with public space following the demolition of a steel framed agricultural building and agricultural shed, on land at Bingley Road, Menston - 10/06229/MAO

And

(b) Land North East of 2 The Coach House, Derry Hill, Menston <u>Wharfedale</u>

A full application for 174 dwellings and public space land at Derry Hill, Menston - 10/04551/MAF

The Strategic Director, Regeneration and Culture informed the Panel that new information had recently emerged with regard to both applications. He explained that the representations reported within **Document "C"** from the Environment Agency related to comments made at the pre-application stage and it was now clear that a formal consultation response had not been received for both applications. Appropriate legal advice had been sought on the matter and as the Environment Agency was a statutory consultee he informed Members that it would not be considered expedient to determine these applications in the absence of a formal consultation response. It was noted that submissions had been made by solicitors and consultants on behalf of the objectors within the past week that raised issues on flood risk matters. These details had been forwarded to the Environment Agency for their comment and were also being assessed by the Council's Drainage Section.

In conclusion the Strategic Director, Regeneration and Culture recommended to the Panel that both applications be deferred for consideration at a later date once the formal response from the Environment Agency had been received.
