1. SUMMARY

This report is in response to a petition from young people who use the Karmand Community Centre, requesting that the decision to reduce youth sessions at the Centre from two to one per week be reviewed.

2. BACKGROUND

The petition contains 43 signatures and is attached as Appendix A. The potential for negative impact on young people in terms of development opportunities is highlighted in the petition.

The 2 youth sessions at the Karmand Community Centre, run by Bradford Council Youth Workers, were reduced to one session with effect from November 2014 owing to the low number of young people who attended and the need to do work in other parts of the Bowling and Barkerend Ward.

The following sessions are currently run by the Council's Youth Workers in the Bowling and Barkerend Ward:

- 2 sessions/evenings at Greenway Youth Club (Duke of Edinburgh Centre) and
- 1 session at the Karmand Community Centre.

It was felt that there was a need to undertake detached youth work as some of the Ward is not covered in terms of youth work, for example the East Bowling area. As Youth Workers are no longer running 2 sessions at the Karmand Community Centre, they are able to carry out detached youth work and reach young people in other parts of the Ward.

In addition, it should be noted that there are youth sessions in neighbouring wards that young people from the Bowling and Barkerend Ward can access. There are 4 sessions at Laisterdyke Youth and Community Centre in the Bradford Moor Ward (one of these sessions is for girls only). Young people who attend the session at the Karmand Community Centre can also attend the sessions at Greenway Youth Club which is close to the Karmand Community Centre.

3. OTHER CONSIDERATIONS

There are no other considerations for this report.

4. FINANCIAL & RESOURCE APPRAISAL

Full time Youth Workers run most sessions and they are supported by part time staff. The Youth Service in East can't afford to run additional sessions. The only way to support an additional session at the Karmand Community Centre would be by stopping a session elsewhere.

5. RISK MANAGEMENT AND GOVERNANCE ISSUES

There are no significant risks arising out of the proposed recommendations in this Report.





6. LEGAL APPRAISAL

This work relates directly to the Local Government Act 2000 and to the Duty of Well-being placed upon the Council to promote and improve the well-being of the District.
