# 59. **DEVOLVED BUDGET - SAFER ROADS SCHEMES**All wards

The report of the Strategic Director Regeneration and Culture (**Document "AE"**) sought approval for a programme of Safer Roads Schemes for Bradford East for the 2015/16 financial year.

It was reported that there had been an addition of waiting restrictions at the New Line/Sulby Grove junction to Appendix 3.

Members raised concerns as to why the Leeds Road/Harrogate Road feasibility study was not on the priority list when there had been fatalities and why this had not been funded by a developer.

The Principal Engineer clarified that schemes were prioritised on a value for money basis taking into account the potential for casualty reduction and project costs. The entry for Leeds Road/Harrogate Road was for a feasibility study rather than an actual scheme.

A Ward Member felt there should have been 4 vehicle activated signs on Pullan Avenue rather than 2.

# Resolved -

- (1) That the Bradford East Area Committee approves a programme of Casualty Reduction schemes for 2015/16 listed in Appendix 1 to Document "AE".
- (2) That the Bradford East Area Committee approves the proposed programme of Traffic Management schemes for 2015/16 listed in Appendices 2 and 3 of Document AE subject to the addition of the Leeds Road/Harrogate Road feasibility study as a replacement for Census Radar Surveys in Appendix 2 and addition of waiting restrictions at the New Line/Sulby Grove junction to Appendix 3.
- (3) That a further report be presented to the Bradford East Area Committee in Autumn 2015 to update members on progress with the 2014/15 schemes programme and give consideration to the allocation of any residual funding.
- (4) That any Traffic Regulation Orders, or any legal procedures linked to the processing of traffic calming measures or pedestrian crossing facilities which are necessary to implement the chosen schemes be approved for processing and advertising subject to the scheme details being agreed with the local Ward Members.

- (5) That any valid objections to the advertised Traffic Regulation Orders, traffic calming or pedestrian facilities be submitted to this Area Committee for consideration or in the event of there being no valid objections the Traffic Regulation Orders be sealed and implemented and the traffic calming or pedestrian facilities be implemented as advertised.
- (6) That, subject to consultation with ward members, those items highlighted in Appendices 4 & 5 be removed from the list for future consideration in accordance with the methodology detailed in paragraph 3.3 of Document "AE".

- (1) That members note the approved Traffic Regulation Orders and Traffic Calming measures as detailed in Appendices 1-3 of Document "AF".
- (2) That any valid objections to these proposed Traffic Regulation Orders and Traffic Calming measures be reported to this Area Committee for consideration or, in the event of there being no valid objections, the Orders be sealed and measures implemented as advertised.

The report of the Strategic Director, Regeneration and Culture (**Document "AG"**) provided information on Capital Highway Maintenance funding for 2014/15 – 2015/16 and made recommendations on the allocation for Non-Classified road resurfacing schemes and Surface Dressing sites in Bradford East for 2015/16.

# 62. ARRANGEMENTS BY THE COUNCIL AND ITS PARTNERS TO TACKLE CHILD SEXUAL EXPLOITATION All Wards in Bradford East

The Strategic Director of Children's Services submitted **Document "AK"** which highlighted issues relevant to the Area Committee which arose from the resolution passed unanimously by Council on 21<sup>st</sup> October 2014 regarding child sexual exploitation (CSE) and from the detailed report accepted by the Executive on 13<sup>th</sup> January 2015, regarding the same issue.

The Assistant Director Children's Specialist Services reported on the preventative work taking place and the work of "The Hub" such as a multi-agency co-located service which was established in January 2012 based at Javelin House.

It was reported that online training on child sexual exploitation was available to Members.

Members were informed that a lot of work was being undertaken with all faiths and community groups to raise awareness of CSE.

It was reported that there were 480 young people known to the child sexual exploitation hub and 106 of these were from Bradford East area; in respect of prosecutions since the start of the Hub in 2012; 90 individuals had been arrested, a number had been charged and these cases were going to court, there had been 23 convictions.

Members commented on a number of issues which included:

- Was work being undertaken in terms of child abuse within families?
- 500 children on protection plans seemed high, how did that compare with neighbouring authorities?
- How confident should Members feel that all mechanisms were in place to safeguard children?
- The report needed to include all the information available or at least made reference to it; Ofsted reports should have been included in the report as background documents.
- There were issues that had been flagged up in the Ofsted report which were not detailed in the report.
- The statistics were different in the various documents that were available relating to CSE; information presented needed to be smarter and understandable; It was important to be open and transparent.
- Members were not fully aware of the process of reporting suspected child sexual exploitation; ward partnership teams should be more involved in providing support in this area.
- It was crucial to have a good system in place that flagged up at risk cases.
- A lot of good work was being undertaken in this area; risk factors needed to be identified early; but felt there was not enough preventative work being undertaken.
- Would be useful to see the work of the Hub and a map of hot spots and key areas.
- Needed to be aware that vulnerable people over 18 were equally targeted and exploited.
- It should be the role of Ward Partnership Teams to engage schools in this serious issue.

- In relation to paragraph 2.25 of Document "AK" the report should include other models such as young women within families from different community settings.
- It would be useful to have information on children in care of this authority and those living in Bradford in the care of other local authorities.

In response to Members' questions it was reported that:

- A lot of work was being undertaken relating to child abuse in families; over 500 children were on child protection plans; however sexual abuse within families was the smallest category.
- The number of child protection plans in question were slightly higher in Bradford than neighbouring authorities; additional cases had been referred to Social Services since the Hamzah Khan serious case review.
- The national picture made people feel more confident in coming forward and reporting CSE.
- A lot of preventative work was being undertaken as detailed in paragraph 2.17 onwards of the report.
- An electronic link to the Ofsted report could be sent to Members.
- The systems in place to tackle CSE were now more robust than ever; professionals knew children at risk well.
- In recent months the Council had made a significant investment in developing the functionality of the integrated children's system to allow children's services staff to "flag" cases of children at risk of CSE; West Yorkshire Police had also developed a similar "flagging" system which identified for all officers and relevant police staff cases where there was a risk of CSE.
- All Members need to be urged to undertake online CSE training.
- Regular reports on CSE could be provided to the Committee; officers were honest about the information presented.
- Schools had a significant role to play in supporting young people and having trained pastoral staff in school.

#### Resolved -

- (1) That having considered Executive Document "AM", Bradford East Area Committee welcomes the work being undertaken and requests that its views and comments be taken into consideration during the Council's operational approach in exercising its duties to keep children safe from child sexual exploitation in the Bradford East area.
- (2) That the Strategic Director, Children's Services be requested to submit a further report in six months time, on the progress made in keeping children in the Bradford East area safe from child sexual exploitation.
- (3) That the Strategic Director Children's Services inform all Members of the process for reporting suspected child sexual exploitation to their Local Police Safeguarding Team.
- (4) That all Members be urged to undertake the online training relating to Child Sexual Exploitation.

- (5) That the future report due to be submitted to the Committee in six months time includes information on children in the care of the City of Bradford Metropolitan District Council and those living in Bradford in the care of other local authorities.
- (6) That in relation to paragraph 2.25 of the report the Strategic Director Children's Services be requested to include other models giving examples from different community settings.
