#### 1. SUMMARY

1.1 The Street Name "Christophers Court" to be dedicated to the Late Private Christopher Kershaw Close who served his country in Afghanistan. His family still live in Idle.

#### 2. BACKGROUND

- **2.1** Incommunities are developing this site as residential site of 22 new dwellings.
- **2.2** Councillor Fear wishes to honour Christopher by naming the street "Christophers Court".
- **2.3** Councillor Fear makes the following statement in support of a decision to approve the allocation of "Christophers Court" as the new street name:

"Private Christopher Andrew Kershaw"

Christopher Kershaw was born and raised in Idle. He attended Hanson and played rugby from a young age. He later became a national karate champion at 15 and joined the ACF cadets at Thornbury 4 PARA. He joined up with the Yorkshire Regiment in August 2011 and was deployed to Afghanistan in February 2012.

He was tragically killed along with five comrades in Helmand Province when the vehicle they were patrolling in was destroyed by a roadside bomb. Pte Kershaw, who was described by his commanding officer as 'a true Yorkshire warrior' had volunteered for the patrol in the place of a friend.

Pte Kershaw is buried in Holy Trinity Church in Idle and his family still live locally. He is part of Bradford's strong military heritage and stands as a shining example of the incredible bravery of service men and women from across the district.

His family hope that his memory can be carried on and the thought of a road so close to his home being named for him gives some consolation for such a tragic loss. It is hoped that his memory will be carried on in the letters, correspondence and memories of those that live on the street in the future.

#### 3. OTHER CONSIDERATIONS

3.1 As the naming of a new street after any individual is a sensitive matter, to be given very serious consideration, and is usually only approved in exceptional circumstances, it is sensible to provide an alternative suggestion in the event that the Committee does not approve this proposal. In this particular case, should the Committee not be minded to approve this proposal;

The name "**Poppleton Close**" will be the allocated street name following consultation with the Ward Councillors as part of the current Policy and Protocol.

As mentioned above in Councillor Fear's Statement of Proposal, Private Kershaw's family are in full support of, and have been instrumental in, working with Councillor Fear in honouring his name in this way.
