1. SUMMARY

1.1 This report details the design and formal consultations carried out for a proposed Zebra crossing to be situated on Holroyd Hill, Wibsey

2. BACKGROUND

- 2.1 At the full Council meeting on 24th January 2012 a petition of 195 signatures was received requesting a pedestrian crossing on Odsal Road/Holroyd Hill, Wibsey adjacent to the Quarry Dene retirement complex.
- 2.2 The petition was subsequently referred to the Bradford South Area Committee for further action.
- 2.3 On the 14th March 2012 the Bradford South Area Committee gave approval to carry out investigatory works and scheme development for the provision of a Zebra Crossing on Odsal Road/Holroyd Hill, Wibsey, initially with a view to implementing a scheme in the 2013/14 financial year.
- 2.4 Due to efficiency savings during the course of the 2011/12 and 2012/13 financial years the proposed scheme was bought forward into the current works programme at the Bradford South Area Committee in September 2012.
- 2.5 A formal crossing has been designed as shown in Appendix 1.
- 2.6 Formal consultations for the scheme have been undertaken. Details of the consultations are show in Appendix 2
- 2.7 No objections to the scheme had been received before the end of the five week formal consultation period which closed at noon on the 11th January 2013




Consultation letters regarding the proposals have been hand delivered to 6 properties in the immediate vicinity of the scheme affected by parking.
