#### 1 SUMMARY

1.1 This report details a proposed Works Programme for Traffic Measures to be undertaken in the Bradford South Constituency Area the 2013/14 financial year.

#### 2 BACKGROUND

- 2.1 The Bradford South Area Committee is responsible for the allocation of funding to schemes within its constituency area to deal with traffic measures and road safety issues.
- 2.2 A provisional budget of £**135,203** has been allocated to the Area Committee from the Integrated Transport budget in the 2013/14 financial year. This budget may not be fully confirmed until June 2013.
- 2.3 A proposed programme of works within the assigned annual budget for the 2011/13 financial year is shown in Appendix 1, together with a rationale for each scheme and an estimated cost. The total cost estimate for these works is **£103,000**.
- 2.4 Also included in the programme of works are three global elements covering Disabled Parking, Mobility and General Traffic Regulation orders. These elements combined represent a cost of **£24,000**.
- 2.5 A contingency sum of **£8,203** has been included to take into account retention payments on previously completed schemes and to allow for possible cost overruns in the 2013/14 financial year.
- 2.6 Some schemes have previously been approved by committee and have not been included in the 2013/14 programme. These are listed in Appendix 2 together with a rationale for their exclusion from the programme list

# 4 OTHER CONSIDERATIONS

- 4.1 Any new schemes bought to Area Committee may now take a minimum of 12 months to be considered for implementation.
- 4.2 Cost savings are possible in terms of Traffic Regulation Orders by rationalising a number of schemes into a single order. Such rationalisation does, however, lead to delays in implementation of schemes across the financial year as multiple consultation issues may need to be taken into consideration by the committee.
- 4.3 The 2013/14 year is the last year of Implementation Plan 1 from the West Yorkshire Local Transport Plan. As such it is imperative that the Area Traffic and Highways Budget is balanced at the end of the financial year. In order to ensure this is the case the works programme is deliberately set so that no extensive schemes or

major Traffic Regulation Orders are programmed to be capital funded within the financial year.

4.4 In order to maximise LTP spend any savings made across the 2013/14 programme will be allocated to lining, maintenance works and/or infrastructure development.

- 5.1 That the Bradford South Area Committee accepts the proposed programme of works for 2013/14 as shown in Appendix 1
- 5.3 That the Bradford South Area Committee decides not to accept the recommendations outlined in this report.
