1. SUMMARY

- 1.1 This report considers additional funding available to the Bradford South Area Committee for both Local Highway Maintenance and Strategic Highway Maintenance in the 2013/14 financial year.
- 1.2 The report also gives information regarding 2012/13 Category 1 and 2 repairs and current figures for 2013/14.

2. BACKGROUND

- 2.1 The Local Highway Maintenance Budget was developed to be used to deal with highway maintenance issues on local roads in order to aid further progression in the reduction of the insurance premium by targeting, where possible, the worst areas on the local network, complementing other strategic and statutory maintenance work undertaken by the authority utilising separate budget heads.
- 2.2 Bradford District has received an additional £1.04 million capital allocation from the Department for Transport for the 2013/14 financial year. Additionally £500k has been set aside to supplement the highway maintenance budget from revenue funding making a total additional of £1.54 million.
- 2.3 The £1.04 million capital funding is subject to local highway authorities agreeing to publish transparency statements at the end of each financial year (there is also likely to be additional funding for the 2014/15 financial year of £0.54million).
- 2.4 Following top slicing of that budget for strategic maintenance purposes (specialist district-wide works carried out on roads of strategic importance), an allocation £100,000 has been made available in the current financial year to each Area Committee for Local Highway Maintenance works within the constituency area replacing the previously allocated £40,000 discretionary Area Committee budget for such works.
- 2.5 It is proposed that this additional £1.54m is allocated in the following way: -

Streetscene – Spend £500k on targeted major and minor patching work to improve the overall condition of the network in areas that regularly cause problems and repeat visits.

Major Maintenance – Spend £540k on centrally procured strategic overall district priorities. The aim is to target sites that are showing signs of failure and treat with full resurfacing / micro asphalt/ surface dressing as appropriate.

Area Teams – Spend £500k on their locally derived priorities including areas of proactive patching, carriageway repairs and footway maintenance within the 5 Area Constituencies (£100k per district).

- 2.6 The South Area allocation procured by Major Maintenance is show in Appendix 3.
- 2.7 Each local area team will have different pressures for spend, and allocation of works. Works may cover any aspect of highway maintenance, including footway, kerbing, highway drainage, potholes, strategic patching and other proprietary treatments to extend the life span of the network
- 2.8 A list of proposed carriageway resurfacing works, as identified and compiled by officers is included in Appendix 1.
- 2.9 In order that works can be programmed ordered and the appropriate legal/statutory notices may be served before the end of the financial year it is imperative that the committee approves a work programme as soon as possible.
- 2.10 Area teams also have a revenue budget (£55,000) at their disposal to cover a number of maintenance issues as follows: -
 - Replacement or new street nameplates and other street furniture
 - Gully repairs, drainage surveys, root cutter equipment hire
 - Repairs/replacement of anti-motorcycle barriers and hand-rails
 - Works on footways and carriageways formerly maintained by In Communities (Gulliksen Agreement)
 - Signing and lining maintenance
 - Other miscellaneous highway repairs and works covered under Highways Act

Given the relatively insignificant figures that arise once this budget has been apportioned between the works areas listed above, it is recommended that this be prioritised by officers to meet the varying levels of demand.

2.11 As part of the commitment to the devolution process initial figures for Cat 1 and 2 repairs for the 2012/13 financial year and the current 2013/14 year to date have been included in Appendix 2. A more detailed report on the financial position of the devolved budget will be bought to this Area Committee in September 2013

3. OTHER CONSIDERATIONS

3.1 There are no other considerations with regard to this matter.

4. OPTIONS

4.1 That the Bradford South Area Committee adopts the recommended schemes/works outlined in Appendix 1 – this is the preferred option as works have been identified by officers across the previous financial year.

4.2 That members request alternative schemes for implementation.

5. FINANCIAL & RESOURCE APPRAISAL

- 5.1 The committee may only choose works up to the limit of the available budget of £100,000
- 5.2 The £55,000 revenue budget is available in the 2013/14 financial year but may be subject to change in future.

6. RISK MANAGEMENT AND GOVERNANCE ISSUES

6.1 Failure to prioritise highway maintenance schemes based upon condition and safety survey data will result in an increased requirement for reactive maintenance and lead to a reduction in road safety conditions and an associated increase in successful insurance claims against the Council..

7. LEGAL APPRAISAL

- 7.1 There are no specific legal issues arising from this report.
- 7.2 All works undertaken will be carried out within the requirements of the Highways Act 1980

8. OTHER IMPLICATIONS

8.1 EQUALITY & DIVERSITY

8.1.1 Due regard is given to Section 149 of the Equality Act 2010 when formulating a programme of Highway Maintenance repairs.

8.2 SUSTAINABILITY IMPLICATIONS

8.2.1 Proactive repairs such as surface dressing serve to extend carriageway life.
