1 SUMMARY

This report summarises the range of work undertaken by the Youth Service within the Bradford South area, this includes a focus on its work to encourage young people into positive activities.

2 BACKGROUND

- 2.1 The Youth Service provides an open access service to young people with a focus on prevention and early intervention, reducing the need for a more formal crisis response at a later stage. Youth work is well established across Bradford South and has consistently received positive external evaluation in terms of impact and value for money since 2002. The Service's focus is on the 11 19 age group and offers a wide range of provision in local communities, in partnership with third sector organisations and on a district wide basis, thus making a significant contribution to the community cohesion agenda. There has also been a significant increase in the delivery of services to support disabled young people and all other vulnerable groups.
- 2.2 In June 2012 Statutory guidance was issued by the Department for Education which placed a duty on Local Authorities to secure services and activities for young people aged 13 to 19 (up to 24 learning difficulties) to improve their well-being.
- 2.3 In essence the duty is to practicably secure equality of access for all young people to positive, preventative and early help needed to improve their well-being. This includes youth work and other services and activities that:
 - Connect young people with communities so they have a voice in decisions which affect their lives
 - Offer safe opportunities in a wide range of activities, to develop a strong sense of belonging, socialise safely, enjoy social mixing, spend time with older people, and develop relationships with adults they trust
 - support personal and social development of young people so they build the capabilities they need for learning, work, and the transition to adulthood
 - improve young people's physical and mental health and emotional well-being;
 - help young people at risk of dropping out of learning or not achieving their full potential to engage and attain in education or training; and
 - raise young people's aspirations and build resilience to inform their decisions and thereby reducing risky behaviours
- 2.4 There are three main areas of responsibility for Local Authorities:
 - Involving young people in decisions that affect their lives, securing their views through structured arrangements that also allow them to be involved in service design and especially those who traditionally have little or no voice.
 - Securing access to sufficient services and activities although it does not prescribe services and activities that Councils should fund or deliver or to what level Councils should take the strategic lead to work with young people; the





voluntary, community and social enterprise sector; health and wellbeing boards; schools and colleges; and agencies including health and police.

- Local Authorities should do all that is reasonably to secure a sufficient local offer based on an understanding of need. The offer has to be aspirational and young people test services that delivery it through an audit they undertake which should then be published. The offer should be delivered by a range of providers with a mix of open access, targeted, preventative and specialist provision as well as publishing relevant funding and performance data.
- 2.5 In December 2012, the service implemented a revised model of delivery significantly designed against the new Guidance described above in order to secure:
 - An open access service with a focus to deliver a prevention and early intervention approaches
 - An increase in face to face work by youth workers that offers informal learning opportunities (life skills) to support improving educational attainment
 - A wider role for youth workers to support vulnerable young people
 - The clear retention of a focus on inclusion particularly for young people with disabilities
 - A closer working relationship with VCS
 - A planned to approach to increase volunteering of adults and young people to build capacity in the service and in communities
- 2.6 The service is currently funded by the Council at 4.26 million for 2012/13.
- 2.7 The delivery of youth work to young people is based on providing a range of exciting, relevant and young people focussed activities. This allows staff and young people to develop provision that reflects the needs of the young people, address issues on a local community level and supports young people to find solutions to issues as well as taking part in activities. Overall the new model has allowed a closer working relationship with a range of agencies and services ensuring the Service is flexible in how it delivers youth work. This is described more fully in section three below. Each of the wards within the South area now have 5 evening sessions of youth work available to young people. An extra programme of activities is offered during every school holiday period. All full time Youth workers hold a caseload of the most vulnerable young people who are worked with during the day and in the evening as appropriate. Please see Appendix 1.





2.8 The high performance of the Youth Service in meeting its main target of securing the involvement of 25% of the district's 13-19 year olds in the service over the last four years is as follows:

2.9 Breakdown of Membership by Ward and Constituency

2.9.1 The table below gives the current position in terms of membership by young people within each of the five constituencies across the District as of 30 October 2013. As a service we are currently delivering at 22.29% against a target of 25% with five months of the year still remaining and new pieces of work planned. Bradford South Youth Work Team have already exceeded the 25% target and leads the rest of the Teams across the district in relation to reach. Please see below.

2.10 T1 NEET SERVICE

2.10.1The service currently delivers the support to TIER 1 NEET young people and has supported the Councils' obligation to reduce NEET for 16 -18 Year Olds:

- 2.10.2 In 2011/12 a target was set to reduce the gap between the Bradford NEET rate and the England rate at 0.8 percentage points below the Bradford rate. The outcome at Quarter 4 was that the gap had reduced to zero.
- 2.10.3 In 2012/13 targets to reduce high NEET rates amongst vulnerable groups saw significant reductions in rates for care leavers (25.6% against a 37% baseline) and YOT supervised young people (36% against a 46.2% baseline). Currently, Bradford South Youth Work Team is working with 88 of the most complex Tier 1 NEET young people.

2.11 Positive Activities of Young People

2.11.1 The delivery of Positive Activities for Young People (PAYP) during school holidays has consistently increased both in number participating and the number of hours delivered in holiday periods. The service is clearly on target to meet the number for participants attending provision during school holidays.

2.12 Shortbreaks – Disabled Young people

2.12.1 The Youth Service has seen a significant development in the opportunities available to young people with disabilities to access the service. The table below indicates the progress being made to October 2013. This total numbers of young people with a disability participating is not fully accurate at the time of this report. The Service is redesigning the way in which data will be captured by staff to address this point. A better picture will be available by the end of March 2014.

2.13 Duke of Edinburgh (D of E) Award Scheme

2.13.1 The table below demonstrates that Gold awards in particular have soared in the last year. 41 is an incredibly large number to be achieving this award level for a Service of our size when compared to other authority areas. 18 young people from Bradford South have achieved the Gold Award this year.





- 2.13.2 A SENCO unit and a special school have enrolled in the scheme to give young people with special needs an opportunity to take part in D of E. The Ambassadors project had a big impact on promoting the D of E in Bradford and is directly responsible for new schools involvement as the schools have grown to understand what outcomes had been achieved through starting up a D of E scheme.
- 2.13.3 Although enrolment figures are not available on the electronic D of E system we estimate that there are a very healthy 700 young people accessing D of E in the District. The increase in groups over the past few years has seen many running D of E independently, hence healthy participation numbers and an increasing number of awards achieved. We have 231 young people accessing D of E within the South Area.

2.14 Lord Mayors Award

- 2.14.1 The withdrawal of the sectional awards for the Duke of Edinburgh's Award Scheme has resulted in the Youth Service designing an alternative accreditation opportunity for young people. The Lord Mayors Award has a focus on young people aged 11-16 (up to 25 with disabilities). The Award introduces young people to the importance and benefits of being engaged in positive activities, to get recognition of their achievements and positive participation. The Award is aligned to Council priorities and provides opportunities for young people to contribute and see themselves as part of the future of the Bradford district.
- 2.14.2 There are 3 sections to the Lord Mayors Award:
 - Be Someone All about learning new skills, achieving new attributes that will help a young person in the future (life skills, employment skills, hobby skills)





- Be Active All about commitment to a physically active activity, or range of activities that benefit a young persons health and allow them to be more active (football, dance gym etc)
- Be Valued All about positivity and helping others while gaining from the experience themselves (helping a local charity, helping within the community etc)
- 2.14.3 Young people participate in each section for a minimum of 10 hours of leisure time over a 3 month window. Young people work on one section at a time and identify their chosen activity and the youth worker who will endorse their participation in it. Each section costs £3 to register. Each section is certificated, with an offer to participate in further sections until all 3 sections are completed. Young people can undertake the sections in any order they choose. On completing all 3 sections a Lord Mayors Award (certificate and badge / medal) is presented at an Award ceremony the Mayor hosts. The Award is nationally recognised.
- 2.14.4 Since the scheme started in May 2013 there have already been **139 successfully completed by young people within South area**. This number will grow as each team has been set a target to achieve 25 single sections as a minimum per ward by the end of the March 2013.

3 OTHER CONSIDERATIONS

- 3.1 The Youth Service undertakes a significant amount of work to encourage young people to access our services. This supports a general approach that young people are talking part in positive, enjoyable and socially educative activities rather than to primarily divert them away from a range of anti social, crime or gang related behaviour.
- 3.2 The vast majority of young people are a significant asset in our communities. Many voluntarily support youth workers to run and plan activities in centres and areas from a basic collection of subs, to organising trips or activities alongside or independently of youth workers. They help to decide with local ward councillors the allocation of Youth Opportunities Funding, and assess the quality of provision that their peers receive or by involvement in Youth Forums. Bradford South currently has **35 young volunteers** working across all six wards.
- 3.3 The service does recognise that there are some young people who need early help as well as guidance and support to divert them away from negative activities or influences in their lives into more positive ones. In recognising this being the case the Youth Services has approaches in each of the five areas that are consistent and flexible depending on issues in an area.
- 3.4 The Youth Service is a partner in the District wide Anti Social Behaviour (ASB) Panel which looks at individual cases of ASB amongst young people to ensure sanctions are in place or there are opportunities for young people to participate in alternative positive activities. The Panel looks to address issues at a locality level by reviewing each case every 8-10 weeks.





- 3.5 The Service offers support to young people who are NEET in the provision of 1-1 support to work with them to identify and remove of barriers to their participation in Education, Employment and Training. Currently Bradford South Youth workers are working with 92 of the most complex NEET young people. Young people receive intense support around a range of issues, including; homelessness, mental health issues, sexual heath and teenage pregnancy, family breakdown, abuse issues, drug and alcohol dependency, disability and involvement in crime.
- 3.6 The Service is involved in the Families First agenda through attendance at weekly allocations and sanctions meetings for each area. From these meetings and information sharing processes we join up our services to compliment the offer from families' first services. This ensures more cohesive and appropriate responses to families, enabling vulnerable young people to be identified and supported as part of the wider intervention for a family by opening opportunities for young people to access mainstream provision. The youth work Team within the Tong Ward are particularly engaged with Families First and a clear referral process is in place.
- 3.7 The Youth Service plays a considerable role in the wider Crime agenda. We work closely with police colleagues to respond to many district wide crime issues, including a piece of work around reducing burglary and robbery to educate young people about the consequences of taking part in robbery and street crime. Alongside this we provide personal safety information to support young people in reducing the likelihood of them becoming a victim of robbery. All wards within the South area offer diversionary provision aimed at attracting young people away from anti social behaviour and crime at critical times e.g. weekends, night times and every school holiday periods. All the provision is available to young people for at least 50 weeks of the year.
- 3.8 As a service one element of core business is to ensure young people are able to make informed choices. The service delivered a district wide, targeted diversionary programme of activities to prevent vulnerable and at risk young people from getting drawn into protests in the City Centre on 12 October 2013. The early identification and intervention strategy to work with those most vulnerable enabled a tailored response to individuals. In total 558 young people were diverted into positive activities on the day. In the week running up to 12 October approximately 890 young people were supported through work in youth settings about consequences, though home visits and project based activity in local areas and out of the district for those identified as being most at risk. The reports of no arrests of young people aged within the service's 13-19 age range on the day indicates the successes of this approach. In Bradford South alone, over 156 of the most at risk young people were diverted away from becoming attracted the protest.
- 3.9 Full time Youth Workers attend Ward Officer Team meetings which address a range of community based issues with a number of partners such as Local Wardens, the Police, Housing agencies who alert staff to issues with young people. Each of the Wards in the District has a named youth worker who designs and coordinates activities for young people. **The South Youth Work Team is working with an**





increased number of Looked After young people and those involved in Child Sexual Exploitation.

4 OPTIONS

4.1 That the Bradford South Area Committee request a further report from the service in spring 2014 reflecting progress in meeting its targets.

5 FINANCIAL & RESOURCE APPRAISAL

5.1 There are no financial issues arising from this report. The development and implementation of all activity has been through has been provided from within existing Youth Service resources.

 - Support personal and social development of young people so they build the capabilities they need for learning, work, and the transition to adulthood
 - Improve young people's physical and mental health and emotional well-being;
 - Help young people at risk of dropping out of learning or not achieving their full potential to engage and attain in education or training; and
 - Raise young people's aspirations and build resilience
