1. SUMMARY

1.1 This report considers an objection to the recently advertised 24/7 permit parking zone for High Fernley Road and High Fernley Court, Wyke

2. BACKGROUND

- 2.1 Following the introduction of various traffic measures for Appleton Academy this Amendment to traffic regulation order, is being processed to pick up any anomalies and issues identified when the school first opened in 2012.
- 2.2 The new traffic regulation order includes all the properties within the schedule to the Permit parking aspect of the order, additional combination of business permit parking/limited waiting for a local business with no off-street parking facilities, additional waiting restrictions included to protect existing islands/bus operation and relocated the school bus stop away from the service stop/business, so it is adjacent to the school.
- 2.3 The objection is on the grounds that the severity of the restrictions on parking is far in excess of that which would be reasonable to prevent the undesirable congestion in the area of High Fernley Road and high Fernley Court, due to parking of vehicles delivering and collecting pupils from Appleton Academy at the start and end of the school day, Monday to Friday during term time. The total application of the restrictions prevents the reasonable use of street parking for visitors at other times of the day, at weekends and during school holidays. As each household is only allowed one visitor parking pass, only one vehicle is able to visit each address at a time. The objector finds it hard to believe the results of the study following the petition. The current arrangement restricts parking at times when there is no parking problem and this causes unnecessary inconvenience to residents and their visitors. This is not consistent with reasonable legislation.
- 2.4 A petition was considered by this committee on the 27th June, the petition wanted the 24/7 permit parking relaxing to 8am to 6pm, Monday to Friday. The Petition questionnaire was sent to 132 properties, asking the residents what they wanted either 24/7 or 8am to 6pm, Monday to Friday permit parking. The results were considered by committee on the 27th June, 39 households responded, 18 wanted change, whilst 21 were happy. The majority of the residents had not replied or asked for any changes to be made, committee's decision was that the petition be dismissed.

3.1 The Ward Councillors continue to support the 24/7 permit parking zones/parking places.


12. BACKGROUND DOCUMENTS
