#### 68. LORD MAYOR'S ANNOUNCEMENTS

#### NELSON MANDELA

It was announced that the Lord Mayor had opened a book of condolence and written to His Excellency the High Commissioner of South Africa to express sadness at the passing of Nelson Mandela, the first black president of South Africa, at the age of 95.

Members stood in silent tribute.

#### CITY PARK – THE MARSH AWARD

Judges from the Public Monuments and Sculpture Association had been highly impressed by their visit to the City Park and, on 6 November 2013, Bradford Council and Fountain Workshop Limited were named the winner of the Marsh Award, which recognised "the best use of moving water in the regeneration of urban public space". This was the ninth accolade to be bestowed on the attraction.

"We would like to ask, what this Council is going to do to help make our campaign a success and ensure that residents and businesses across all of the Worth Valley overcome growing disadvantage and are able to fully benefit from high speed Internet access to council, NHS, educational and business services now and in the future?"

### 74. YOUTH SERVICES

The motion was moved by Councillor Whiteley.

An amendment, as set out in the resolution below, was moved by Councillor Berry and was carried.

#### **Resolved** -

The Council recognises the value of youth services and the important work that they perform across the District and notes that:

- (1) Cuts in Government grants have forced the Council to reduce spending by over £100m in the last three years and the Council will have to find more cuts or extra income estimated at £115m over the next three years.
- (2) Along with other Local Authorities, the Council has already been actively lobbying Central Government to ensure that Government funding is sufficient to meet the needs of the population we serve.
- (3) The Executive's initial budget proposals are currently subject to an extensive programme of public consultation and to date no decisions have been taken however, the current administration has a track record of listening and responding to consultation.

The Council resolves to:

- (1) Keep working to ensure that a diverse offer of activities continues to be available to young people across the Bradford District.
- (2) Request that the Executive takes proper account of the outcomes of public consultation when formulating its final budget recommendations to Council.

#### 79. RECOMMENDATIONS FROM THE EXECUTIVE AND COMMITTEES RECOMMENDATION FROM THE EXECUTIVE – LOCAL PLAN CORE STRATEGY

Previous reference: Executive, Minute 63 (2013-2014)

The Assistant Director Planning, Transportation and Highways submitted **Executive Document "AJ"** to the meeting of the Executive held on 19 November 2013 on the preparation of the Local Plan (formerly the Local Development Framework) which would replace the current Replacement Unitary Development Plan for the Bradford District. The first of the Local Plan documents was the Core Strategy which set out the strategic approach to managing development and change to 2030. Following consultation on the Further Engagement Draft in 2011 and 2012, a revised draft had been prepared for submission to Government for independent examination.

Council resolved to suspend Standing Order 16 to enable amendments to be voted on in numerical order. Amendments moved by Councillor Love on Policy EC4 Sustainable Economic Growth mechanism I; Policy HO5 Density of Housing Schemes key objectives; Policy HO9 Housing Quality paragraph B and adding additional paragraphs; Policy HO11 Affordable Housing section B; Planning for Places Policy EN11; and a generic amendment on removing all references to 11,000 homes being built on green belt and by Councillor Cooke on Policy BD1 paragraph 10 were defeated. The other amendments moved by Councillors Cooke and Love were carried and it was:

#### Resolved –

(1) That the Publication Draft Core Strategy contained in Appendix 1 to Executive Document "AJ" be approved and the associated sustainability report for the purposes of submission to the Secretary of State for independent examination pursuant to Section 20 of the Planning and Compulsory Purchase Act 2004 subject to the following amendments:

#### Introduction (page 2)

Amend paragraph 1.1 to read:

1.1 Planning involves making decisions about the future of our cities, towns and countryside – where we work, where we live, where we play and how we are able to get to these destinations. It involves planning ahead to ensure that services, utilities and infrastructure are available where they are needed and attempting to balance different needs and goals ranging from our desire **to** for development, growth and regeneration to our desire to protect and conserve and enhance our built and natural environment. <u>We need to achieve a strategy for sustainable development that meets the needs of the present without compromising the ability of future generations to meet their own needs.</u> Plan making involves the process of combining research and analysis with engagement and consultation with all who have a stake in making our district a great place and in the process producing a framework of policies and proposals to guide future decisions on where development will take place and in what form. Ultimately plan making is aimed at creating sustainable and vibrant communities and places.

Amend A to read:

A. Effective collaboration between the Council, adjoining local planning authorities, **the District's Town and Parish Councils**, partners and communities within the District, Leeds City Region and beyond.

Under "Regional City":

Add new B7:

#### "Improve Connectivity between the City and the Airedale Regeneration Priority Area including access to the Regional City of Leeds via Otley Road."

Under "Local Growth Centres":

Amend B2 to read

"<u>Develop new and</u> improve<u>d</u> public transport links between Local Growth Centres and with Regional City of Bradford and the Principal Towns of Ilkley, Keighley and Bingley and also the Regional City of Leeds and the Principal Towns of Halifax and Skipton."

Amend B. to read:

"Proposals for development must identify potential nuisance issues (including noise, vibration, **<u>odour</u>**, light and dust) arising from the nature of the proposal and address impacts on that development from existing land uses."

## (2) That prior to submission the publication draft be issued for formal representations for a period of 6 weeks in the New Year.

- (3) That the Assistant Director (Planning Transportation and Highways) in consultation with the relevant portfolio holder be authorised to make minor amendments of redrafting or of a similar nature as may be necessary prior to formal publication for representations of the Core Strategy Publication Draft contained in Appendix 1 to Executive Document "AJ".
- (4) That delegated authority be given to the Assistant Director Planning Transportation and Highways in consultation with the relevant portfolio holder to submit the document to the Secretary of State once the 6 week period for representations has been completed.

#### 82. DISTRIBUTION OF PUBLIC SPENDING AND INVESTMENT

A motion, as set out in the resolution below, was moved by Councillor Green and was carried.

An amendment moved by Councillor Cooke was defeated.

#### Resolved -

This Council notes that there are regional imbalances in the current and proposed distribution of public spending and investment the consequences of which have seen:-

- Resources provided by Government to Bradford Council reduce by disproportionate amounts compared to some other parts of the country.
- Proposals to redistribute NHS funding away from Clinical Commissioning Groups in Bradford to other parts of the country.
- Long standing issues of lower levels of spending per person on infrastructure, transport, housing and culture in Yorkshire than in London, the South-East and Scotland.

The Council is concerned that if these trends continue they could lead to an increasing imbalance between local services and regional economies that will be detrimental to the interests of Bradford District, increase health inequalities between Bradford and other parts of the country and jeopardise the future viability of some public services.

The Council therefore resolves to request all Group Leaders to agree and sign a joint letter to the Chancellor of the Exchequer requesting that the Government urgently seeks to:

- (1) Re-profile the distribution of national public spending to address current inconsistencies and secure a balanced approach to economic investment and growth.
- (2) Ensure that a higher proportion of funding for local government is distributed according to need and that Councils are provided with the stability required to support effective financial planning.
- (3) Provide funding for all new responsibilities required of Councils arising from the Care Bill currently going through Parliament.
- (4) Recognise the cumulative effects of reductions in public spending on Bradford District.
- (5) Provide local government with increased powers to raise income and to deliver economic growth.
- ACTION: Chief Executive/Director of Finance

#### 83. REVEREND PAUL FLOWERS – BRADFORDIANS WANT CRYSTAL CLARITY NOT MYTHS

The motion was moved by Councillor Karmani.

### 85. WEST YORKSHIRE COMBINED AUTHORITY: GOVERNMENT CONSULTATION

The report of the Strategic Director Regeneration and Culture (**Document** "G") updated Members and sought approval from Council on the approach proposed to responding to the constitutional arrangements and functions of a Combined Authority for the area of West Yorkshire as set out in the Government consultation.

#### **Resolved** -

- (1) That the publication of the Government consultation paper which invites the submission of views by Thursday 2 January 2014 be welcomed.
- (2) That the proposed constitutional arrangements and functions of the Combined Authority as set out in the consultation paper be endorsed.
- (3) That the proposed approach to responding to the consultation be approved.
- (4) That the Chief Executive (in consultation with the City Solicitor and Leader) be authorised to make a formal response to DCLG confirming the Council's support for the establishment of the Combined Authority and to take such other steps as are considered appropriate to facilitate the preparation of the Order.

- (5) That the next steps and timetable be noted, and in particular that providing Government is satisfied that the proposals for a Combined Authority for West Yorkshire command wide local support and also meet the required statutory conditions, the Secretary of State will invite Parliament to approve the Order establishing the Combined Authority.
