**Review of Polling Districts, Polling Places and Polling Stations 2014**

This report details proposals in respect of the review of polling districts, polling places and polling stations, for consideration by Council and as required by law.

# 1. SUMMARY

- 1.1 This report is in respect of the review of polling provision and makes proposals for change, if necessary. It contains a summary of the findings and the Returning Officer's recommendations affecting polling district boundaries, polling places and polling stations.
- 1.2 The proposals in this report are put forward for consideration by Council and as required by The Representation of the People Act 1983, The Electoral Administration Act 2006, The Review of Polling Districts and Polling Places Regulations 2006 and The Electoral Registration and Administration Act 2013.

#### 2. BACKGROUND

- 2.1 The Council is required, by law, to review its polling districts, polling places and polling stations by 31<sup>st</sup> January 2015, in accordance with The Representation of the People Act 1983, Section 16 of The Electoral Administration Act 2006, The Review of Polling Districts and Polling Places Regulations 2006 and The Electoral Registration and Administration Act 2013. The previous review took place in 2011.
- 2.2 The review is undertaken to help improve polling provision and in particular to seek to ensure that:
  - all electors have such reasonable facilities for voting as are practicable in the circumstances
  - so far as is reasonable and practicable, the polling places are accessible to those who are disabled and
  - when considering or reviewing polling places, regard is given to the accessibility needs of disabled persons.
- 2.3 The Returning Officer is responsible for the provision of polling stations within polling districts and must make representations to the Council with regard to his proposals for suitable polling districts and stations within the electoral wards of Bradford.
- 2.4 The review commenced on 1<sup>st</sup> July 2014 with a consultation exercise, inviting representations to be submitted by 1<sup>st</sup> August 2014. Representations were sought from members of the public, elected Members, MPs, Parish/Town/Community Councils and disability/community groups.
- 2.5 Taking into account the submissions made, proposals were published on 15<sup>th</sup> August 2014 and a second consultation exercise, on those proposals was undertaken, inviting representations by 22<sup>nd</sup> September 2014. All Members were informed of the proposals and invited to comment.
- 2.6 Consideration was also given to the individual polling districts, polling places and polling stations, in line with the legislative requirements.





2.7 Following the consultation exercises and consideration of the comments received, the summary of proposed changes to polling districts, polling places, polling stations and recommendations, attached at Appendix A in this report, were prepared to be brought to Council for the meeting, 21<sup>st</sup> October 2014.

#### 3. OTHER CONSIDERATIONS

- 3.1 Council approval is required before any changes can be incorporated into the Electoral Register. In order to make changes to the Electoral Register to be published by the statutory date of 1<sup>st</sup> December 2014, approval is required at the meeting, 21<sup>st</sup>October 2014. Council is asked to consider the proposals made.
- 3.2 Following Council approval, the outcome of the review will be published, together with all representations made.
- 3.3 Changes made to polling districts, polling places, or polling stations will become effective for elections where the Notice of Election occurs after 1<sup>st</sup> December 2014.
- 3.4 It is the Council that designates a polling district as the polling place. This enables the swift activation of emergency changes to polling stations within a polling district, close to an election, when needed. This is the purpose of the option outlined at paragraph 9.2.

#### 4. FINANCIAL & RESOURCE APPRAISAL

- 4.1 The proposals, if approved, will achieve annual spending reductions in the region of £7340, which contributes to the Council strategy to use money wisely and which does not disproportionately affect electors or political parties.
- 4.2 The proposals, if approved, will contribute to increase resource effectiveness where the same polling station is used for more than one polling district, by combining polling districts, with no affect upon electors.

6.1 In approving the specific options, the Council would be compliant with the legislative requirements identified in this report.

polling stations. The rationale for these changes took into consideration the benefits of alternative voting arrangements offered by postal and proxy voting and accessibility, both in general terms and also under the Equalities Act 2010.

7.2.1 The proposals do not involve continued additional financial expenditure, or additional resources and in any event the arrangements are reviewed annually to make appropriate adjustments in line with electoral law.
