#### 12. PROPOSED STATEMENT OF LICENSING POLICY 2011-2014 FOR APPROVAL BY FULL COUNCIL

The Assistant Director, Corporate Services (City Solicitor) presented **Document "B"** which detailed the outcome of a public consultation exercise with regards to the new Statement of Licensing Policy for the District (Appendix 1 to Document "B"). It was explained that the Policy had to be reviewed every three years and a wide ranging consultation had been undertaken between 10 September and 19 November 2010. The main changes to the document related to the licensing of sexual entertainment venues; new mandatory conditions applicable to premises licences and other minor amendments from over the last few years.

In response to Members' queries the Assistant Director, Corporate Services (City Solicitor) confirmed that there had been very little change to the policy at this point as major alterations would be required once the new legislation was introduced.

#### Resolved –

- (1) That the Committee recommends to Council that Appendix 1 to Document "B" be adopted and published as the District's Statement of Licensing Policy 2011-2014, pursuant to the Licensing Act 2003.
- (2) That the Assistant Director of Corporate Services (City Solicitor) be given delegated authority to update pages 2 and 3 of the Statement of Licensing Policy (Appendix 1 to Document "B") relating to the Cultural, Tourism and Leisure context and also be given authority to make any necessary amendments of a minor or drafting nature prior to formal publication.
