1. SUMMARY

The application is for the grant of a Premises Licence for the sale of alcohol for consumption on and off the premises, the provision of regulated entertainment and the provision of late night refreshment.

2. BACKGROUND

2.1 The applicants

Ilkley Cinema Limited. A copy of the application is attached at Appendix 1.

2.2 The Premises

Ilkley Cinema, 46-50 Leeds Road, Ilkley, LS29 8DS.

2.3 Proposed Designated Premises Supervisor

John Tate.

2.4 Application

The application is for the grant of a Premises Licence. The operating schedule describes the following as the relevant licensable activities applied for:-

- Sale of alcohol for consumption on the premises
- Provision of regulated entertainment
- Provision of late night refreshment

Hours of licensable activities:

Sale of alcohol, provision of regulated entertainment (films, live music, recorded music) and provision of late night refreshment (from 23.00).

Monday to Saturday: 09.00 to 00.30 Sunday: 09.00 to 00.00

New Years Eve: 10.00 until 01.00 on 2 January.

2.5 Steps proposed by the applicant to address the Licensing Objectives

a) Prevention of crime and disorder will be achieved by;

The applicant has undertaken a risk assessment in connection with the operation of this unit taking into consideration the area in which it is located.





With regards to the prevention of crime and disorder the applicant would offer the following steps in order to address this issue:-

- 1. Alcoholic drinks may not be removed from the premises in open containers save for consumption in external areas provided for that purpose.
- 2. No customers carrying opened bottles of alcoholic drink upon entry shall be admitted to premises at anytime the premises are open to the public.
- 3. CCTV to cover the bar area. Data will be retained for a period of 31 days.
- b) Public safety will be achieved by;

The applicant has undertaken a risk assessment with regard to public safety.

This is a conversion of an existing premises Planning and Building Control are to be secured and the applicant will ensure that the fixtures and fittings provided to the premises will be of an appropriate nature.

The applicant undertakes to comply with reasonable requirements of the Building Control Officer and those of the Fire Officer. In any event, the approval of these statutory authorities will be required before the premises can open to the public.

c) Prevention of public nuisance will be achieved by;

The applicant has undertaken a risk assessment with regards to public nuisance.

The applicant proposes condition as follows:-

Where appropriate prominent and legible notices shall be displayed at all exits requesting the public to respect the needs of the local residents and to leave the premises and area guietly.

d) Protection of children from harm will be achieved by;

The restrictions set out in the Licensing Act 2003 will apply. No unusual or additional risk of harm to children have been identified.

- 1. No films or videos of any description will be shown so that they can be viewed by persons under the age of any applicable BBFC/Local Authority certification.
- 2. Children under the age of 16 shall not be permitted to enter the premises after 22.00 unless accompanied by an adult.





e) General – all four licensing objectives

This is an application for a new premises licence which is to support the opening of a small independent cinema in premises which have been used for some 10 years. Planning permission has been secured. The premises will have a 56 seat capacity and will be supported by a small reception bar area and lounge and external balcony. The premise is located in the predominantly commercial area and will be attractive to children, families and those wishing to see specialist screenings.

The above is provided by way of explanation and is not intended to be converted into conditions.

2.6 Relevant Representations Received

Individual, Body or Business

A representation has been submitted by a local resident. The representation raises concerns of anticipated noise and disturbance from patrons attending the premises and leaving the premises late at night.

The letter of representation is attached at Appendix 2.

3. OTHER CONSIDERATIONS

Legal Appraisal

- 3.1 The Licensing Act 2003 requires the Council to carry out its various licensing functions so as to promote the following four licensing objectives:
 - a) the prevention of crime and disorder
 - b) public safety
 - c) the prevention of public nuisance
 - d) the protection of children from harm
- 3.2 The Council must also have regard to the guidance issued by the Home Office under Section 182 of the Licensing Act 2003. Regard must also be taken of the Council's statement of Licensing Policy for the District.
- 3.3 Where it is decided it is necessary to depart from the statutory guidance or the Licensing Policy on the merits of a particular case; then special reasons justifying this must be given that can be sustained.
- 3.4 Only "relevant representations" can be taken into account. In order to be "relevant" a representation must fairly relate to achieving a licensing objective. If it does not, it must be discounted.





3.5 Any licensing conditions that Members may propose attaching must also relate to achieving one of the licensing objectives; be tailored to the actual premises and style of licensable activity; must be reasonably achievable by the applicant and in his/her control.

Statement of Policy Issues

Article 6 – A procedural right to a fair hearing. As refusal of the application is an option, adherence to the Panels' usual procedure of affording a hearing to the applicant is very important. The applicant should also be able to examine the requirements of the fire authority. If the decision is to refuse then reasons should be given.

Please give a general description of the premises (please read guidance note 1)

The applicant is proposing to convert premises situated at 46-50 Leeds Road, Ilkley into a boutique cinema operation which will be situated on the first floor which was formerly a night club. The cinema will have a 56 seat capacity and is intended to operate alongside a small bar and lounge area. It is intended that the applicants premises will provide sophisticated and pleasant experience for individuals to view main stream films but also those from the Independent Film Industry and to provide live screenings, National Theatre performances, those by the RSC and Royal Opera and to work in conjunction with the already established Ilkley Literature Festival and Ilkley Film Festival. Planning Permission has been granted.

The layout is proposed in accordance with the plans deposited with the Licensing Authority and numbered 320/02.15 Revision j illustrating the proposed first floor with supporting reception bar and lounge area. The first floor also has the benefit of a small external balcony.

The second floor which comprises of the projection room and then void comprising of the space above the auditorium seating.

All licensable activities are to take place internally in the area outlined in red. The licensable activities for the external balcony area are limited to retail sale of alcohol and late night refreshment only. On opening the premises will trade as Ilkley Cinema.

The following permitted licensing hours are sought for on and off sales of alcohol.

Monday – Saturday 09:00 to 00:30 hours Sunday 09:00 to 00:00 hours

The applicant seeks to authorise:

- Films, which will be provided in a standard cinema format and close seating arrangement.
- Live music which will predominantly be to occasionally support the viewing of films.
- Recorded music provided prior to, during and after the showing of films and to support corporate functions and private bookings of the cinema.
- Late Night Refreshment to cover the provision of hot drinks and light refreshment after 23:00 hours.

The premises will seek to close 30 minutes after cessation of licensable activities.

The premises will be open from 09:00 hours.

It is envisaged that during the daytime, films will be shown at regular intervals with the last screening being between 22:00 and 21:00 hours on weekdays and 22:30 and 23:00 hours on Fridays and Saturdays.
