1. SUMMARY

The application is for the variation of a premises licence to extend permitted hours for the sale of alcohol and provision of regulated entertainment and late night refreshment.

2. BACKGROUND

2.1 The applicant

Ghyll Beck Leisure Ltd. A copy of the application is attached at Appendix 1.

2.2 The Premises

Ghyll Beck Restaurant, Ghyll Beck Golf Driving Range, Esholt Lane, Baildon, Bradford.

2.3 Designated Premises Supervisor

Katrina Eileen Sheldon

2.4 Current Licence

The premises currently hold a Premises Licence with the following permitted hours;

Sale of alcohol for consumption on or off the premises, performance of live music, playing of recorded music, provision of facilities for dancing and provision of late night refreshment (from 23.00 hours).

2.5 Variation Application

The variation application has been submitted to extend permitted hours for the sale of alcohol, playing of recorded music and provision of late night refreshment (from 23.00 hours)

Monday to Sunday: 09.00 to 02.00

2.6 Steps proposed by the applicant to address the Licensing Objectives

a) Prevention of crime and disorder will be achieved by;

We think this will discourage binge drinking by opening longer hours. Staff monitor the alcohol levels of customers in order to prevent over consumption thereby preventing crime and disorder.

Our premises are fully lit, internally and externally.

Local licensed private hire companies drop off and pick our customers up at the door of the premises.

We have a zero tolerance to drugs policy which is clearly displayed.

b) Public Safety will be achieved by;

We have recently had a fire safety inspection report carried out in order to obtain our grant of approval of premises as a venue for marriages and civil partnership formations.

We also have very good relations with the local police force.

Our escape routes are all lit with emergency lighting and there are several emergency escape routes available.

We have trained first aiders to deal with any accidents using our well stocked and maintained first aid kits.

Our events always incorporate a seating plan which is fully documented in our diaries.

c) Prevention of public nuisance will be achieved by;

As we are out in the countryside with relatively no adjoining properties, therefore our customers will be less likely to encounter busy town centres as the event will start and conclude within our facilities.

We also have very close relationships with the local taxi firms, ensuring customers get home directly and safely.

By extending the licensing until 2am this will deter customers from leaving our premises at midnight looking for a further party at the local nightclubs.

Our events are privately booked and most attendees are guest listed.

We are responsible for our own noise levels, smells and litter.

Music levels are monitored and maintained to a reasonable level by our staff for the enjoyment of our customers, having recently been passed and checked by Environmental Health.

We have a full time groundsman who controls any litter which may arise from an event.

As we are situated in the countryside and are a private event venue, neighbours and noise do not present a problem to us too much but we still ensure that windows and doors are closed after the hours of 9pm and that guests leave the premises in a quiet and orderly manner.

d) Protection of children from harm will be achieved by;

Any children who attend our premises will be with their parents at a private event.

They will arrive and go home with their parents at a suitable time.

We have CCTV cameras installed throughout the public areas of the building.

All children are carefully monitored and cared for by all the staff employed here. There are family parties and events and any children will be fully looked after by their parents, grandparents, aunties etc. We operate a Challenge under 21 Scheme.

e) General – all four licensing objectives

All staff are fully training in regards to licensing issues.

A personal alcohol licence holder is always on the premises during licensing times.

We employ 2 fully licensed doormen when the event is for under 25 year old parties who conduct bag searches for drugs and for alcohol which has not been bought on the premises etc.

Most of our events are weddings with a more sedate calibre of clientele.

We have a live CCTV system installed within the premises which provides live images to our computer and also to our mobile smart phones, these include sound and images from over 16 cameras.

We are also fully monitored by SECOM PLC our premises alarm receiving centre.

A copy of the current operating schedule is attached at Appendix 3.

2.7 Relevant Representations Received

Individual, Body or Business

Ten letters of representation have been received from individuals. The representations raise concerns of an increase in noise nuisance from regulated entertainment at the premises and anti-social behaviour and noise nuisance from patrons leaving the premises late at night. The residents also have concerns about litter problems such as glasses and bottles being left in the gardens and broken glass on the road and noise from staff clearing the bottles and other rubbish after patrons leave the premises.

Legal Appraisal

- **4.1** The Licensing Act 2003 requires the Council to carry out its various licensing functions so as to promote the following four licensing objectives:
 - a) The prevention of crime and disorder
 - b) Public safety
 - c) The prevention of public nuisance
 - d) The protection of children from harm

- **4.2** The Council must also have regard to the guidance issued by the Home Office under Section 182 of the Licensing Act 2003. Regard must also be taken of the Council's statement of Licensing Policy for the District.
- **4.3** Where it is decided it is necessary to depart from the statutory guidance or the Licensing Policy on the merits of a particular case; then special reasons justifying this must be given that can be sustained.
- **4.4** Only "relevant representations" can be taken into account. In order to be "relevant" a representation must fairly relate to achieving a licensing objective. If it does not, it must be discounted.
- **4.5** Any licensing conditions that Members may propose attaching must also relate to achieving one of the licensing objectives; be tailored to the actual premises and style of licensable activity; must be reasonably achievable by the applicant and in his/her control.

Statement of Policy Issues

- **4.6** The following parts of the Licensing Policy are of particular importance; Part 4 (prevention of Crime and Disorder) and Part 6 (prevention of Public Nuisance).
- **4.7** The Annexes to the Policy sets out various types of model condition that could be considered.

- 5.1 Members may:
 - (a) Vary the premises licence as applied for subject to any mandatory conditions and the precautions specified in the operating schedule submitted.
 - (b) Vary the premises licence in whole or in part subject to such additional conditions relating to achievement of the licensing objectives as members think fit; or
 - (c) Refuse to vary the premises licence.
- **5.2** Should the applicant or any other party to the hearing feel aggrieved at any decision with regard to the licence or to any conditions or restrictions attached by Members they may appeal to the Magistrates Court.

(a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-

supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or

(ii) drink as much alcohol as possible (whether within a time limit or otherwise);

(b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or

6. (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

(2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

7. The responsible person shall ensure that-

(a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-

(i) beer or cider: ½ pint;
(ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
(iii) still wine in a glass: 125 ml; and



Annex 1 – Mandatory Conditions

- 1. No supply of alcohol may be made under the premises licence;-
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 3. (1) The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

(2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children–

(a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-

(i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or

(ii) drink as much alcohol as possible (whether within a time limit or otherwise);

(b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);

(c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;

(d) provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on–

(i) the outcome of a race, competition or other event or process, or

(ii) the likelihood of anything occurring or not occurring;

(e) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.

- 4. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 5. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.
- 6. (1) The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

(2) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark.

7. The responsible person shall ensure that-

(a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—

- (i) beer or cider: $\frac{1}{2}$ pint;
- (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
- (iii) still wine in a glass: 125 ml; and
- (b) customers are made aware of the availability of these measures.

Annex 2 – Conditions Consistent with Operating Schedule

8. The Licensee shall ensure that adequate supervision of the premises is maintained at all times during the carrying out of licensable activities and that any staff are trained in ensuring compliance with the licensing objectives at all times.

I would like to object to the following application for an extension to their current license for serving alchohol. I live directly adjacent to Ghyll Beck Driving Range, currently their licence extend to 12.00 with twelve variations per year. On the twelve occasions when they have had an extended licence there has been excessive noise as guests leave and then when staff are clearing up afterwards due to the rubbish and bottles being put out. As the guests leave while they are waiting for taxis they wander along the road causing noise nuisnace and the following morning my garden is littered with glasses and bottles amongst other items. The staff are then at the venue until 4 in the morning preparing for the following days events surely this could be done in

On one occasion last year, December 8th they did not have an extended licence but I was made aware whilst in my garden as I overheard staff talking to each other that they were working until 4 in the morning as they had a late licence and the venue had to be prepared for the next day,I spoke to the licensing officer who duly called them and advised that if this was the case then they would be in breach of their licence, had this not been done they would have carried on regardless with a total disregard to the Licensing Laws. Once againlast Friday 8th January there wasmusic and alcohol served until 1am ,this I am sure could be verified by the numerous security cameras which are inside and outside the premises, again a total flout of the licensing law.

During the events the windows, rear door are left open as is the kitchen door which increases the noise, due to the age of the building the windows are not triple glazed even if they were to be kept closed.

If their application of a 2.00am license was to be granted I would be concerened that it would be used more as a nightclub than a rural golf range and wedding venue which is within keeping of the rural community. They have a number of 18th birthdays and school proms although bouncers are employed occassionally I feel that they should be a regular condition due to the amount of people at the venue, the current owners do not have a DPS to act on their behalf to serve alcohol as they are often absent from the venue once the food has been served leaving the staff, who are mostly young people on their own to motivate guests to leave, close down and secure the venue, have any of the staff been trained in Licensing Laws and how to deal with guests who have a one too many.

I have also made several complaints to the environmental officer carol williamson as Ghyl Beck Driving Range have piped a drain into my garden causing flooding and have had numerous bonfires, both of these have been photographed and sent to the Environmental Officer, whilst I was taking the pictures I was verbally abused on three occassions by the gentleman making the bonfire, even though I was stood on my own garden. I feel that if this is the mentality of the staff then I feel that they should not be in a position to serve alchohol.

These are justa few of my objections to the extension and I would be grateful if you could let me know when this meeting will be held so that I may attend.

Please could you acknowledge receipt of this objection.

I understand that this restaurant has applied for a licence until 2pm every night of the week. We live in Esholt although at the other end of the village & we have lived here for over 20 years. We are however very concerned about this application. If it is an application to serve late for specific functions such as weddings then perhaps it is not unreasonable (assuming residents close by are happy which I doubt). However, if this is a general late licence intended to bring in late night drinkers from the surrounding areas (which is what we have heard) then we would be really concerned at the level of nuisance likely to arise & we would certainly wish to object. Our house is on the road down to the water treatment work s and that acts as a short cut for people walking – and even now we get youths under the influence walking past our house making a noise and not acting very considerately from time to time late at night. If this were to significantly increase throughout the village I can only see there would be an increase in unsocial behaviour / malicious damage. Houses like ours are a bit remote and it is scary if groups of youths congregate outside (as happened last weekend with a group of lads on quad bikes who raced up and down the road on Saturday night and rucked up a grassed area we have been trying to keep nice for village in bloom). Its fairly foolhardy to tackle them yourself in case of a consequence and they are gone by the time the police could attend.

This is a small village which already feels overwhelmed by visitors and excessive parking by day due to tourists and visitors to the farm & this has worsened considerably since we moved here. We feel very strongly that any further activities in the village that may cause even more concern to residents should be resisted strongly as its out of all proportion to the size & nature of the place which after all is a conservation area. I feel that late licensing laws such as attended should be restricted to commercial areas not allowed in areas such as this which has no relevant access to public transport etc etc. commercial areas can surely be more properly policed.
