# A. PROCEDURAL ITEMS

# 1. **ALTERNATE MEMBERS** (Standing Order 34)

The Assistant Director Corporate Services will report the names of alternate Members who are attending the meeting in place of appointed Members.

#### 2. DISCLOSURES OF INTEREST

(Members Code of Conduct - Part 4A of the Constitution)

To receive disclosures of personal and prejudicial interests from members and co-opted members on matters to be considered at the meeting. The disclosure must include the nature of the interest.

An interest must also be disclosed in the meeting when it only becomes apparent to the member during the meeting.

#### Notes:

- (1) Members may remain in the meeting and take part fully in discussion and voting unless the interest is prejudicial. A personal interest is prejudicial if a member of the public with knowledge of the relevant facts would reasonably regard it as so significant that it is likely to prejudice the Member's judgement of the public interest. The Member must withdraw from the meeting if the interest is prejudicial unless a dispensation has been obtained from the Standards Committee.
- (2) Members in arrears of Council Tax by more than two months must not vote in decisions on, or which might affect, budget calculations, and must disclose at the meeting that this restriction applies to them. A failure to comply with these requirements is a criminal offence under section 106 of the Local Government Finance Act 1992.
- (3) Officers must disclose interests in accordance with Council Standing Order 44.

# **B. BUSINESS ITEMS**

5. APPLICATION FOR THE REGISTRATION OF LAND AS A TOWN OR VILLAGE GREEN AT LAND KNOWN AS LAND AT ELLCLIFFE QUARRIES, TO THE NORTH OF IVY LANE, ALLERTON, BRADFORD

The Assistant Director, Corporate Services (City Solicitor) will present a report (**Document "A"**) which explains that an application has been received for the registration of an area of land known as land at Ellcliffe Quarries to the north of Ivy Lane, Allerton, Bradford as a Village Green from Mrs Beverley Porter supported by a number of local residents. The Council as Registration Authority must consider and determine the application.

## 6. POLICING AND CRIME ACT 2009 - SECTION 27

The Assistant Director Corporate Services (City Solicitor) will submit **Document "B"** which seeks Members views on the adoption of amendments to Schedule 3 of the Local Government (Miscellaneous Provisions) Act 1982, relating to the licensing of lap dancing, pole dancing and similar entertainment under existing legislation controlling sex establishments.

## Recommended -

- (1) That the Panel considers whether it wishes to recommend that Council adopt the provisions of Schedule 3 of the Local Government (Miscellaneous Provisions) Act 1982, as amended by Section 27 of the Policing and Crime Act 2009, and authorise the Assistant Director Corporate Services (City Solicitor) to complete all necessary legal procedures to formalise and advertise such adoption.
- (2) That if Council resolves to adopt the new provisions, Members are asked to authorise the Assistant Director Corporate Services (City Solicitor) to:
  - a) adopt on behalf of the Council proposed standard conditions for sexual entertainment venues attached at Appendix 1; and

b)	implement the proposed licence fee of £5658 for sexual entertainment
	venues and from time to time increase that fee in line with inflation
	where deemed necessary.
