#### 1. SUMMARY

1.1 This report seeks Standards Committee approval to a proposed guidance document to be provided to Elected Members setting out advice on the framework within which they are required to undertake their different roles.

#### 2. BACKGROUND

- 2.1 The Council's Constitution contains various documents which form the framework within which Members are expected to undertake in their role. In addition, there are a range of legal requirements of which Members must be aware to ensure they can operate effectively and within the law.
- 2.2 Attached at Appendix 1 is a proposed guidance document for Elected Members setting out the usual areas of concern or complexity and giving basic advice to assist Members in navigating some of these rather complex areas.
- 2.3 Standards Committee are asked to consider the attached guidance and comment on its effectiveness in supporting Elected Members to undertake their roles.
