#### 1. SUMMARY

1.1 This report presents information about Bradford LINk, HealthWatch pathfinder and the development of HealthWatch

#### 2. BACKGROUND

- 2.1 In 2007 Bradford Council contracted with Keighley & Ilkley Voluntary Services to deliver the Bradford LINk project for 3 years, with the option to renew for a further 2 years.
- 2.2. Bradford LINk's role is to provide opportunities for people to have voice and influence over the health and social care services that they use, or may use in the future. Specifically it:
- 2.2.1 Brings people together who share the same concerns
- 2.2.2 Brings groups of people together with commissioners so that their experiences and voices influence plans
- 2.2.3 Brings groups of people together with service providers so that their experiences and voices influence how services are run
- 2.2.4 Steps in when there is a problem to make sure that people using services and those running or planning them work together to resolve the problems
- 2.2.5 Works with people so they have the right knowledge and skills to be heard and to influence
- 2.3 Bradford LINk has a number of powers to help it carry out its functions:
- 2.3.1 Comment on the Quality Accounts that health providers publish every year as part of their annual reports. This enables the public to comment on health providers quality improvement agendas.
- 2.3.2 Conduct Enter and View visits to publically funded health services to make sure they are doing a good job
- 2.3.3 Question providers of health and social services in the district about concerns that have been raised by the public. Providers must respond to LINk within 20 working days.
- 2.3 In October this year, Bradford was one of 75 districts in England to be awarded HealthWatch Pathfinder status. Pathfinders are charged with testing out different methods of engagement and involvement and to produce evidence to help inform the development of successful models for Healthwatch
- 2.4 In Bradford, the HealthWatch Pathfinder is a partnership between Bradford Council, Bradford LINk, North Yorkshire LINk and NHS Airedale, Bradford and Leeds. It is focusing on developing effective public voice within the emerging Clinical Commissioning Group arrangements. Specifically:

'Strengthening the patient and public voice by building better partnerships between the GPs, health and social care commissioners, providers and advocacy services. This pathfinder will focus on effective ways of engaging and involving people in service planning and development, and understanding choice.'

2.5 Commissioning Bradford Healthwatch for October 2012 will be a separate process from the pathfinder process. It is intended that this should commence in December 2011.
