

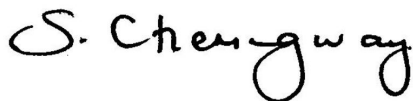

9 **NHS PARTNERS JOINT RESPONSE TO THE COUNCIL'S TWO YEAR BUDGET PROPOSALS 2014/15 AND 2015/16**

The Strategic Director, Adult and Community Services will submit **Document "T"** which requests that the Health and Wellbeing Board consider the response of NHS Partners, who are members of the Integration and Change Board, to City of Bradford Metropolitan District Council's draft budget proposals for 2014/15 and 2015/16, and to ensure that the response is considered by the Council as part of the on-going consultation process.

In accordance with Paragraph 9.4 of the Access and Information Procedure rules of the Council's Constitution, the chair of the meeting (Health and Wellbeing Board) considers that by reason of special circumstances the item should be considered as a matter of urgency. Given the timing of the Health and Wellbeing Board in relation to the full council meeting on 20th February 2014 which will determine the budget for 2014/15 and 2015/16, the meeting of the Health & Wellbeing Board on 23rd January is the final opportunity to consider the response from NHS partners. ICB received the paper on 17th January 2014, which necessitates this urgent item.

Recommended-

That the Health and Wellbeing Board consider the response from NHS partners to the draft budget proposals and that they are passed on to the Council for consideration as part of the on-going public consultation.
