



A. PROCEDURAL ITEMS

1. **ALTERNATE MEMBERS** (Standing Order 34)

The City Solicitor will report the names of alternate Members who are attending the meeting in place of appointed Members.

2. **DISCLOSURES OF INTEREST**

(Members Code of Conduct - Part 4A of the Constitution)

To receive disclosures of interests from members and co-opted members on matters to be considered at the meeting. The disclosure must include the nature of the interest.

An interest must also be disclosed in the meeting when it becomes apparent to the member during the meeting.

Notes:

- (1) Members may remain in the meeting and take part fully in discussion and voting unless the interest is a disclosable pecuniary interest or an interest which the Member feels would call into question their compliance with the wider principles set out in the Code of Conduct. Disclosable pecuniary interests relate to the Member concerned or their spouse/partner.
- (2) Members in arrears of Council Tax by more than two months must not vote in decisions on, or which might affect, budget calculations, and must disclose at the meeting that this restriction applies to them. A failure to comply with these requirements is a criminal offence under section 106 of the Local Government Finance Act 1992.
- (3) Members are also welcome to disclose interests which are not disclosable pecuniary interests but which they consider should be made in the interest of clarity.
 - (4) Officers must disclose interests in accordance with Council Standing Order 44.

3. INSPECTION OF REPORTS AND BACKGROUND PAPERS

(Access to Information Procedure Rules – Part 3B of the Constitution)

Reports and background papers for agenda items may be inspected by contacting the person shown after each agenda item. Certain reports and background papers may be restricted.

Any request to remove the restriction on a report or background paper should be made to the relevant Strategic Director or Assistant Director whose name is shown on the front page of the report.

If that request is refused, there is a right of appeal to this meeting.

B. BUSINESS ITEMS

4. URGENT AND EMERGENCY CARE STRATEGY 2014-19

Dr Andrew Withers will provide a presentation on the Urgent and Emergency Care Strategy 2014-19, which sets out how urgent and emergency care services in the district will be developed over the next 5 years. It reflects the plans of all NHS and social care organisations across the District and has a strong focus on joined up care, self care, prevention and improved management of long term conditions.

5. THE BRADFORD LOW EMISSIONS STRATEGY

Previous Reference: Executive Minute 57 (2013/14)

The Executive at its meeting held on 5 November 2013 considered the Bradford Low Emissions Strategy, it was resolved amongst other things that the Health and Wellbeing Board monitor progress on the strategy on a periodic basis.

In accordance with the above the Principal Environmental Health Manager and the Pollution Control Officer will provide a presentation that shows how the strategy relates to the wider responsibilities of Departments and partners and how the work can be progressed through a more integrated, partnership approach to make improvements to the health and wellbeing of the citizens of the District.

6. PHYSICAL ACTIVITY AND HEALTH IN BRADFORD

A report was brought to the shadow Health and Wellbeing Board in 2012 outlining the development plan for physical activity and sport strategy, and a method for monitoring the work to be progressed was agreed. With increased understanding for each department's objectives the work has continued and developed, delivering a range of strategies, activity and commissioning work. Examples of this work include the Cycling Strategy; Breeze rides, BEEP (Bradford Encouraging Exercise in People), physical activity for overweight children, new gyms and volunteer schemes.

The Director of Public Health and the Strategic Director Environment and Sport will submit **Document** "F" which reports that since the development of the strategy new policies and evidence have been developed to further strengthen the case for physical activity.

Recommended-

That the following be endorsed:

- Review the Physical Activity Strategy and Sport for Bradford and ensure joint planning and implementation by June 2015.
- Ensure ease of access and incentive to participate in physical activity is considered in local plans and strategies including the Local Development Framework, Supplementary Planning Guidance and Sustainable Communities Strategy.
- Support measures that achieve a modal shift away from cars in favour of walking, cycling and public transport, in terms of increasing physical activity, environmental and air quality improvements.

5. HEALTH AND SOCIAL CARE INTEGRATION AND TRANSFORMATION

The Board requested an update from Bradford and Airedale Collaborative Commissioners on joint commissioning, particularly in relation to commissioning from the third sector.

The Strategic Director Adult and Community Services and the Director of Collaboration NHS Airedale, Wharfedale and Craven, Bradford City and Bradford Districts CCGs will submit **Document** "G" which sets out the journey so far to integrate the health and social care systems across the Bradford, Airedale, Wharfedale and Craven Districts.

Recommended-

- (1) That the Board comments on the progress made towards integration across Health and Social Care.
- (2) That the Board identifies areas where the greatest efforts should be focused to achieve the most benefit for citizens.
