1.5 Variation Application

The variation application has been submitted to extend permitted hours for the sale of alcohol, provision of regulated entertainment & late night refreshment and amend Conditions 20 & 22 of the Licence.

Sale of alcohol, provision of regulated entertainment (live music, anything of a similar description, facilities for making music, facilities for dancing, facilities of a similar description) & provision of late night refreshment (from 23.00 to 05.00).

Amend Condition 20 to:-No under 18's shall be allowed on the premises at any time.

Amend Condition 22 to:-

A minimum of two SIA registered door supervisors shall be employed at the premises between 22.00 hours & 23.00 hours, 3 SIA registered door supervisors

between 23.00 & 00.00 hours and four SIA registered door supervisors between 00.00 and close of business at 07.00 hours.

1.6 Steps proposed by the applicant to address the Licensing Objectives

- a) All current conditions are to remain the same except conditions 20 & 22 annex 3.
- b) Public Safety will be achieved by;

c) Prevention of public nuisance will be achieved by;

All current conditions are to remain the same except conditions 20 & 22 annex 3.

d) Protection of children from harm will be achieved by;

All current conditions are to remain the same except conditions 20 & 22 annex 3.

e) General – all four licensing objectives

All current conditions are to remain the same except conditions 20 & 22 annex 3.

2. **Relevant Representations Received**

2.1 **Responsible Authorities**

West Yorkshire Police requested that condition 20 remains unchanged and condition 22 be amended as follows;

A minimum of two SIA registered door supervisors shall be employed at the premises between 22.00 hours & 23.00 hours

A minimum of 3 SIA registered door supervisors shall be employed at the premises between 23.00 & midnight

A minimum of six SIA registered door supervisors shall be employed at the premises between midnight and close of business, when the premises are open for licensable activities.

The Police have also requested that the following condition is placed on the Licence;

West Yorkshire Police shall be notified seven days in advance of any proposed event at the premises which will extend beyond 03.00 hours.

The applicant has already agreed to the above conditions being placed on the licence.

2.2 Interested Parties

Local residents/Businesses – 4 letters of representation have been received from local residents and businesses on the grounds of an anticipated increase in noise and disturbance from regulated entertainment and noise and anti social behaviour from patrons outside the premises.

The letters of representation are attached at Appendix 3.

3. Legal Appraisal

- 3.1 The Licensing Act 2003 requires the Council to carry out its various licensing functions so as to promote the following four licensing objectives:
 - a) The prevention of crime and disorder
 - b) Public safety
 - c) The prevention of public nuisance
 - d) The protection of children from harm
- 3.2 The Council must also have regard to the guidance issued by the Department of Culture Media and Sport under Section 182 of the Licensing Act 2003. Regard must also be taken of the Council's statement of Licensing Policy for the District.
- 3.3 Where it is decided it is necessary to depart from the statutory guidance or the Licensing Policy on the merits of a particular case; then special reasons justifying this must be given that can be sustained.
- 3.4 Only "relevant representations" by or expressly on behalf of a defined "interested party" or "responsible authority" can be taken into account. In order to be "relevant" a representation must fairly relate to achieving a licensing objective. If it does not, it must be discounted.
- 3.5 Any licensing conditions that Members may propose attaching must also relate to achieving one of the licensing objectives; be tailored to the actual premises and style of licensable activity; must be reasonably achievable by the applicant and in his/her control.

4. **Statement of Policy Issues**

- 4.1 The following parts of the Licensing Policy are of particular importance; Part 6 (prevention of Public Nuisance).
- 4.2 The Annexes to the Policy sets out various types of model condition that could be considered. Those in Annex A; Annex B; Annex D and Annex E may have conditions that are of particular relevance.

5. Legal Options

- 5.1 Members may:
 - (a) Vary the premises licence as applied for subject to any mandatory conditions and the precautions specified in the operating schedule submitted.

- (b) Vary the premises licence in whole or in part subject to such additional conditions relating to achievement of the licensing objectives as members think fit; or
- (c) Refuse to vary the premises licence.
- 5.2 Should the applicant or any other party to the hearing feel aggrieved at any decision with regard to the licence or to any conditions or restrictions attached by Members they may appeal to the Magistrates Court.

6. **Financial and resource appraisal**

6.1 There are no apparent finance or resource implications.

7.1 Equal Rights

There are no apparent community safety implications.

7.4 Human Rights Act

The following rights are applicable:

Article 6 - A procedural right to a fair hearing. As refusal of the application is an option, adherence to the Panels' usual procedure of affording a hearing to the applicant is very important. The applicant should also be able to examine the requirements of the fire authority. If the decision is to refuse then reasons should be given.



This letter is a formal objection from our client company Prudential Buildings Ltd to the application for the above Premises Licence Variation. Prudential Buildings Ltd is owned by the residential and commercial tenants of Prudential Buildings which is the building at the junction of Ivegate, Tyrell Street and Sunbridge Road and owns the freehold of the building.

The commercial tenants are the Co-operative Bank Plc, Sunbridge Optical Limited and Mr N McGawley t/a Firths. The residential tenants are the owners of the nine apartments above the commercial units.

In objecting to the application for the variation of the licence, we have been asked to make you aware of the fact that a number of the current licence conditions are not being adhered to.

1. On the first part of the variation application which is the opening hours being increased as follows:

For provision of: Sale of Alcohol:

Sunday - Thursday, 11.30am - 06.00 am / Friday & Saturday 11.00 am - 06.00 am

Late Night Refreshment:

Sunday - Monday 23.00 - 05.00

Regulated Entertainment:

Sunday - Thursday, 11.30am - 07.00 am / Friday & Saturday, 11.00 am - 07.00 am,

the requested opening times create issues for both the residential and commercial occupants of Prudential Buildings, particularly bearing in mind that the only entrance to the residential apartments in Prudential Buildings is directly from Ivegate and almost opposite the subject premises.

Throughout the daytime, the disabled entrance to the Co-op bank is located on lvegate, the people entering via this entrance are often elderly and vulnerable and would be intimidated by the

scenes of drunken activity and urination that occurred on lvegate when the venue was previously able to open in the day time. Indeed, The Wharf jewellery shop which objected to the last review of Funkys decided to move off lvegate specifically due to the issue of drunken behaviour and the consequences of this.

On a weekend and particularly at night, the residential owners of the apartments and their tenants live in fear of walking outside their own property due to drunken, violent, and uncontrolled behaviour of young drinkers at Funkys. The demand for drugs is also resulting in problems with vehicles parking directly outside the only entrance (and fire escape – see Appendix B) for the residential element of Prudential Buildings.

Bob Parker of Bradford Council has stated that West Yorkshire Police are struggling to maintain Operation Gridiron and as such the decision taken by the Licensing Panel needs to consider this fact. Extending the hours or decreasing the door staff will have a noticeable negative impact on the night time environment and economy and there is a genuine risk police resources maybe too stretched to deal with increased crime and disorder and public nuisance. We cannot stress enough how dangerous lvegate will become if it can no longer be policed as part of Operation Gridiron.

Please note that this objection is accompanied by a brief 7 minute DVD featuring very recent events recorded outside Funkys and Prudential Buildings and underlines all the concerns raised in this objection. A TV and DVD player will be needed to show this to the Licensing Panel and we would kindly ask that it is watched and listened to without interruption.

Prudential Buildings Limited objects to this particular variation on the following grounds:

1.1 The prevention of crime and disorder

a) **Patrons fighting.** Patrons of Funkys are creating an unsafe environment in Ivegate and surrounding areas due to the lack of any door policy, lack of any policy to control underage drinking and entrance to Funky's (see attached flyers). The number of door staff active on the door often does not meet the current licence obligations.

b) **Drugs**. The patrons are creating a demand, and hence the supply of drugs, resulting in vehicles being driven recklessly, including driving directly outside of the only access point to the apartments in Prudential Buildings. With any criminal activity it raises a danger and creates an unsafe environment for the residents of Prudential Buildings and members of the public.

c) Non SIA registered doorstaff. The Funkys venue is still unclear on the SIA rules, and whilst improving in this matter still has on occasion non-SIA staff tackling issues with patrons outside of the premises. The SIA staff and non-SIA staff alike are often abandoning the door completely especially at the venue's official closing time, although the venue chooses to allow entry and exit for at least 45 minutes after such times.

1.2 Public safety and the prevention of public nuisance.

a) **Patrons fighting.** A number of the fights occurring have involved many of Funkys patrons at any one time. There is a complete loss of order and a potential for innocent bystanders being caught in between fighting groups.

b) **Vehicle issues.** Vehicles are driving aggressively in an effort to park up near to the barriers which separate Funkys from the rest of lvegate on a weekend. The occupants can also be aggressive and involved in criminal activity as will be seen from the DVD.

c) **Noise.** Whilst the owners of the venue have sound proofed the venue physically to an acceptable level, the anti-social behaviour of it's patrons caused by the venue failing to close promptly is causing a disturbance for up to an hour after official closing. The vehicles attempting to supply drugs to the patrons of the

venue are causing a noise nuisance due to the engine noise and occasional use of horns.

The proposed increase in the permitted hours will have a negative impact on the above Licensing Objectives and principles for the above reasons.

2. On the second part of the variation which is the age of the patrons being lowered as follows:

To remove condition 20 which reads: "No under 21's shall be allowed on the premises at any time". To be replaced with: " No under 18's shall be allowed on the premises at any time"

Prudential Buildings Limited objects to this proposed condition on the following grounds:-

2.1 The prevention of crime and disorder and Public safety and the prevention of public nuisance.

a) The current age limit is not being adhered to, and the venue is activity promoting under age drinking. Our clients are very concerned at the bad faith the owners of the venue are showing to the licensing panel and authorities in Bradford and it's neighbours by knowingly and actively showing gross disregard for the current limit of 21 (see appendix A - where we have recorded under 18's). The venue has been for some months engaged in a marketing campaign directed at youngsters as young as 16. Funkys promoter has posted flyers onto personal "Myspace" pages of youngsters in Bradford and sent messages via "Facebook". The youngsters accounts clearly show their age to prevent accidental and inappropriate marketing, This behaviour is grossly irresponsible and speaks volumes for the intention of this amendment which will simply make enforcement by the licensing authorities more difficult as the venue will be able to plead ignorance when under 18's are found in the venue. Clearly given the age difference from 18 to 16 is so small a doormen could claim an underage patron looked 18, where the current under 21 rule would make such a claim tenuous at best. Funkys promoter appears to have assumed the use of modern marketing techniques would go unnoticed and unchallenged by the licensing authorities.

b) Given the owners of the venue have not understood the current licensing condition, any lowering of the age limit, will merely reward bad practice and set a disturbing precedent for other venues to follow. Other Bradford venues will be encouraged to market in the same manner and know they can do so without repercussions. As youngsters are more susceptible to peer pressure and internet advertising, the effects of the greater availability of alcohol and drugs on lvegate will result in an increased negative effect on the problems already being experienced.

c) And finally a quote from a post on the promoter's own myspace page sums up what we can all expect:

"Heyyy ive got myself another job promotinggg so here u go..... If u LOOK 18 n want cheap drinks then come down :)"

Once again this proposed variation will have a negative impact on the Licensing objections and principles.

3. On the third variation which is the number of SIA door staff being reduced as follows:

To remove condition 22 which reads: " minimum of one SIA registered door supervisor shall be employed at the premises from the start of business until 1900 hours and a minimum of four SIA registered door supervisors shall be employed from 2100 hours until close of business" To be replaced with: " A minimum of 2 SIA registered door supervisors shall be employed at the premises between 22.00hrs & 23.00hrs, 3 SIA registered door supervisors between 00.00hrs & close of business at 07.00 hrs

Prudential Buildings Limited objects to the proposed variation on the follow grounds:-

3.1 The prevention of crime and disorder and Public safety and the prevention of public nuisance.

a) At least one door supervisor is needed through the day time. The venue and indeed lvegate has a poor history with regard to the behaviour of day time drinkers and given Bradford already has significant issues in keeping retail units open, and any move which results in drunkenness, disorder and street urination is only going to drive trade away. The Co-op bank uses the lvegate entrance specifically for elderly and disabled customers who would be intimidated by such scenes.

b) The variation as proposed leaves a gap between 23:00 and 00:00hrs. The variation needs clarification. Clearly an adequate number of door staff need to be on duty at this time.

c) The door supervisors do not have sufficient numbers to contain order at the current time. In recent weeks and months, fights between Funkys patrons and general disorder have been a significant concern. If anything the door staff needs increasing and certainly should not be decreased. Funkys has made a conscious choice to not maintain a dress code and to target at younger drinkers, so it has created a problem that it should take the responsibility to control.

d) The hours for the presence of door staff need to specified as 1 hour after the official closing time. As the withdrawal of door staff at the official closing time is occurring whilst patrons are still drinking up and entering and exiting the premises, door staff need to be present until the doors are physically locked and the external lights are turned off.

Once again this proposed variation will have a negative impact on the Licensing objectives and principles.





Re: Funkys Nightclub, Ivegate, Bradford BD1 1SW

On behalf of Bradford City Centre Residents' Association (BCCRA) I write to object to the application by the licensee of the above premises – Derek Greenaway – for a substantial variation to the conditions of the existing license. Our organisation is recognised by Bradford Metropolitan District Council and by West Yorkshire Police as representing all those who live within the regeneration boundary.

This boundary takes in the residential area in which Funkys Nightclub is situated: apartment blocks which would be directly affected by relaxing the present licensing conditions include Landmark House facing onto Bridge Street, Ivebridge House on Market Street, Prudential Buildings on Ivegate, The Empress on Sunbridge Road and the flats at 49 Bank Street.

BCCRA would like to take this opportunity to acknowledge the excellent work of West Yorkshire Police in reducing criminal activity throughout the city centre, and the similarly excellent work of Bradford Metropolitan District Council and Bradford Centre Regeneration in improving the public domain.

Public Safety

"Derek Greenaway, the premises license holder said "There will be no baseline [sic] at all, because baseline sadly causes problems in Halifax, Leeds and all over the place."

(Telegraph & Argus, 1/11/07)

This assertion is in line with a report by the Yorkshire BBC television programme Inside Out entitled 'Bassline and Gang Culture' (18/09/07). BCCRA believes that it is essential that a strong presence of SIA registered doormen is maintained at all times in any venue electing to hold bassline events, and would therefore not support the proposed removal of condition 22.

The Protection of Children from Harm

The licensee's undertaking to stop bassline events did not last long: just three months later the club hosted '*Stush meets Bassline Flavaz*'. BCCRA is concerned that this event was advertised as suitable for over 18s, flouting Funkys' over 21s license (www.clubtickets.com, 16/02/08).

We further understand that evidence will be presented to the panel suggesting that events are being actively promoted to even younger individuals. BCCRA would ask that this allegation is investigated by the police before any variation to the present licensing restrictions is authorised.

The Prevention of Crime & Disorder

"Bassline music seems to attract people who have a real liking for serious violence. Most of the firearms incidents at nightclubs in Sheffield would be around the bassline scene," says Inspector Neil Mutch."

(www.bbc.co.uk, 18/09/07)

In August Club Icon on Westgate, BD1, had its license revoked following a fatal shooting. The venue held regular bassline events and was known amongst locals for disturbances (Telegraph & Argus, 26/08/08). There are indications that Funkys Nightclub is attracting similarly unpleasant patrons, with one clubber attacking a member of staff so violently that

"Licensee Derek Greenaway ... said Mr Ellison's injuries were the worst he had seen in 15 years working in the pub and club trade."

(Telegraph & Argus, 13/05/08)

We would also request that that the panel considers that Ivegate is acknowledged by Bradford Metropolitan District Council as a magnet for substance abusers, such that it has recently been necessary to install a sharps depository. BCCRA understands that allegations of overt drug dealing to patrons of Funkys Nightclub are the subject of an ongoing investigation by West Yorkshire Police. We therefore ask that the police are allowed to complete their investigations before any variation to the present licensing restrictions is authorised.

The Prevention of Public Nuisance

In the evenings Market Street has historically been a surprisingly peaceful place to live. However, I have personally witnessed several late night scuffles on the corner of Market Street and Ivegate this summer – a substantial rise on previous years. There has also been an increase in noise in the early hours of the morning as clearly inebriated patrons depart from licensed premises.

Whilst BCCRA does not attribute these problems to any one establishment, it is intuitive that extending the opening hours, sale of alcohol and entertainment license of any of the nearby premises would prolong the period of the disturbance suffered by local residents.

I trust our objections will meet with the panel's approval.
