I am writing to register my objection to the above application. My reasons for opposing this application are listed below.

- 1. On occasions there are incidents of late night noise outside Chutneez by persons who are clearly the worse for wear due to alcohol. They have obviously had too much to drink and are not concerned about disturbing local residents. This has occasionally happened as late as 1am.
- Chutneez sometimes play their music loudly with the shop door wide open clearly showing little, if any regard for local residents. We certainly do not want this happening any later. This is a residential area and I, for one sometimes have to get up for work at 4.30am.
- 3. Youths sometimes gather outside Chutneez and, although on the whole do nothing wrong, again they can generate disturbing levels of noise.
- 4. Although not often, there have been occasions when police have been called due to trouble outside Chutneez. This can be quite distressing to people who just want to live in peace, yet feel compelled to observe such events due to wanting to keep an eye on their cars and property, etc.
