4. INTRODUCTION OF STREET TRADING RESTRICTIONS IN BINGLEY

The Assistant Director, Corporate Services (City Solicitor) presented a report (**Document "A"**) which detailed the results of the statutory consultation exercise and advertisement period that was initiated in order to consider the introduction of street trading restrictions in various streets within Bingley town centre. Members were informed that no representations had been received and that a plan of the proposed prohibited area and consent streets/area was attached at Appendix 1 to Document "A". It was also noted that if a person engaged in street trading in a prohibited area or engaged in street trading in a consent area without authorisation they would be guilty of an offence and be liable to a fine.

Resolved –

That street trading restrictions for the streets referred to in paragraph 5.1 of Document "A" be introduced within Bingley Town Centre.

5. MODEL STANDARDS 2008 FOR CARAVAN SITES IN ENGLAND CARAVAN SITES AND CONTROL OF DEVELOPMENT ACT 1960 – SECTION 5

The Assistant Director, Corporate Services (City Solicitor) presented a report (**Document "B"**) that sought approval of the adoption of the Model Standards 2008 for Caravan sites in England. The standards only applied to those sites which contained caravans that were used as permanent residential units and replaced the Standards set in 1989. Members were informed that if adopted the proposed standards would apply to new caravan site licences or those sites that had been substantially redeveloped.

In response to Members' questions it was noted that the licence would tie in with the planning permission for the site in question and that the new Standards updated references to fire safety and other regulations.

Resolved –

That the new Model Standards 2008 for Caravan Sites in England in Appendix 1 to Document "B" be adopted and attached as conditions to site licences issued by the Council in future.
