1.0 SUMMARY

1.1. This report considers objections to a recently advertised Traffic Regulation Order for No Waiting At Any Time restrictions on Spring Mill Street, Bradford

2.0 BACKGROUND

- 2.1. Planning permission (REF: 16/03406/FUL) has been granted for the construction of a bus depot with associated access on Spring Mill Street, Bradford.
- 2.2. One of the conditions requires a Traffic Regulation Order (TRO) to implement No Waiting At Any Time restrictions on various sections of Spring Mill Street.
- 2.3. Following the advertisement of the proposals, 9 objections have been received. These include 8 representations from local businesses, and one from MP Imran Hussain. A summary of the points of objection and corresponding officer comments is tabulated below:-

Objectors concerns	Officer comments
Reducing the number of available parking from the street will affect business.	The proposed waiting restrictions at the development site are required to protect sightlines and maintain access for vehicles entering and exiting the proposed bus depot. Further short lengths of restrictions are proposed to ensure safe access between Manchester Road and Spring Mill Street.
Congestion on street.	The introduction of waiting restrictions should not lead to an increase in congestion.

3.0 OTHER CONSIDERATIONS

3.1. Local ward members and the emergency services were consulted on the original proposals.

4.0 FINANCIAL & RESOURCE APPRAISAL

4.1. The estimated cost of the proposals is £7,000 and will be met by the developer.

5.0 RISK MANAGEMENT AND GOVERNANCE ISSUE.

5.1 A failure to implement appropriate waiting restrictions at this location would result in potential access issues and restricted sightlines for the new development along with the likelihood of conflict at the Spring Mill Street/ Manchester Road junction.



1.0 SUMMARY

1.1 This report considers an application for a Disabled Persons Parking Place where the applicant does not meet all the Policy criteria.

2.0 BACKGROUND

- 2.1 The Council has received an application for a Disabled Persons Parking Place from the occupant of 19 Hill Side Terrace. The resident who lives here is registered disabled, received PIP at the higher rate and holds a current Disabled Person's Blue Badge. There is no off-street parking at these premises.
- 2.2 The criteria for eligibility for a Disabled Persons Parking Place require that the applicant:
 - i. holds a Disabled Person's Blue Badge,
 - ii. has a vehicle registered at their place of residence,
 - iii. does not have accessible off-street parking e.g. hard standing or garage, and
 - iv. receives either:
 - a) the Higher Rate Mobility component of Disability Living Allowance, or
 - b) the Higher Rate of Attendance Allowance
 - c) the Mobility component of a Personal Independence Payment (PIP)
- 2.3 The applicant meets 3 of the 4 criteria listed in para. 2.2, but does not currently have a vehicle registered at the address and is currently being visited by care workers and family members in their vehicles for ongoing support.
- 2.4 A plan showing the indicative location of a Disabled Persons Parking Place outside 19 Hill Side Terrace is attached as Appendix 1.

3.0 OTHER CONSIDERATIONS

- 3.1 The applicant has ongoing medical conditions preventing her from being able to support herself independently and relies on the help of family and the community health nurses within the district. The Council has received supporting documentation from Bradford District Care detailing the applicants ongoing medical conditions including difficulty in walking and the ongoing long-term need for support from NHS nurse visits and family members.
- 3.2 As part of the Disabled Persons Parking Place application investigation process, officers undertake consultations with adjacent neighbours to determine if there are any objections to the proposal. This consultation is usually undertaken as a second stage, following successful verification of the criteria being met. In this instance, however, the consultation has already been undertaken (to avoid a scenario whereby the Area Committee approves the exception to the policy but the application then meets with objections from neighbours, thus requiring a further report to the Area Committee). There were no objections from neighbouring properties.





4.0 FINANCIAL AND RESOURCE APPRAISAL

4.1 A budget of £8,000 for the provision of Disabled Persons Parking Places across the Bradford East constituency has been approved as part of the 2017/18 Safer Roads schemes programme. If approved, this parking place would be implemented as part of the overall programme of Disabled Persons Parking Places in Bradford East.

5.1 There are no significant risks arising out of the implementation of the proposed recommendations.



1.0 SUMMARY

1.1 This report considers objections received to a recently advertised Traffic Regulation Order for Killinghall Road, Bradford proposed in association with the provision of a pedestrian refuge island and footway build-outs at the junction with Ellerton Street.

2.0 BACKGROUND

- 2.1 At its meeting of 11 July 2017 this Area Committee approved as part of its Safer Roads schemes programme the provision of a pedestrian refuge island on Killinghall Road near Thornbury Road and associated footway build-outs at its junction with Ellerton Street. A Traffic Regulation Order for No Waiting at Any Time restrictions on both sides of Killinghall Road at this location is proposed to ensure the free flow of traffic past the refuge island and good visibility for pedestrians and drivers. Double yellow lines are also proposed at the junctions of Killinghall Road with Carrington Street and Thornbury Road to improve visibility for drivers. It is also proposed to remove some of the existing peak hour parking restrictions between the pelican crossing south of Carrington Street and Barkerend Road where parking would not impede through traffic. The scheme will provide a facility for pedestrians and thereby improve road safety at a location where there have been 8 collisions in the last 5 years, 6 of which have resulted in pedestrian injuries.
- 2.2 The location of the proposed refuge island and footway build-outs, and extent of the proposed waiting restrictions are shown on drawing No. HS/TRSS/103756/TRO-1A attached as Appendix 1 to this report.
- 2.3 The Traffic Regulation Order was advertised between 10 November and 1 December 2017. At the same time consultation letters and plans were delivered to residents and businesses affected by the proposals. This has resulted in three objections one of which is a petition and one representation regarding the proposals.
- 2.4 A summary of the valid points of objection and corresponding officer comments is tabulated below:

	Objectors	concerns
Objector 1		

The objector claims to have had a meeting with residents of Killinghall Road and Ellerton Street and they feel the new refuge island will make matters worse in terms of safety for the public. The road will be narrowed with the island and changes to parking restrictions will be detrimental to road safety on Killinghall Road and Ellerton Street. The full wording of this objection is given in Appendix 2.

Officer comments

Sufficient carriageway width can be maintained for the passage of traffic past the refuge island provided that the proposed double yellow lines are implemented .The narrowed road with the island will make it easier for pedestrians to cross Killinghall Road and therefore improve road safety. The existing single yellow line on Killinghall Road is only operational during peak hours. Outside these hours the residents and any visitors to the area are able to park on Killinghall Road. The relaxation of these

parking space in this area.

Objection 2- Petition (40 signatures)

The petition opposes the traffic calming measures to include double yellow lines on Killinghall Road. The petitioners concerns relate to a reduction in the availability of parking space. The full wording of the petition is given in Appendix 3.

The double yellow lines are proposed only where necessary to ensure the free flow of traffic past the refuge island and to protect sight lines for pedestrians crossing and for drivers negotiating junctions onto Killinghall Road. Existing single yellow lines prevent the residents of Killinghall Road parking outside their houses at peak times; it is proposed to relax these restrictions. The proposed double yellow lines will be outside 3 residential properties and one business, 2 of the residential properties have off-street parking. Given that vehicles should not be parking within 10 metres of a junction approximately 5 parking spaces will be lost.

The petition was collected by a business on Killinghall Road. No residents from the affected area of Killinghall Road signed the petition and only one resident of Ellerton Street.

Objector 3

The objector is concerned that the provision of double yellow lines will lead to parking on the footway and grass verge and that will be detrimental to the area. Also that the double yellow lines will not be enforced.

Waiting restrictions cover the full width of the highway to the back of the verge or footway; therefore parking on the footway or verge will be in contravention of the Traffic Regulation Order and the Council Wardens will be able to enforce the restrictions.

2.5 A letter of representation has also been received from a resident of Killinghall Road concerned about the removal of the single yellow lines on the east side of Killinghall Road between Barkerend Road and Warley Drive. They are concerned that parking will take place obstructing driveways and reducing visibility for drivers exiting driveways. They also comment that a refuge island exists at Chelmsford Road and feel that the need for another island close to this should be reconsidered and the funding spent elsewhere. Despite making the forgoing comments this resident has stated that if the single yellow line is not removed from in front of their property they do not object to the scheme.

Officer comment: It is not proposed to remove the single yellow line from the frontage of the objector's property. In the last 5 years there have been 8 incidents causing road injury on the section of Killinghall Road between Chelmsford Road and the pelican crossing south of Carrington Street, 6 of which have involved pedestrians. The provision of an additional pedestrian facility on this length of road is therefore justified on casualty requestion arounds.


