1. SUMMARY

1.1 Consideration of one objection received to a proposed Traffic Regulation Order (TRO) to introduce no waiting at anytime restrictions on Laycock Lane and Chapel Road, Laycock.

2. BACKGROUND

- 2.1 Requests have been received from WYCA and the local bus operator to introduce no waiting at anytime restrictions on the junction of Laycock Lane and Chapel Road, Laycock.
- 2.2 The junction is used as a turning head for the K1 bus service between Keighley and Laycock. Buses from Keighley pass the junction mouth on Laycock Lane before reversing back into Chapel Road and heading back towards Keighley on Laycock Lane.
- 2.3 A location plan identifying Laycock Lane/Chapel Road, Laycock and the proposed no waiting at anytime restrictions are identified within the plan, attached to this report as Appendix 1.
- 2.4 These proposed restrictions are considered necessary to ensure that the junction is kept clear to facilitate the necessary bus manoeuvres and maintain the bus timetable.
- 2.5 The proposed TRO was formally advertised on 22nd June 2017 for a 3 week period and resulted in the receipt of 1 objection. These objections, along with officer comments, are tabulated in Appendix 2.



Objector's comments	Officer comments
 We have never seen anyone parking on the white lines on Chapel Lane. "We've only once seen anybody park at the very bottom of Chapel Lane where there is no lines but this was for about 5 minutes so any lines would make no difference." 	 The proposed no waiting at anytime restrictions on Laycock Lane/Chapel Road, Laycock was requested by the bus company as a result of their drivers' experiences.
"The proposed lines extend further up Chapel lane than the present white line, where nobody ever parks (because they would be totally blocking the road to vehicles)."	
"The bus has <u>never</u> been unable to reverse because of a cars parked on Chapel Lane. When the bus reverses up Chapel Lane it stops all traffic and pedestrians because it fills the whole width of the road."	
"The problem on Chapel lane is not parked cars but turning buses. Some drivers find it difficult to reverse even though there are no parked cars, sometimes hitting our wall or the church yard wall. Since they have increased the size of the buses they have found it harder to manoeuvre, getting stuck between the traffic sign and bus stop having to forward and reverse repeatedly, mounting the pavement where pedestrians are waiting to cross and hitting the for sale sign on number 7. We have heard that two drivers have refused to do the Laycock run in the new buses. The bus service is a boon to the community but smaller buses would be an improvement to the flow of traffic."	
"When there is a problem with cars, it is not parked cars but the moving	ge 7

traffic which has to stop while the bus manoeuvres. Sometimes there are a number of vehicles, some of whom are unfamiliar with the buses routine and become impatient or get in the way."	
• "We object to the unnecessary cost of introducing double yellow lines, as they would have no effect on the traffic conditions visibility, access or safety."	 Costs will be met from the Committees capital allocation.
 "We object to the addition of yellow lines, which would be ugly and unsympathetic to the area, it's architecture and it's streetscape and contrary to the requirements of the conservation area, especially where there are no lines at all at present." "In Bradford Council's CONSERVATION AREA ASSESSMENT October 2005, it states on page 22 in section 7. 'Conclusion: Character Summary'- " The width and informality of the roads is part of the rural character of the location and should not be regularised or improved"." 	 We will be introducing "Conservation" double yellow markings - 50mm "Primrose yellow" lines instead of 100mm "Lemon yellow" lines

1. SUMMARY

- 1.1 This report details how the Planning, Transportation & Highways service currently manages the Local Highway Maintenance (LHM) function and allocates resources.
- 1.2 It also updates the committee with regard to current operations being undertaken on the network and the indicative costs of works undertaken in the current financial year.

2. BACKGROUND

- 2.1 Local Highway Maintenance issues were devolved to Area Committee control in July 2013.
- 2.2 As part of the commitment to the devolution process, information relating to the operation of Local Highway Maintenance is to be reported to the Area Committees on a regular basis.
- 2.3 The need to undertake highway repairs throughout the District is identified through a variety of sources including:
 - General public calls to the customer contact centre
 - Inspections as a result of service requests dealt with by the Area Teams or as a result of observations by highway officers in the course of undertaking other duties
 - Programmed condition, safety and other surveys
 - Safety Inspections
 - Reports from Ward Members

Where repairs to the highway are required these are categorised, depending upon the severity of the issue, into one of three categories (CAT1, CAT2 or CAT3). Each category has a target repair time which has been agreed with the Council's Insurers.

- 2.4 CAT1 reports from the public and technical staff are passed directly through to the Council's Highway Delivery Unit (operational arm) and allocated to the work crews for immediate inspection and necessary remedial works.
- 2.5 CAT2 reports are assessed by technical staff and collated into operational zones so that operational gangs can visit and patch affected areas in a co-ordinated manner.
- 2.6 CAT3 sites are assessed by technical staff and ranked on a priority and needs basis, with works allocated to operational staff by the HDU Operations Manager.
- 2.7 Operational resources may be redeployed at short notice to deal with specific issues. Gang sizes may vary depending on demand, staff leave and sickness. Service Level requirements, such as the need to respond to an extensive number of CAT1 requests or the need to respond to emergency planning issues, may also have an effect on the availability of operatives.

- 2.8 Some technical and operational staff are required to facilitate the needs of the winter service between November and April each year.
- 2.9 A list of work types covered by the Local Highway Maintenance budget is included in Appendix 1.
- 2.10 A breakdown of the current technical staff allocation and an overview of their duties is included in Appendix 2.
- 2.11 A breakdown of operational staff and their duties is included in Appendix 3.
- 2.12 Currently reported CAT1 and 2 details are included in Appendix 4.
- 2.13 The current list of completed and ordered CAT3 works is included in Appendix 5.
- 2.14 A list of completed gully cleaning in the Keighley constituency is contained in Appendix 6.

3. OTHER CONSIDERATIONS

3.1 Due to the constantly changing state of the highway and unpredictability in new matters arising or being brought to officers' attention, there may be a requirement to amend programmes in order to address emerging priorities.

4. FINANCIAL & RESOURCE APPRAISAL

- 4.1 The overall 2017/18 budget for Local Highway Maintenance work, carried out by the Council's Highway Delivery Unit, is **£1.541m**.
- 4.2 The allocation for the Keighley constituency is **£351,185**.
- 4.3 Spend this financial year to 30th September on all categories in the Keighley constituency is **£55,410** (16% of allocation), broken down as follows:-

£27,430 has been spent on CAT1/2 repairs **£8,929** has been spent on drainage work including new gullies, new pipework/connections, dyking and repairs to existing pipework and culverts **£6,949** has been spent on CAT3 repairs and works, including footway reconstruction

£12,102 has been spent on CAT3 planned carriageway patching work

5. RISK MANAGEMENT AND GOVERNANCE ISSUES

5.1 Alterations to work programmes that have been prioritised in accordance with condition inspections and technical assessments may lead to increased insurance liabilities at a future date.

6. LEGAL APPRAISAL

- 6.1 There are no specific legal issues arising from this report.
- 6.2 All works are carried out within the Council's powers as Highway Authority under the Highways Act 1980.

7. OTHER IMPLICATIONS

7.1.1 Due regard is given to Section 149 of the Equality Act 2010 when formulating a programme of highway maintenance repairs. Ensuring safe surfaces for all users, including those with special needs/requirements, is prioritised.

Appendix 1 – Work Undertaken as Part of the LHM Function.

The following is a list of work types funded by the Local Highway Maintenance budget and undertaken by the Council's Highway Delivery Unit:

- CAT1 Potholes reactive response footway and carriageway
- CAT2 Defect response/patching footway and carriageway
- CAT3 Repairs & works footway and carriageway
- Planned carriageway patching works
- Kerbing, channelling and edging works
- Large and small element footway repairs block paving/flagging
- Footway reconstruction taking up damaged flagged areas and replacing with tarmac
- Highway Drainage repairs exploratory trial holes, dig outs of blocked gullies, dyking, drainage connections, repairs to damaged culverts (including the cost of hiring specialist equipment/subcontractors for deep excavations)
- Emergency call out response including road traffic accidents, recovery of dead animals, flooding, traffic management/road closures, dealing with requests from the Police, requests from Emergency Planning
- Planned gully cleaning of 97,304 units across the district
- Repairs to minor highway walling elements
- Winter maintenance road gritting, footway gritting, ploughing, grit bins, etc. (separate budget but re-directs resources from above)

Staffing costs are also included within this budget.

Appendix 2 – Technical Staff Overview

Technical staff are currently deployed in each constituency area team reporting to the relevant area Principal Engineer for Highway Maintenance.

Staffing is allocated in the following manner: (*Please note the roles and duties described are indicative only and do not represent the full spectrum of works carried out by individuals*).

Senior Engineer

- Co-ordinates the actions of the Highway Inspectors.
- Responds to queries and complaints from the public relating to highway maintenance matters.
- Develops and co-ordinates network condition and works programme lists in conjunction with the Major Maintenance team.
- Investigates larger network issues across the constituency area.

Highway Inspector (General Maintenance)

- Responds to complicated complaints and issues on the highway network that require technical assessments.
- Undertakes driven and walked inspections of the network on a scheduled basis.
- Undertakes general condition surveys
- Works on a roaming basis across the constituency area

Safety Inspector

Four Safety Inspectors operate across the whole of Bradford District working to a set inspection regime to comply with the requirements of the Councils insurance policy. These inspectors report to the Principal Engineers for Highway Maintenance North and South, with CAT1 & 2 repair works ordered as necessary – this supplements the General Maintenance function.

NRASWA Inspector (reports to the Principal Engineer for Network Resilience)

- Inspects works carried out by statutory undertakers to ensure consistent standards of repair
- Co-ordinates repairs with utilities
- Works on a roaming basis across the constituency area

Appendix 3 – Operational Staff Overview

Operational staff are contracted to work the following hours:

07.00 to 16.00 Monday – Thursday 07.00 to 12.30 Friday

A standby crew is available outside these hours to deal with emergency issues as and when they arise.

Operational resources are deployed across the five constituency areas, reporting to 3 programme managers under the direct control of the Operations Manager. At present, resources are allocated as follows for the operational areas of Keighley and Shipley:-

• Patching gang (3 FTE: all CBMDC)

Work gangs carrying out planned patching of carriageways across the constituency areas. Gang is deployed on an 'as needs' basis.

• <u>Scheme gang (2 FTE: both CBMDC + 1no. sub-contract JCB and operator)</u>

Work gang operating in each constituency area, carrying out larger repairs on tarmac areas, flagging, kerbing, highway drainage and miscellaneous issues on carriageways and footways. Gang is deployed on an 'as needs' basis.

• <u>Patching/Scheme gang (2 FTE: both CBMDC)</u>

Work gang carrying out patching or scheme work as described above. Gang is deployed on an 'as needs' basis.

• CAT1 and CAT2 gang (2 FTE: both CBMDC)

CAT1/CAT2 masonry and pothole gang - reactive crews dealing with complaints received from the public and issues raised by the area Highway Inspectors.

CAT1 work is carried out as necessary within 24 hours.

CAT2 work is carried out on a 5 day rotation as per the Council's standards for response.

• Drainage gang (2 FTE: both CBMDC)

Responsible for highway drainage issues.

• Gully Cleansing Operations (3no. gully tankers, 6PTE)

One vehicle covers Keighley and Shipley constituencies and two vehicles cover Bradford West, East and South constituencies. With a total of 97,304 gullies across the district, these vehicles clean 50-80 gullies per day. Main arterial routes are cleaned annually, secondary routes and side roads are cleaned on average every two years. There is also a proactive and higher risk based approach to cleaning busy junctions and areas on a steep gradient.

1.1 This report informs the Area Committee of the progress made in relation to the establishment of the new Youth Offer across the Bradford District and the contribution of the Youth Service to delivering the 5 Key Elements in the Keighley Area.

2. BACKGROUND

- 2.1 The Assistant Director for Neighbourhood and Customer Services presented a report to the meeting of the Children's Overview and Scrutiny Committee on 12th April 2017. This report set out an Action Plan for progressing the Youth Offer for the Bradford District.
- 2.2 A Youth Offer Working Group oversees the implementation of the Youth Offer Action Plan which supports the Council's budget considerations in relation to Youth Work and its future in the district. There have been closer working relationships developed across the Youth Sector with representation from the Voluntary Sector, the Council, the Police, Community and Faith sectors, working together to develop and lead the Youth Offer Action Plan. This working group feeds into the core strategic group of the Young Lives Bradford Network and the Safer and Stronger Communities Partnership – Active Communities Group. There was recognition of the need to do things differently and to increase the sharing of resources and expertise from across the sector. The Youth Offer Action Plan and achievements for 2016-17 are detailed in Appendix A of this report.
- 2.3 The Council's Youth Service is a key player in the development and delivery of the Youth Offer in the district. Recent budget savings have driven and heightened the need to do things differently and to work closer with a wider range of youth sector providers. The development of a "Key Individuals Network" for organisations and adults who work in the voluntary, community and faith side of the Youth Sector in the District has a sign up of 118 organisations. Added to the network supported by Young Lives Bradford there is significantly more routes and opportunities to share and promote opportunities for young people, training for staff and volunteers and to share details of funding pots that may support youth work delivery.
- 2.4 The Youth Offer for the district comprises of 5 key elements:
 - Information and advice
 - Voice and influence
 - Open access
 - Targeted provision
 - Active citizens and young people's contribution towards community life

2.5 Information and advice

a) District-wide Youth Offer

i) Bradford Council's Information service for young people have operated for many years from two key locations – the Information Shop for Young People, sited within the Culture Fusion premises and the Keighley Connexions Centre sited in the Keighley Town Hall. What is evident is that young people are seeking less Information, Advice and Guidance (IAG) from these two stars 30

- ii) Information Services from the two existing locations is no longer viable in the face of reduced resources, but the commitment to provide good quality and trusted IAG is still considered to be essential for the districts young people. The Youth Service has now developed an alternative model of support for young people in relation to IAG in the district. This has seen the relocation of information workers to the Customer Services Team based in Britannia House and Keighley Town Hall, offering opportunity to expand the existing offer by sharing knowledge with the existing customer services team. This provision operates alongside a wider offer from a broader range of community settings (both voluntary and statutory) which will ensure increased locality based support for young people to access IAG.
- iii) Working with the Safeguarding Children's Board and the Virtual College we have been working to strengthen the offer around IAG and create a web based 'App'. Recognising that national use of the smartphone stands at 72%, in Bradford this is even higher with 76% of the population engaged in smartphone use. In terms of technology and its use, Bradford outshines the national picture with 81% liking or loving technology compared to 78% nationally (Mosaic Research 2016). Young people have helped the virtual college to shape the App and engagement will continue once the app is launched in terms of feedback around ease of use, information supplied etc. to ensure this remains relevant to young people. As always with online developments there are many considerations to ensure online safety for the users and the log in arrangements have leaned into data sharing agreements which has meant this has not progressed as speedily as we would have wished. However, it is felt that we are now in the latter stages of this piece of work and this would hope this will be able to be launched in early November.
- iv) We have undertaken work with the Children's Commissioner for England to explore her desire to develop a National App based on IAG for more vulnerable young people, particularly those at risk from CSE. This is to be called "Is It OK?", and whilst this has some distance to travel before it will be live, Bradford's young people have contributed significantly in helping the Commissioners Office to understand how young people use the different platforms within social media and what they consider to be trusted sources of information. Bradford has agreed to be a pilot area, (alongside a London Borough) for the App which is expected to be several more months in its development.

b) Youth Service – Keighley

March 2016 to April 2017 the Keighley Youth Work Team engaged with 1,970 individual young people in the Information Shop. The main topic areas where young people requested support was as follows: -

Employment, Education and Training	= 858
Law and your Rights	=361
General IAG	=613
Health	= 47
Housing/Emergency Housing	= 30
Money and Debt Advice	= 45
Referrals to Counselling etc.	= 16

- i) Since the changes with the Information shop in April 2017, the Keighley youth work team have worked creatively with young people and partners to ensure they continue to receive an IAG via open access youth provision in local neighbourhoods. Discussions have and continue to take place with customer services to ensure that there is IAG available at Keighley Town hall. In addition it is hoped that the IAG worker based at the centre will be able to reach out to support drop in sessions and events run by the youth work team.
- ii) IAG is embedded through the wider youth offer. The needs of young people are met through staff working on a one to one basis, signposting and by working alongside partner organisations to set up services. For instance weekly sessions have been set up at Keighley College where young people can come along and join in activities, access youth support, information on education, training and employment, and volunteering opportunities. Time to talk drop-ins within open access provision have been set up enabling young people to have access to one- to-one IAG and young people are sign posted to specialist projects and organisations
- iii) Young people have been engaged in the consultations about developing the youth app, with over ten young people from Keighley attending an event at Margaret McMillan Tower to help with its design. Once launched young people will be encouraged to download which will support the IAG work currently being carried out.

2.6 Voice and influence

a) District-wide Youth Offer

- i) The Youth Voice Framework young people have developed a Youth Voice Framework as part of the Children and Young People's Priority 6 (see Appendix B).
- ii) Using the Youth Voice Framework we have run 15 district-wide cross sector Youth Voice events which have influenced key plans around services for young people. This has included identification of the Top 10 priorities for young people in relation to the development of the District Plan, the priorities for the Children, Young People and Families Plan and development of the IAG App. Attendance by young people to the Public Forum for Education saw young people raising their concerns around the future of education in the District Further meetings with lead members for

education enabled young people to raise and discuss their concerns directly and start to better understand the role they can play in contributing towards the District's Education Covenant.

- iii) West Yorkshire Police has used the district Youth Voice to undertake consultation around an awareness raising poster campaign that is to be rolled out into key transportation hubs across West Yorkshire. This campaign is aimed to support more vulnerable young people in indentifying signs of abuse and CSE, and to signpost them towards help and support services.
- iv) The voice of transgendered young people the Youth Service has maintained a partnership working with voluntary sector providers that has enabled the continuation of provision for LGBT young people. More recently the Youth Service has made significant steps in developing provision specifically to meet the needs of transgender young people. This has seen the local authority Youth Service, partner with the national organisation Gender Intelligence and through sharing of resources we have shared knowledge and expertise that has enabled supportive work to be established in the district for transgendered young people and in return 24 staff and volunteers have received introduction training for working with young people.
- Growing up North working with young people from across the District V) Bradford has hosted a team from the Children's Commissioner's Office to explore the impact on where you live on your aspirations and successes. Early in the year we facilitated the visits to more vulnerable young people. including those who were living in Care, in supported housing or who were homeless. The findings of the Commissioner's visit (see Appendix C) have been presented back to young people and the strategic director for Children's Services, and has been key in shaping the District Plan and the Children and Young People's Plan. This has been followed up with further work and the creation of a film which has been used to launch the 12 month project. The launch at the BBC in Salford in December 2016 was the start of the voice and influence by Bradford's young people on the Northern Powerhouse developments. Young people who made the film had opportunity to attend the launch and chat to decision makers about their aspirations for Bradford and its future.
- vi) The Takeover Challenge this was an opportunity for young people to "takeover" adult roles for the day, and during that takeover to have their voices heard. Professionals agreed to a young person taking on their role for the day. Working with a steering group of young people we saw a diverse range of opportunities taken up by young people including roles in health, the Council, Housing and voluntary sector agencies. 82 young people and 17 schools offered "takeover" opportunities that supported young people into decision making roles which included local and strategic levels. For young people this had been an empowering experience with a team of roving reporters working alongside the 'Takeovers' to capture and record the day. Following positive feedback from both professionals and young people we are looking to run the

"Take 2 Takeover" on the 24th November 2017 in line with the national Takeover Challenge

- vii) Young people's mental health services at a previous Children's Overview and Scrutiny Committee meeting young people raised their concerns around services to support their mental health. Following this a further Committee meeting was established bringing the Health and Children's Overview and Scrutiny Committees together to hear what young people had to say. Young People presented a report with recommendations called "Help today's youth to help tomorrow's Bradford". The joint Committee agreed that a sub group would be established to receive a response to the young people's paper. This response was heard on 27th March 2017, and a follow up joint Overview and Scrutiny meeting is due to take place in late November which will enable the Committees to review the progress and receive feedback from young people on the changes to services.
- viii) The Youth Survey across the Youth Sector a survey was undertaken in October/November 2016 to identify and inform the future direction of youth work in the District. This survey saw 1,700 young people completing the survey which gives some clear directions in terms of the needs and priorities for young people. Highlighted issues from this survey are how young people feel people from different backgrounds generally get on with each other, how adults respect young people, how safe they feel when it's late and dark and during the daytime and the pride they feel about the area in which they live. The Youth Survey results will be examined closely by the Youth Offer Working Group and responses to the findings will be embraced by the working group in the development of the Youth Offer Action Plan. Young people from across all communities have contributed to the survey with each area asked to undertake around 200 surveys.
- ix) Interview panels during recent months we have worked with the Department of Children's Services Senior Management Team to support their interviews for key strategic positions including the Safeguarding Children's Board Manager and the Head of Social Work Service. This has seen a unique opportunity for young people from different organisations to come together to be key contributors and to influence decision making at a high level in being part of a process of appointing lead officers for services for children and young people.

b) Youth Service – Keighley

i) The Youth Survey

Appendix D sets out some of the highlights from the Youth Survey for the Keighley Area. The following action/activities etc. have been undertaken in response to the results of the survey:

Five hundred and thirty seven young people completed the survey. The survey reflected that young people were most concerned about safety after dark, community relations in the area, ASB and their level of influence locally. The paperity of young people felt safe during the day,

felt able to pursue their hobbies and interests and were interested in volunteering.

The youth work team have set up a number of sessions, activities and initiatives in response to the survey. Young people have participated in community clean ups, district wide events, single gender work, IAG sessions, drops ins, volunteering briefings, the setting up of weekly wellbeing sessions, sports activities and befriender training. Please see Appendix D for a detailed response to the Young People's Survey.

Voice and Influence is at the heart of all youth work delivered however the survey reflected that the majority of young people felt that they were unable to have influence in their local area. It is perhaps that they feel it is outside the youth work setting were they lack influence. The youth work team have put together a strategy to address their feeling around the level of influence they have locally. The strategy is based around giving young people knowledge and experiences which will enhance their self-confidence to engage in decision making processes.

Sessions around awareness of their rights and responsibilities and an understanding of decision making process are being delivered to young people both in youth sessions, on the streets and in schools. Opportunities to participate in consultations and shape services have been taken up by young people. These have included identifying young people's top 10 priorities for the District plan, shaping of Early Help, Health Watch, Public Education Forum, West Yorkshire Police, and Growing up North.

Over a dozen young people participated in National Take-Over Day. Taking up the challenge in schools, with voluntary sector partners and community groups. One young person spent the day shadowing Assistant Director Jenny Cryer.

One young person was involved in the recruitment to the Safeguarding Lead post and the Head of Social Work. Another young person is an observer on the Children's Services Overview & Scrutiny Committee and a further four young people where involved in the recruitment of a new manager in the Social Care team in Keighley.

'Your Voice, Your Vote sessions have run across the Area and young people have been encouraged to register to vote.

Young people who have expressed a keen interest in making changes in their communities are given continuous opportunities to further develop their skills, knowledge and interest. In Autumn and Spring 2018, young people are planning to send invites to set up spaces for them to engage with their local ward councillors and MP.

2.7 Open access

a) District-wide Youth Offer

- i) **Youth Work Grants –** working with the Youth Offer Working Group and Young Lives Bradford we have, in the last 12 months, undertaken a radical overall of the grants allocated to the Voluntary Sector for the delivery of youth work. The budget of £311,000 was retained but needed to be aligned to the priorities of the Youth Offer Action Plan, with an emphasis on projects meeting gaps in services and contributing to the wider district youth offer. For the first part of the financial year we retained the existing 13 providers, but were able to create 2 strands to the funding from Quarter 3 onwards. The remaining funding in 2017-18 saw 22 providers securing awards for the delivery of sessional youth work (week in week out type provision) and 3 securing awards to seed fund a piece of developmental youth work. A further round to consider further one off seed funding for developmental youth work for delivery in 2018-19 has seen a further 11 providers securing grants. This is a significant increase in providers with the funding supporting 36 VCFS led initiatives. Early indications from the first round of sessional work are that 656 young people have benefitted from 415 sessions within Quarter 3 of the financial year 2016-17. Quarter 1 figures have seen increases to 977 individual young people benefitting from 476 sessions.
- ii) Accreditation and The Duke of Edinburgh's Award Youth workers have worked with 241 young people to gain Accredited Outcomes in 2016-17. This includes ASDAN qualifications, the Lord Mayor's Award and The Duke of Edinburgh's Award.
- iii) In partnership with the Regional Duke of Edinburgh's Award Charity we have successfully remodelled the provision and accessibility for young people to enrol on the Award across the Bradford area. This model has seen 28 schools directly licensing their Award activity to the Awards Operations Team, with 1985 young people enrolled to participate. In addition to this there are 805 young people gaining full awards, which is more than 3 times as many as last year's and puts the figure at an all-time high. In addition there are various voluntary organisations operating through the Bradford licence, who again this year have seen growth. Through direct support from the operations team over 100 members of teaching staff have received introduction to Duke of Edinburgh's Award and eDofE training, 40 new Award Expedition Assessors have been trained and 24 new Expedition Leaders have been trained.

The local authority Youth Service retains a licence to continue to deliver the Award until March 2018. Currently it runs Award activity in 4 constituency locations, supporting 452 individual participants. Since April 2016 the Youth Service has supported young people to complete 136 Awards (88 Bronze, 37 Silver and 11 Gold Awards). The Youth Service provision is heavily reliant on a team of youth service volunteers who support the direct delivery of the Award and particularly the expedition section. We are working directly with the Award volunteers and the Regional Award office to explore different deliver models for the continuation of some of the Award related work which will include sourcing alternative funding streams for some groups. The Youth Service retains a store of outdoor education equipment, which is available to any young person in the district regardless of where they take part in the Award. We have, during the last 10 months worked closely with a team of volunteers in preparation for the transition of the management of these stores to a voluntary sector group. This will enable and support young people to be able to both continue to access equipment, but also to undertake volunteering hours by supporting the running of the stores.

b) Youth Service – Keighley Area

iv) Youth Service Ward-based provision – The Youth Service continues to offer a ward-based open access provision as part of the Youth Offer. There are 47,817 young people in the 13-19 cohort and during 2016-17 there were 7,572 individual young people who have attended one or more Youth Service sessions. These provisions are detailed in the profiles of provision in Appendix E and are led by a ward-based youth worker. Increasingly we are seeing sessions delivered in partnership with other youth providers which is increasing the use of resources and removing duplication. The Youth Service continues to have a pivotal role in empowering and supporting the development of locality-based provisions for young people. This includes working with and alongside volunteers in a range of settings and supporting training and skill building to deliver ward-based provision.

2.8 Targeted provision

a) District-wide Youth Offer

- i) Early Help The changing face of Early Help has see youth work input into the 2 pilot Early Help hubs in Keighley and BD3, 4 and 5. The learning and successes of these pilots have enabled a district wide roll out of the Early Help model in January this year. These 5 hubs will see increased joining up and co-ordinated responses to families and young people from across the youth sector within the hub areas, ensuring families and young people have the best possible voluntary engagement and interventions early in the life of identified problems.
- ii) Targeted Support The Youth Service continues to identify through its needs assessments areas of targeted support. This includes work undertaken in school settings through the provision of Teenage Information Centres/Teenage Advice Centres (TICTACs) where one-toone support can be provided on a broad range of social and emotional issues. Commonly youth workers are supporting young people in increasing resilience and critical thinking around issues such as bullying, mental health and relationships.
- iii) CSE Hub Youth Workers are working closely with the district wide CSE Hub, taking referrals for young people at Tier 1 (low risk), identified as those who undertake or are in peer groups where there are concerns or risk taking behaviours. The Youth Service Youth Workers have worked with 64 young people since this work commenced, providing 1-1 support, and using a 'Signs of Safety' framework to enabling these young people to develop local support networks and feel empowered to make positive choices in their lives. Page 37

- iv) Youth Work Grants the realignment of the Youth Work Grants has seen a significant increase in the number of Voluntary, Community and Faith providers securing grants for youth work. This means we are beginning to build clearer evidence of an increased offer to those groups identified previously by the Youth Offer Review as being "bordering on insufficient services". This included young people who were affected by drug misuse, young parents, LGBT young people, young people who had been homeless, missing from home or had ran away and those who were from New Migrant Communities or who had mental health problems.
- v) Fire Fit Bradford has seen the first cohort of young people through the Fire Fit Training. Run by West Yorkshire Fire Service this is a programme designed and targeted towards young people who have disengaged with physical activity. It uses fire fighter training as a tool for re-engaging young people into regular physical activity.
- vi) Bradford District Police through their Safer Neighbourhoods and Partnerships Team are undertaking a range of projects offering targeted youth provision. The vast majority are focused on engagement of vulnerable young people, with opportunities for young people to gain an insight into policing. Through the Police partnership working they offer a range of activities designed to divert young people away from crime, especially in the school holidays. The E-Safety Team engages and educates young people around online safety, with school and community engagement opportunities. The Police Spring, Summer and Autumn camps recruit staff and volunteers from a wide range of services to deliver diversionary activities in school holiday periods. The Police **Explorers** programme offers young people 15-18 a real insight into policing, working on evenings and weekends to undertake project work. **Safer Schools Officers** are aligned to schools in the district and run bespoke sessions with students. The **Police Ridealong Scheme** offers young people 16-18 years an opportunity to work alongside a police officer whilst on duty.

b) Youth Service – Keighley Area

The youth work team have run a number of initiatives to support vulnerable young people.

One-to-one support

The Youth Service, as a partner in the Youth in Mind partnership, offers a one-to-one service to vulnerable young people who have emotional or mental health issues. Referrals are taken from CAMHS through the Buddies project. The team also receives referrals from the CSE hub, the Gateway and the Early Help panel. Each young person is offered one-to-one support and worked with for twelve weeks with a final assessment completed using either Signs of Safety or MYMUP. Workers draw up a plan with the young person identifying challenges they face and building stepping stones to overcome challenges. At the end of the 12 weeks young people are offered the opportunity to engage in youth service provision or any other activities of projects that they are interested in.

Two of the youth workers have been trained to deliver the WRAP course (Wellness Resilience Action Planning). WRAP is a closed group which runs for 12 weeks for young people who have been referred for one to one support. Its focus is self-care and resilience. Having attended the WRAP young people are encouraged to participate in the mental health drop-in session which is a step towards the participants self-managing and getting support from their peers.

On a Thursday evening the Keighley team in partnership with Project 6 operates a weekly a drop in for vulnerable young people who have been referred to the service. The sessions are focussed on emotional wellbeing with young people identifying what subject areas they would like to discuss

Tic Tac

The Youth Service offers 5 hours per week one to one support in Oakbank School for students who need emotional support. Referrals are made by school staff. Issues raised include self-harm, low self-esteem, domestic violence, and anger management. Young people are given space to explore issues and supported in putting together action plans and coping strategies.

Young people have had one-to-one support and engaged in a number of activities such as youth voice events, body positivity sessions, organised fund raising events, attended residential, and had the opportunity to meet specialist workers.

Anti Social Behaviour (ASB)

Over the year requests have come to the service from, police, ASB panel and councillors to carry out detached work in hot spot areas. All requests have been met and programs of activities have been carried out targeting young people involved with ASB.

In Keighley West, three six week programs for young people involved in ASB or at risk of ASB have taken place. The programs gave young people a space to gain a better understanding of ASB, explore their attitudes and behaviours and look at the consequences of ASB and crime on others and themselves. These were delivered in partnership with JAMES and involved girls only, boys only and mixed groups which have enabled a range of positive activities for young people to take place. Another partnership with the Big Local enabled small group work sessions with young people to try out different activities such as team building at Doe Park, sports activities and cooking.

Child Sexual Exploitation (CSE)

A range of initiatives have been developed to build resilience for vulnerable young people involved with CSE or at risk of CSE. Amongst these have been personal development courses, understanding relationships, social media risks and safety. Single gender work has been developed and a magging women's session is being piloted in Keighley Town Centre in partnership with Step2 and Hand in Hand. Youth workers from Keighley have a key role in delivering training to other professionals in using resources, some of which have been developed in house by the Keighley youth work team. In addition Youth workers have carried out streetwork sessions in partnership with the Night time economy worker from Barnardos.

Inclusion

The Keighley Team continues to support the delivery of three open access sessions. These sessions are now well established and receive a number of referrals from Social Care, Early Help, local Schools and individual families. Over 80% of the young people attending these weekly provisions have disabilities and the projects have seen young people grow in confidence and their ability to engage. Recently the Inclusion Project at Ilkley has set up a Youth Committee which aims for young people to direct the delivery of the project. In addition to developing links with People First Keighley, advocating for themselves and others with learning disabilities to ensure their voices are heard. Another aspect of the Keighley Inclusion sessions is the opportunity for main stream young people to improve their life skills and to volunteer within the community in an environment that is supported and bespoke to their individual needs.

Sound

A regular weekly session is run in Keighley which provides one-to-one support and group work around different topic areas relevant to the needs of LGBTQ young people. Again regular referrals are received in addition to young people self-referring. These sessions take place in Keighley on a Monday evening. Young people are also offered the opportunity to participate in a number of experiences such as residential, organising activities during LGBTQ history month, and attending PRIDE events. Young people have also designed a poster in conjunction with ITV Fixers.

Eastern European and New Arrivals

A regular Saturday open session takes place on a weekly basis where approximately 20+ young people attend. Young people from this group are now beginning to engage with other young people and, particularly over the summer, we saw young people participating in the Park Events, Football Tournaments and Constituency-wide activities. Young people are increasing in confidence and self-esteem.

2.9 Active citizens and young people's contribution towards community life

a) District-wide Youth Offer

i) **People Can -** The district wide "People can" initiative has been warmly embraced by young people from across the youth sector with increased numbers taking part in community based activity. The development of a "Young People Can" arm to the initiative has empowered more young people to get involved. There are many examples from across the district evidenced on the People Can website at: <u>www.peoplecanbradforddistrict.org.uk</u>. This shows the range of active citizenship activity undertaken by young people including many examples of neighbourliness, volunteering, raising money for good causes and taking part in community action.

- ii) National Citizenship Service (NCS) has seen 1039 of Bradford's young people using their free time to take part in this national programme during 2016, with a further 800 already signed up for this year's Summer Programme. From the 2016 cohort 53 young people have taken up the opportunity to progress to the NCS Graduates programme, and these young people will be trained to take an active role in supporting the delivery of this coming summer's activities. The NCS programmes run during school holiday periods recruiting young people who are 15/16 years of age from across the district to come together in cohorts of between 12-15 young people to develop and take action in response to locally identified needs in an area. Bradford young people raised £10,014 for community partners in the Summer of 2016. Feedback from young people who have participated in these programmes has been extremely positive with 87% of participants reporting increased skills and confidence.
- iii) Formalised partnerships with education providers There are good examples of the impact of youth work practice within a more formal educational setting. In partnership with schools the Youth Service offers a range of programmes of citizenship, anger management, conflict resolution and one-to-one support that supports and enables more vulnerable young people to remain within formal education.
- iv) Informal Learning a broad offer of informal learning is offered by youth workers using a Youth Service Curriculum. This curriculum is underpinned by a commitment to make activity fun and engaging, whilst presenting challenge and opportunity for personal and social development for young people who participate. Young people are presented with choices and are encouraged and supported to make a positive contribution towards the communities in which they live and within the wider district.
- v) Children's Overview and Scrutiny Committee the Committee has been supportive and encouraging of youth voice within its meetings. A number of young people have attended Committee meetings over the last 12 months, and have had their voices heard, with regular attendance by a small number. Work is now being developed to ensure those in regular attendance are representative of a wider youth voice.

b) Youth Service – Keighley Area

Youth workers work within a framework to encourage active citizenship. Informal sessions giving young people the space to learn about self, develop self-confidence and self-respect through fun activities take place within open access sessions. Through a gentle process of engagement young people are able to explore their rights, responsibilities, community and their contribution both to the gommunity they live in and wider community. This journey leads young people into active participation into community life through volunteering at differing levels. Young people's contribution is recognised through accreditations. Since April 1st 2016 over hundred young people have seen their achievement's recognised through the Duke of Edinburgh Award, Lord Mayor's Award or the Local Award.

Youth Workers have delivered volunteer training to young people, these young people have gone on to become involved in youth sessions as befrienders, as young leaders and have supported the delivery of our holiday's activities programme across the constituency area. One has recently applied and was successful in getting a casual youth support worker post.

Over that last 12 months we have supported six individuals with schools or college placements. This has been an excellent experience for both the individual and for us as a Youth Service. They are all still involved or working with us after their placements has been completed.

2.10 The Voluntary, Community and Faith Sector in Bradford contributes a diverse and rich offer to the key elements of the Youth Offer. A number of examples of this are detailed in Appendix F.

3. OTHER CONSIDERATIONS

No other considerations.

4. FINANCIAL & RESOURCE APPRAISAL

- 4.1 As part of the Budget decisions taken by the Council for the financial year 2016-18 the Youth Service budget is on course to deliver savings of £750,000. The Youth Service budget will see a realignment of resources based on the Youth Population from April 2017. The local authority has committed £1.8m to the Youth Service for 2017-18.
- 4.2 This is set in the context of reduced financial resources for the whole of the Youth Sector and the delivery of youth work, including the voluntary, community and faith providers.
- 4.3 The Youth Service budget whilst devolved to the respective Area Committee also supports aspects of district wide provision.
- 4.4 There are increasing numbers of Voluntary and Community providers who are contributing towards the district's Youth Offer through delivery of services that are funded from external resources.

5. RISK MANAGEMENT AND GOVERNANCE ISSUES

The Youth Offer Working Group is chaired by the Commissioner (Youth Provisions)

and includes the Area Co-ordinator with lead responsibility for the Youth Service. Other members of the Working Group are representatives from Young Lives Bradford, Voluntary, Community and Faith Groups and the Police.

6. LEGAL APPRAISAL

6.1 The Council has a responsibility to co-ordinate and offer support for the Health and Well-being of Young People set down by Statutory Guidance issued in 2012.

The duty is to secure equality of access for all young people to the positive, preventative and early help they need to improve their well-being. This includes youth work and other services and activities that:

- Connect young people with communities so they contribute to society including through volunteering and ensure they have a voice in decisions affecting them.
- Offer young people opportunities in safe environments so they develop a sense of belonging, socialise safely with their peers, enjoy social mixing, experience time with older people and develop relationships with adults they trust
- Support the personal and social development of young people to build capabilities needed for learning, work ad the transition to adulthood
- Improve young people's physical and mental health and emotional well-being
- Help those at risk of dropping out of learning or not achieving their full potential to engage and attain in education or training; and
- Raise young people's aspirations, build resilience and informs their decisions particularly to address risky behaviours

7. OTHER IMPLICATIONS

7.1 EQUALITY & DIVERSITY

The Youth Service has a responsibility to ensure that the services are accessible to all young people and that participation in the service reflects this approach. Specific targeted work takes place to encourage participation from under represented groups.

7.2 SUSTAINABILITY IMPLICATIONS

The Youth Service delivery enables local initiatives to be supported, encouraging groups and individuals to undertake activities that improve the social, economic and environmental well being of their communities.

The Youth Work Developmental Grants have inbuilt sustainability plans, activated from the offset of the grant in an attempt to reduce dependency on Council funding and grants in future years.

7.3 GREENHOUSE GAS EMISSIONS IMPACTS

No greenhouse gas emissions apparent within the context of this report.

7.4 COMMUNITY SAFETY IMPLICATIONS

There are a number of youth work projects who are concerned and driven to improve Community Safety within local communities. The increased opportunities and involvement of young people in local decision making has the potential to improve Community Safety. The Youth Sector provides positive experiences for young people helps to build self-confidence, raise aspiration and can provide and encourage 'diversionary activities', these are key contributors in builds and helps to support safer and stronger communities.

The Commissioner (Youth Provisions) works with the district wide Anti-Social Behaviour Panel, the Youth Service and key providers across the Youth Sector to ensure young people are informed of the consequences of their participation in Anti –Social Behaviours. This ensures early interventions, joined up responses and positive requirements are offered to reduce criminalisation of young people and support community safety

7.5 HUMAN RIGHTS ACT

There are no direct Human Rights implications arising from the recommendations below.

7.6 TRADE UNION

There are no implications for Trade Unions arising from this report.

7.7 WARD IMPLICATIONS

District-wide Youth Service work and activities support young people and communities within all the Wards in the Bradford District.

Examples of VCS contributions to the Youth Offer: some examples

There are a wide range of different voluntary, community and faith providers that provide activities and support for young people in the district. These include

- Page Activity to support particular interests (arts, drama, junior sports clubs)
- Alternative education providers
- Play and adventurous activities (e.g. Big Swing / Eccleshill Adventure playground, Forest Schools network,
- <u>\$</u> Specialist support (e.g. mental health, counselling)
- Uniformed organisations (scouts, Guides, Cadets, Boys/Girls Brigade) and similar (Woodcraft Folk)
- Faith based provision hosted by churches, mosques, gurdwaras, temples, or faith inspired organisations

Some organisations operate on a very local basis and others on a district wide basis. Young Lives supports them with information and guidance and signposts them, to sources of support.

There an estimated 200+ organisations that contribute to the youth offer in some way. Here are just a few examples of their activities – the majority of the activities listed below are predominantly or fully funded from sources other than the Council, although in some cases a small amount of Council funding has enabled the leveraging of much greater external funding). This paper gives a few examples (predominantly of district wide provision) and how they contribute to the youth offer.

1. Information and Advice

• 16-2-25 advice service runs 5 session per week, 3 at culture fusion and 2 from Shipley youth café. They mainly advise around homelessness, housing, welfare benefits and debt and see on average between 25 and 30 young people a week on a drop in basis. They refer and signpost to all relevant organisations in the area, as well as working closely with, leaving care service, youth service, Bradford college amongst other young peoples services. This is supported through lottery and trust funding.

BYDP: IAG does not have to be a separate service. BYDP describes how it embeds IAG within its wider offer. "we do not provide IAG as a service. However, staff provide IAG support frequently in conversation with young people engaging on programmes. Typically this involves support for 'making appropriate choices' which may include behaviour with younger people and support for courses and work with older people."

2. Voice and Influence

- Young Lives Bradford survey of organisations in 2016 indicated:
 - 81% of organisations involve young people in the governance of their organisation
 - 96% of organisations involve young people in Planning the activities and priorities of their organisation
 - 68% involve young people in the recruitment of staff
 - 88 % involve you8ng people in the running of activities (e.g. as volunteers)
 - 2017 data is currently being collected.

Barnardos undertake a significant amount of work supporting young people to have their voice heard, especially on mental health issues

- Page•82 **Centrepoint** runs a youth council, to gather views of young people and influence change
- Emerge run youth councils operating in both BD4 and BD3, 8 10 YP involved in each, engaging with influencing their provision and local issues
- Brathay: currently deliver a project "Have your voice" to young offenders which works with small numbers of young offenders who are in the system and who have been in the system to establish a core group of young people to take part in consultation of their experience of being involved with the Youth Offending Team, identify what it was like having received a service from the YOT, which has increased confidence and self-esteem and helped the young people feel empowered that their voice is valued.
- BYDP: hosted the spotlight events held in Bradford to engage young people with decision makers. BYDP carries out research activities to understand the concerns of young people.-BYDP, in partnership with BMDC, is leading a Government (Communities Fund) project working with four long standing voluntary sector organisations in BD3, 5 and 8. The project will identify and meet unmet needs of 8-25 year olds in these communities. Partners will build their capacity and skills to attract more funding to the city.
- 3. Open Access

- Uniformed groups: Uniformed groups provide a range of open access activities. Foer example Bradford Sea Cadets offer "Youth development and lifelong learning. Through leadership, teamwork, friendship and self-belief the Sea Cadets help young people find their sense of direction: we broaden horizons and create possibilities with the aim of helping young people see the world through new eyes and with new confidence." 66% of cadets said that attending Sea Cadets improved their attendance and engagement in school; 93% said it helped them gain gualifications; 94% said it provided them with the skills they need in later life; 88% said it will help them get a job. Their work is funded by subscriptions and local donations and volunteer activity.
- **Emerge** runs a total of 28 open access sessions of youth work each week across the following areas (Brierley 7 sessions per week; West Bowling -2; East Bowling -6; Windhill -4; Undercliffe -4; Laisterdyke -3; Holme Wood -2). These sessions have a range of content from detached work, tradition drop in youth sessions, sports sessions, music sessions, arts and crafts and cohesion initiatives. Most groups are for 11+ young people, but a couple are children's sessions. They are all run in partnership with a local group providing a venue (e.g. Bierley Community Centre, Community Works in Undercliffe), and funding comes from a range of local sources and large and small national funders.
- JAMES: Have been awarded doorstep sports funding from street games. This funds open access football sessions 3 evenings per week and pays for the hire of centres for 2 of those sessions. They also have a partnership with Bradford park avenue funded through the football association. JAMES has been delivering homeless football and work in schools as well as tournaments and drop ins at bradford park avenue grounds. Page

Forest Schools: There is a range of Forest School provision including from Get out more CIC to provide adventurous and educational activities outside.

4. Targeted Provision

- Brathay offer Saturday provision to young offenders who are on ISS orders, cook & eat, music, targeted interventions, and sports activities. • They also offer CSE Awareness - funded through the PCC and Brathay Bursaries to deliver sessions around cyber bullying, social media, keeping yourself safe, its ok to talk, these sessions have been delivered to primary/secondary schools. They also offer tenancy ready programme - funded through Trust funds brought in through fundraising to deliver skills around independent living skills to 15-18 years to develop their skills of living on their own,
- BYDP has a specialism in social, emotional and behavioural support through its youth work and has been successful in gaining funding for activities that target those most in need. BYDP has a strong local community presence which significantly enhances its impact and engagement with harder-to-reach families. Our Youth Ambitions project based in Manningham (BMDC funding) is developing older pupil's to take leadership responsibility. BYDP is funding 18 Year 12 students at Oasis Lister Park to complete the Level 2 Youth Work Practice accreditation. This investment seeks to ensure a growing base of skilled volunteers and potential workers in the city. BYDP has just started the 3 year Youth Start programme (funded by BBC Children In Need). Activities around the city will focus on young people aged 8-18 and provide opportunities to experience and develop new skills, work together and increase inclusion, build resilience, self confidence and capacity to be effective citizens.

- **Emerge:** Runs a range of targeted groups in each of the above areas including some girls only small groups and healthy lifestyle groups, along with a couple of faith based groups in partnership with local churches. They also run regular Sports Leader awards for young people and partners with schools to deliver interventions with individuals and groups as required.
- **Snoop:** Provides day time and evening services and activities, including holiday schemes, with a focus on life/independence and social skills for young adults with learning disabilities. They support young adults through the transition from special school into adulthood and support them to identify their own person goals and targets to help them gain the confidence they need to become more independent, make choices and take more control of their own lives in a person centred approach. In addition they are a registered provider of ASDAN accredited awards for 'Towards Independence' and their young adults manage the Bradford Safe Place Scheme, known as the 'Help I'm Lost Card Scheme'.
- Dance United Yorkshire: Provides Specialist high-quality arts intervention working with some of the most vulnerable and disengaged children and young people across Bradford and Yorkshire. Bespoke intensive and short term projects are delivered to predominantly 12 21yr olds referred from a range of services across the city in order to provoke sustainable and life-long change. DUY offers a unique arts experience which has a track record of transforming the lives of young people who are living on the margins of society.

Springfield Community Centre has secured £8500.00 from big lottery to provide free meals and deliver healthy eating and nutrition workshops/sessions to young people in BD10/2 throughout the summer holidays addressing again the poverty experience by the most disadvantaged young people.

5. Active citizens and young people's contribution to community life

- Brathay Trust deliver through Princes Trust programme, Team and Community challenges where young people go out and work with communities i.e. producing films around Refugees and their struggle and what its like to be a refugee, painted houses and tidying up gardens, producing packs to be given out on mental health awareness and where young people can be sign posted to, delivered a programme to people suffering from dementia, delivering fun activities and story time, and clean up campaigns. Young people also fundraise in order to carry out the community activities. This is part of their Princes Trust experience.
- Emerge: Run a regular young leaders course in 2 or 3 venues (E and W Bowling, Laisterdyke) enabling young people to become volunteers and tackle local community projects
- NCS: Young people on the National Citizens Service raised £1,100 in a variety of activities to fund other youth work in the District and are therefore investing back into provision in the district.
- Bradford Volunteer Centre has been active in promoting information about volunteering and the People Can Make A Difference campaign to young people and have reached over 1000 young people 15-18 in the District giving volunteering workshops in the following schools ; Dixons

City Academy, St Bedes, Beckfoot Upperheaton, Bradford Girls Grammar. At Bradford Girls Grammar School the 67 pupils volunteered 2600 hours.

Funding

The Bradford District Community Fund is generating money for community projects and distributed grants from a bank to Emerge to fund ongoing youth work see this amazing video. <u>https://www.facebook.com/bradforddcf/videos/1314346835274828/</u>

The Community Fund also gave grants to sports clubs affected by the floods that provide youth sports and the monies were raised in a public appeal. The Bradford District Community Fund is currently accepting applications for the Pears Youth Fund to fund ongoing youth work and is in the process of distribution youth grants for Bradford Council.

Demonstrating impact

Emerge: are able to evidence that they work with over 500 young people weekly, and in the last 12 months 1700 individuals were involved. Key outcomes are personal growth (confidence, self-esteem, social skills improved), increased attendance and achievement at school (evidenced by schools), reduced involvement in ASB, increase health and wellbeing and safer communities.

BYDP is undertaking the Ambitions+ Quality Mark for infrastructure organisations. At present, it is the only Bradford group aiming for this standard. **BYDP** is trained to carry out social return on investment (SROI) evaluations and Cost Benefit Analysis. At present, it is the only Bradford based organisation carrying out SROI.



The Children's Trust

The Trust holds responsibility for the Children, Young People and Families' Plan. The plan has the priorities for our work with children, young people and families in the District. One of these priorities is about how our services hear the voice of children and young people. They will receive reports from organisations and young people and ensure that all the agencies working with the Children's Trust are activity listening and responding to what young people are saying.

Uhey will involve young people when the plan is reviewed each year.

a Ge doung People's Challenge Panel(s)

This is a local opportunity for young people to come together to share concerns and comments, or to speak directly to adults who make key decisions in relation to services for young people. This may be decision makers and budget holders within the Council, health or education. It may be those who buy services or those who deliver services for young people.

Young People's Forums / Networks / Youth Voice Events

These are forums held locally or for the District on subjects that are identified by young people and the district as priorities. These enable young people to come together to discuss things that are important to them and to identify actions they can take themselves or, where they can, work with others to make things better. They are also used to talk about things that may need to be taken to a challenge panel for further discussion with key decision makers.

Bradford Youth Work – Youth Voice Standards

These are the underpinning standards which are being developed that will help organisations make a judgement on how good they are at listening and responding to young people's voices. These standards will be used by organisations so they are better at supporting young people who use their services. They will mean young people have access to a wider range of opportunities to have their voices heard.

Social Media Engagement

This is a growing opportunity to talk to a wider group of young people in the district to seek their views on particular issues or developments. This is intended to be used for one-off consultations so we can better understand what's important for young people. Social media will also be used to promote the opportunities to attend Youth Forums, be part of a Network or District Youth Voice Events.



1.1 This report gives an update of work undertaken by the Keighley Neighbourhood Policing Team to address the "Safer Communities" priorities within the Keighley Area Ward Plans for 2016/17.

2.1 Appendix A gives an overview of the Keighley Area crime figures between April 2016 and July 2017 and gives a comparison with the same period in the previous year.

3. OTHER CONSIDERATIONS

- 3.1 There are now named Police and Council Ward Officers aligned to Wards across the Area who are supported by designated staff with allocation to specific areas. The boundaries are co-terminous and therefore enable effective co-ordination, tasking and problem solving.
- 3.2 Keighley Area Neighbourhood Policing Team works closely with Bradford Council's Neighbourhoods Team across the Keighley Constituency. A number of joint community initiatives have taken place including piloting new street surgeries, attendance at parents' consultation events, fun days and also attendance at other public engagement opportunities. Days of Action have been undertaken including information-giving, door knocking by staff from the teams, traffic operations, fines, warrants, and environmental activities.
- 3.4 Neighbourhood officers from the Council and Police have participated in joint patrols and enforcement activities managing school gate parking issues to reduce traffic congestion, illegal/inappropriate parking and risks to pedestrians as well as other road users. Traffic operations are planned throughout the year. The Council's CCTV car is also deployed to support enforcement activities. Where possible, engagement work including school assembly presentations, attendance at school events to meet parents, children taking part in speed watch and other road safety educational activities also take place.








ASBAT (calls for service)

The below chart shows the total number of calls for service for nuisance related issues for the previous 12 months:




ASB INTERVENTIONS

HATE CRIME

The below shows the trend of hate crimes / incidents reported over the previous 12 months across Keighley. The data has been extracted from Niche and includes Hate Crimes, Race Hate Incidents, Faith Hate Incidents, Disability Hate Incidents, Sexual Orientation Hate Incidents and Transgender Hate Incidents.



I was appointed as the Police Inspector for Keighley Neighbourhood Policing Team on 5th of September 2016.

Keighley has had to face a number of challenges over the last couple of years and it was key for me to understand those issues and to ensure an effective plan was put in place to address them.

I started off with a series of consultations with a variety of people and groups which included the MP at the time Kris Hopkins, Ward, Town and Parish councillors, local groups, individuals and Partners.

Across the board one of the key issues that was repeatedly highlighted was scourge of drug dealing which was not only effecting a wide range of our communities but also impacting on daily crime and our business community.

Working in partnership with Kris Hopkins, Paine Stoppers and Bradford Council and with

the excellent support from Bradford District Police Senior Leadership Team,Op Saucerlake was instigated. This was a large scale Police Operation targeting drug dealing in Keighley linked to organised crime groups. This resulted in 35 suspects arrested for Supplying Class A Drugs in Keighley with all most all of them pleading guilty and sentenced to custodial sentences.

Our Operations are continues and we have seen a surge in reporting drug related information to Crime Stoppers and Police which shows the public's confidence and trust in the police which has assisted us in targeting and arresting drug dealers further.

We have seen an increase in reported crime over the last 12 months and one of the main contributing factors is that HM Chief Inspector of Constabulary sent an instruction to all Chief Constables to reiterate the need to record absolute every crime that comes to Police notice. This means that at one incident there can be multiple crimes recorded which has seen our crime increase in line with crime data integrity. This is absolutely right that we do this as we need an accurate reflection of what is happening in our area.

However it is important that we continuously target criminality in order to reduce crime and ensure our public are safe in line with the PCC and Chief Constables priorities. For this we have set up a number of operations across Keighley to arrest and disrupt nominals involved in SAC crime which includes burglary residential, vehicle crime, robberies. In August the operation resulted in over 20 arrests for a variety of offences.

Also Gangbos which are injunctions against individuals linked to Organised Crime Groups have been served on 11 individuals in Keighley.

Further to above proactive operations have been set up to safeguard our children and vulnerable people against perpetrators working with partners.

Bad driving has been highlighted as an issue on a number of occasions and I am grateful to Keighley Town Council for their support in providing match funding to increase Op Steerside into Keighley to tackle the problem and to ensure our roads are safe.

Anti-Social Behaviour Operations have been set up and actioned in Keighley Town Centre, Church Green, Oakworth and Ilkley. Suspects have been arrested, warning notices served, alcohol and drugs seized from individuals engaged in ASB and a 16 year old ring leader has been remanded in custody.

To increase visibility and reassure our communities our Pcso's are regularly visible outside their local primary schools at opening and closing times. Attending their local churches on Sundays and mosques on Fridays to engage with their communities in addition to patrolling their wards and providing crime prevention advice to victims.

Also we have set up School Watch Scheme in Keighley, working in partnership with the junior schools, working both with the children and staff and building key relationships with our ward officers and Pcso's.

In addition to above engagement we have had a very busy summer where we have attended majority of the events in Keighley ranging from local galas to Keighley Show. Also and quite crucially we have set up street surgeries in every ward, getting out to our communities with our partners and listening first-hand their concerns.

Page 100 Moving forward, we have our ward officer team set up now and looking at increasing the staffing as our numbers increase, each aligned to their ward along with their Pcso's. They are not only looking at early intervention work but proactively tackling the concerns that are raised by our communities.

Above has only been possible through the excellent support we have received from yourselves, our partners and our communities and we are hoping we can continue this going further.

- 2.7 The role of Council Wardens includes supporting community engagement and their work has involved them in Days of Action, Street Surgeries; work with schools and individual local residents. This is in addition to their responsibilities for Parking and Environmental Enforcement.
- 2.8 Keighley Area Co-ordinator's Office also provide support to new and continuing community initiatives as well as advice, guidance or support in relation to assisting the effective functioning of local Voluntary and Community Organisations as requested.

The Grand De - party event supported by Keighley Co-ordinators Office took place in Silsden Park on Saturday 1 July and was a great success with 500+ people attending. Activities on offer provided entertainment for all the family along with a range of information stalls. The newly established community library had a stall run by local volunteers who support the new library on a weekly basis. The event was supported by many local groups and helpers and has become an annual attraction for the area of Silsden.

3. Scouts and Beavers Litter Picking in Addingham



The Scouts and the Beavers; volunteer helpers and parents came together to take part in a Litter Picking Project in Addingham taking in the Memorial Hall, Addingham Village, Marchup Ghyll, Steeping Stones, Allotments, Recreation Ground, Danny Palmer Nature Reserve, Hoffman's Wood, Cricket Ground, Fields, Bowling Green and MUGGA area. Included on the day was 'Hunt The Bin' Campaign – to find all the litter bins in the village; mark them on a map and take photos. The goal for everyone was to put together a display

about litter and the importance of recycling waste linked to the Environment Day that took place in May.

4. Friends of Silsden Town Hall



Friends of Silsden Town Hall in 2017 have been instrumental in supporting the Community Library Initiative as well as providing a full programme of community activities enjoyed by people of all ages. One of their community ventures was a celebration garden day and plant produce sale including a Gardeners Question Time attended by Katie Rushworth; ITV's 'Love Your Garden'. The event was organised by members of the local Bolton Road Allotments, Silsden. The group continues to work in partnership with Keighley Co-ordinators Office and other local groups and organisations to organise a range of community programmes and activities for all ages.

5. Silsden Stroke Support Group



The stroke support group run by lead volunteer Grace Summersgill takes place at Silsden Methodist Church and is attended by people who may have experienced a stroke and their carers'. The group offers information, advice, and organises a range of activities that focus on encouraging movement and speech and trips out are organised by arrangement. The group is supported by Silsden Methodist Church; Creative Support and Later Life Cobbydale mutual support network; with a focus on helping people in later life

in Silsden; health issues and social well-being. Membership of the group has increased recently with people attending from Skipton and Ilkley.

6. Youth Service – Craven Ward



11 open access sessions are available to young people; detached team on Friday evenings; school holiday period has been a success as calls for service were down - young people's behaviour. A partnership between the Methodist Church in Silsden; Youth service has created a Drop-In session 1st Friday of every month; hoping to increase to twice monthly subject to funding after Xmas. Young people had the opportunity to take part in various activities; Summer Program; Buddies Program 'WRAP' – Wellness Recovery Action Plan Course; Voice and Influence events (Youth Voice and Young Advisors). Sessions on Monday evening's will be used for targeted work - topics or projects; Thursday's to remain open access. South

Craven School is promoting the work in the community; Addingham open access sessions have restarted on Tuesdays; Ilkley Grammar School is allowing workers to promote the sessions available

Appendix B Ilkley Ward - Ward Plan Actions Summary April – September 2017

1. Great Get Together

The Great Get Together (Sunday 18th June) certainly lived up to its name in Ilkley with residents of all ages taking advantage of a lovely Summer Day for a community celebration on The Grove. Hundreds of people turned up sharing food and enjoying the company others. Volunteer organisers stretched the £200 grant award from BMDC to ensure the day was fun filled and fabulous, organising everything from sewing 100's yards of bunting to arranging a quiz, tug of war and entertainment.

Lots of people worked tirelessly to make sure the event was a success and the added bonus was that unexpected donations on the day resulted in £1,500 for Ilkley and District Good Neighbours and £500 for the Grenfell Tower families.

2. Summer Fun


Ilkley Youth and Community Association working in partnership with the Area Office, Youth Service, and Police with support from the Community Alcohol Partnership, Rotary and Ilkley Parish Council provided a variety of activity for young people in

Ilkley summer 2017. This included weekly outdoor sessions in the park and taster sessions at Clip n Climb, the Tennis Club, Korkoro Martial Arts and dance, in all 20 separate activities were provided for young people to attend, throughout July and August. As a finale a successful grant award to host a Great Together event the association hosted a community barbeque at Ilkley Warehouse

3. Clean, Green, Safe and Tidy









A number of initiatives to address litter and environmental problems in Ilkley have taken place. 'Spring into Action' resulted in a number

of individuals coming forward to litter pick and have on loan litter pickers, gloves and high visibility vests. A closer working relationship is being formed with the Parish Council employed warden to try and coordinate effort and achieve maximum impact. In keeping the town clean and cared for. In conjunction with the Parish Council a litter campaign is currently in production to encourage people to dispose of their litter responsibly and keep the Town and its open spaces tidy.

4. Tackling nuisance and ASB

Ilkley is a safe place with low levels of serious crime but occasionally anti-social behaviour can create problems.

Working in conjunction with the Police and InCommunities and Fire Service a joint door to door exercise took place earlier in summer in response to reports of ASB in the Valley Drive area. A bespoke leaflet was produced informing residents of the types of anti-social behaviour and how to report it (on-line and phone numbers).

It also provided an opportunity to promote Online Watch List (OWL), Green Dog Walker scheme and 'People Can', in total over 200 homes were visited.

Further initiatives including Street Surgeries are planned for the autumn.

5. Yorkshire Day

Ilkley's Town Crier and chairman of the Parish Council joined the local MP, District Councillors, Parish Councillors and a host of Ilkley residents and representatives from voluntary groups in the annual celebration of Yorkshire day 1st August 2017.

An opportunity to celebrate the county and the town, it was a real feel good initiative with music and entertainment provided by the Phoenix jazz band. At the request of the Parish Council it was also a chance



to celebrate and recognise the wealth of activity undertaken by local volunteers, many of whom joined the crowd that meandered along the Grove before gathering at the Town Hall for a rousing rendition of 'Ilkley Moor Baht'at before retiring indoors for tea, Yorkshire Tea of course!

6. Youth Service



8 young people from Ilkley Youth Club have been actively involved in participating in Fund Raising activities in and around Ilkley in order to raise funds for an activity of their choice. This has included, visiting local business and asked for donations, making cakes, organising a raffle and manning a stall at Ilkley festival encouraging the public to make their own smoothly drinks. Car washing – visiting businesses and residents in the vicinity a number of cars were washed in the Warehouse car park. Local residents were able to see young

people doing something good in their community dispelling any negative perceptions of them. Summer activity culminated in a 'Great Together' BBQ, prior to which a large group of young people (and a dog), walked the 7 miles from Bolton Abbey to Ilkley, raising over £100.00. In conclusion, Young people appreciated the significance of fundraising and gained a valuable insight in to planning and delivering fundraising events.

Appendix C

Keighley Central Ward - Ward Plan Actions Summary April - September 2017

1. Eastwood School working in partnership



A Successful Community Forum took place at Eastwood Primary School, on 11 July. Residents had a direct opportunity to speak with Council Officers from Keighley Co-ordinators Office, Cleansing and Enforcement Section, Youth Services, and BHCA – Bradford Hate Crime Alliance. Other partner organisations who supported the meeting were the Police and Eastwood School Staff and members of local group Youth Vision. Residents were able to raise local issues with some attendees offering to also become involved in local volunteering initiatives. Eastwood School works in partnership with Keighley Co-ordinators and are in the process of looking at a parking

proposal to address road safety in and around the school.

2. All Saints Church in partnership with Highfield Food Co-op



All Saints Church, Highfield Food Co-op organised a series of film nights showing various productions. The film nights were well received with a request for more films for children. On the films shown the topics covered were asylum; local politics and communities coming together. At the end of each production a discussion workshop took place. The message from the full programme was people regardless of background had more in common than they realised. Volunteers connected to the Highfield Food Co-op are progressing a 'grow your own initiative' for the Highfield area.

3. The Great Get Together – Fun Day Friends of Burgess Field



The above event was organised by volunteers with support from Keighley Co-ordinators Office. On the day there was a range of activities including a sack race; egg and spoon race and tug-ofwar. Youth Service supported the activity programme by organising the race competitions and over 150 people attended along with the Mayor of Keighley town Council and John Grogan MP. This is now an annual event in the local community.



4. Clean Sweep Day of Action Page 112 Keighley Co-ordinators Office; Highways; Cleansing Services organised a 'Street Sweep' Day of Action with local residents playing their part by parking their vehicles in another locality on the day so sweeper vehicles could have direct access. The area covered included Devonshire Street West; Drewery Road, Lime Street, Cartmel and Back Cartmel Road, Ada and Back Ada Street and Endersor Road. Other days of action / clean-ups have been organised across the ward with the next one taking place at Knowle Park.

5. Crime Stoppers Campaign



Keighley Co-ordinators Office, Police, Elected Members and MP's Office with volunteers promoted the Crime Stoppers Campaign across Central Ward in 2017 over a 3 month period. Residents were contacted directly; the campaign proved positive in that more people came forward to report incidents of crime occurring in their local community. The message -Residents can report crime anonymously by ringing 0800555111 or go on line. Information provided by residents

was important as working together we can make our communities safe.

6. Youth Service – Supporting Young Women and Girls



Over the past 6 months the youth Service has increased provision for young women and girls in Keighley Central Ward. Youth Service has set up town centre provision – Girls Drop-in where they can access support and advice from Youth Workers. They can hang out; engage in activities or receive advice and information from staff. This session is followed by Detached Youth

Work in Keighley Town Centre localities targeting vulnerable and at risk young women. This project is a partnership between Youth Service and Keighley Healthy Living. We have also recruited two new casual staff and are in the process of setting up Saturday provision at BCA - young women from the Lund park area. This project will be launched on the 14th October, and is being supported by BCA – Bangladeshi Community Association. A member of staff will also be supporting a girls group in Highfield in partnership with Highfield community centre. We are committed to providing a quality service to all of our young people, where possible working in partnership with other organisations and community groups.

Appendix D

Keighley East Ward - Ward Plan Actions Summary April – September 2017

1. Tour de Yorkshire and Easter Fun

'Eggstra' activities for young people took place over the Easter holiday period thanks to Big Local. Grant awards supported 'Out in the Aire' Forest Schools who organised an Egg Hunt, and Forest Schools fun & games in Stockbridge & Damems. A BMDC Animation Grant of £200 also provided the opportunity for young people to literally put the 'flags out' as the Tour de Yorkshire passed through the ward in April 2017. A colourful, creative art & craft session - using natural dyes gave young people the opportunity to create bunting and banners for the route of the cycle race. Both example ways to 'increase the opportunity to play for all people aged 1 - 101 years in the Keighley Big Local area



Following the damage and distress of the floods in December 2015 effort has been put into mitigating problems in the future including enlisting the help of local



people in making environmental improvements to the riverbank. A series of action days have taken place with volunteer helpers

tackling issues of lingering flood debris and clearing litter and vegetation. BMDC cleansing team followed up removing bagged waste (see below) and Area Office staff manned a Flood Roadshow with Environment Agency staff and others at Keighley Library (May 2017) to talk about flood plans and how

we can work together to tackle problems across the district in the

3. A Clean Sweep

74 Gullies – cleaned, 13 bags of litter – collected 2 burnt out wheelie bins - removed, 9 roads - swept

53 residents engaged - All in a morning's work in the Stockbridge area of Keighley thanks to the combined efforts of the gully wagon team, clean team, warden and mechanical sweeper. A heavily parked area it took collective effort to ensure that vehicles were off the streets and the teams had access to the drains and kerbside. We hope to repeat the exercise in the other 'half' of Stockbridge later in the year, it is of huge reassurance to residents who have suffered flooding incidents in the past and an opportunity to engage and encourage responsibility on keeping the area and drains clean and clear.

4. 'Street Talking' – Street Surgeries

Page 114







The latest combined effort between the Police and Area Office and District Councillors to meet with local residents, listen to concerns and address issues in a series of 'Street Surgeries' took place across the ward through an unseasonably wet (and cold) summer. Well received by residents a number of productive doorstep conversations took place. Over 500



houses were visited and information about Crime stoppers and Council Services delivered to each. Initial concerns about why the police were in the area gave way to appreciation and residents were supportive of similar activity in the future. A further series of Street Surgeries are planned for the latter part of the year.

5. Perseverance 'Plays' off

For a number of years residents have complained and

campaigned with regard to the lack of play provision in the Hainworth Wood Area and this year thanks to Big Local their vision is about to become a reality. Despite setbacks along the way with changes to other funding programmes the scheme was agreed as a priority and the £80,000 cost has been met in its entirety through Big Local. Working closely with BMDC Design team contracts have now been awarded and work on the scheme is about to start.

It has required real determination to see this project through but local residents have persevered and with all agreements in place it should prove a well-used and popular amenity, in operation before the end of the year.

6. Youth Service

Workers have engaged with young people across the Big Local area to explore interests and the types of activities they would like to see delivered. Detached workers have developed good relationships with groups of young people from Hainworth Wood, Stockbridge and Parkwood. Weekly activities are delivered in these areas and young people have benefited from one to one support around a range of issues including CSE awareness, school and college issues and emotional wellbeing.

Young people are now starting to take an active role in programme planning. The open access youth club is well attended, with some of the group working towards the 'Lord Mayors Award'. As part of a cultural awareness activity they took part in an 'opening of fast' to celebrate Ramadan .They also hosted a meal as part of the 'Great Get Together' with attendance from across the Keighley constituency.


Keighley West Ward – Ward Plan Actions Summary April – September 2017

Worth Valley ward update, October 2017 Cleaning up a quiet corner of Haworth

Residents have taken part in two clean ups on land around Ebor Lane and Bridgehouse Beck, improving a nature area and a slope down to the beck which was covered in years of litter. The first clean up took place around a path off Ebor Lane to the nature area which forms part of the Railway Children's walk. The second clean up was carried out with support from Haworth Masons from the Mill Hey side of the beck, where litter has been thrown over a wall over years.The



clean ups were arranged after residents expressed concerns about the neglected state of the banks of Bridgehouse Beck, and both clean ups attracted around 20 volunteers each time.



Churchyard clean up reveals hidden gravestones

Volunteers taking part in a second clean up in Haworth Churchyard dug out .gravestones which may not have been seen for decades, hidden under years of leaf mould. In June, volunteers worked on graves cleared at the first event in March, scraped leaves off more gravestones, and carefully dug down to find graves which local historians knew were there

but were not visible. Volunteers met again in August to discuss regular work which could be done in between major clean ups in the churchyard, with some regular volunteers and the Bronte Society agreeing to take on specific sections of graves. Now the plan is to encourage more people to devote a little time on a regular basis to the churchyard and make sure it looks as valued and cared for as it is by so many.

Booklet helps older people to Get Connected !

A new directory listing scores of groups and activities for older people around the BD22 area of Keighley has been published. The booklet, Get Connected, is aimed especially at older people who may not use the internet but who want to find out about activities in their area. It has been put together by a group of organisations serving older people (right) including Dementia Friendly Keighley, local Catholic and Methodist Church representatives, Keighley Elderly Initiative Group, Hanover Housing, and co-ordinated by the



ward officer with support and funding from Bradford Older People's Alliance. The idea was first floated by ward councillors who were concerned about older people living in more isolated areas, and who may not have access to the internet. It will be offered through agencies working with older people such as health centres and housing providers and will also be on the council website.

Improving Haworth for residents and tourists

Users of Haworth's biggest car park off Weavers Hill should see an improvement in maintenance after Parking Services agreed to equilar strimming and significant tree work,

following cutting back by Community Payback. New crime prevention signs are also due to be installed to replace existing worn signs, and a coach driver survey is being devised to sound out views on current provision of coach parking and a range of other issues. The survey is intended to complement other work being done through Bronte Country Partnership and Haworth, Cross Roads and Stanbury Parish Council on facilities for both visitors and residents, and sustaining Haworth as a destination in the future.



Seeing the difference of a year's clean up work

Volunteers at a clean up in Oakworth have noticed less rubbish round the village since they got together for the first time in Summer 2016. Operation Oakworth, an occasional event where residents tackle litter on routes in and out of the village, was first held after concerns were raised about litter and dog bags spoiling the area. On the fourth clean up, held a year later on Saturday July 8, ten volunteers felt the village was looking cleaner, evidenced by a much smaller pile of bags after the event, with more volunteers doing their bit in between clean ups too. However the

group were keen to get together again for a November clean up when they expect more litter to be revealed as vegetation dies back.

Browside action day and youth shelter makeover

Haworth Browside has been the focus of environmental work over summer, starting with a resident survey about issues in the area. Dog waste and the need for a greater police presence were the top concerns, but people also praised the friendliness of the area and good transport connections. An action day and street surgery in June saw the council gully wagon, mechanical sweepers and volunteer litterpickers cover as many streets as possible in the area, along with police, warden and ward councillors



speaking to local residents about any concerns. In August the youth shelter off Apsley St received a face lift, with Parks and Landscapes staff cutting back shrubs surrounding it and a team of young National Citizens Service volunteers repainting the shelter and giving the area around a thorough clean.

1. SUMMARY

1.1 This report provides information about community engagement activities undertaken by Keighley Area Co-ordinator's Office during April - September 2017.

2. BACKGROUND

- 2.1 One of the functions of Keighley Area Co-ordinator's Office is to work with elected Members to organise and develop varied ways of engaging with the public that are appropriate to the Wards they represent, e.g. Neighbourhood Forums, Special Forums on a specific topic of current local interest, events and activities targeted at specific people groups (e.g. older people or parents with young children), stalls at events organised by local community groups (e.g. Galas and Fun Days) and digital engagement (e.g. Facebook, Twitter and local websites).
- 2.3 Appendix A gives details of the community engagement activities that have been undertaken by Keighley Area Co-ordinator's Office (KACO) during the period April September 2017. These have included 'traditional' Neighbourhood Forums, public meetings organised by KACO staff open to all but run on a different format to a Neighbourhood Forums, meetings targeted at particular 'people groups' (e.g. young people), attendance at meetings and other events organised by partner agencies or community groups, door-knocking and 'street consultations'.
- 2.4 This variety of approaches has proved much more effective at reaching a wider and more diverse range of the general public than normally attend Neighbourhood Forums.
- 2.5 The Area Co-ordinator's Office will continue to identify ways of making Neighbourhood Forums, and other forms of consultation and community engagement, relevant to the interests and character of each particular neighbourhood and works with elected Members on ways of increasing public attendance and engagement.
- 2.6 Ward Officers continue to have the flexibility to arrange public meetings in response to local issues that arise outside of the planned schedule of engagement activities, where a majority of Members representing the relevant Ward consider that a public meeting is required.
- 2.7 The importance of the use of the internet and Social Media (e.g. Facebook and Twitter) as a means of communication and consultation is recognised by KACO, and staff now regularly use digital media as a means of engagement alongside meetings, events and activities. To date the Keighley Area Co-ordinator's Office has 693 followers on Twitter and 259 members of its Facebook group.
