1. **BRADFORD SOUTH YOUTH SUMMIT OCTOBER 2018**

**Resolved –**

- (1) That the report recommendations from the Young Ambassadors set out in Document “AA” be welcomed and that this Committee works with the Youth Service to have a dialogue that empowers young people to act.**
- (2) That in light of the recommendations from the Young Ambassadors the following actions be taken with the involvement of key partners to try and make a change:**
  - (i) That the Interim Strategic Director Children’s Services in consultation with the Children and Families Portfolio Holder approaches the University to better promote and encourage applications from young people in the Bradford district, particular from areas of the district where university applications are low and follow the good example of the Aiming High programme.**
  - (ii) That the Interim Strategic Director Children’s Services in consultation with the Children and Families Portfolio Holder work with schools with a view to ensuring work experience placements for pupils are more readily offered throughout their secondary education, are more meaningful, increases opportunities for the student through them and enables them to have a better understanding of the world of work.**
  - (iii) That the Bradford Opportunity Area Board work with the Chamber of Commerce to engage employers in offering work experience opportunities.**
  - (iv) That the Children and Families Portfolio Holder approaches the Bradford Opportunity Area Board with a view to funding the Welfare Advice Services on offering budgeting skills to young people in secondary schools in the district.**
  - (v) That the Children and Families Portfolio Holder works with the Bradford Opportunity Area Board to work with schools to improve mental health support within schools, including better signposting of the help they can access, and recognising the good practice examples of Mental Health School Champions and Youth In Mind.**
  - (vi) That the Chair of the Bradford South Area Committee approaches the West Yorkshire Transport Authority/ Leeds City Region around the cost of public transport restricting young people from seeking opportunities.**

- (vii) **The Chair of Bradford South Area Committee to write to Central Government to express concern of the impact of the high level of tuition fees and the disproportionate impact on young people from communities where there are low levels attending university.**
- (viii) **That the Chair of Bradford South Area Committee writes to Young People to thank and commended them for attending the meeting and for sharing their inspiring journeys.**
