1. SUMMARY

The application is for the grant of a Premises Licence for the provision of late night refreshment.

2.6 Relevant Representations Received

Individual, Body or Business

Three letters of representation have been received from and on behalf of local residents which raise concerns of noise nuisance and boisterous behaviour late at night particularly from people congregating outside the shop. Concerns are also raised regarding anti-social behaviour in the grounds and around the area and litter problems. A resident also comments that the majority of residents in a nearby complex are in their 80's and 90's and any noise would be a great intrusion.

The representations are attached at Appendix 2.

3. OTHER CONSIDERATIONS

Legal Appraisal

3.1 The Licensing Act 2003 requires the Council to carry out its various licensing functions so as to promote the following four licensing objectives:

- a) the prevention of crime and disorder
- b) public safety
- c) the prevention of public nuisance
- d) the protection of children from harm

3.2 The Council must also have regard to the guidance issued by the Home Office under Section 182 of the Licensing Act 2003. Regard must also be taken of the Council's statement of Licensing Policy for the District.

3.3 Where it is decided it is necessary to depart from the statutory guidance or the Licensing Policy on the merits of a particular case; then special reasons justifying this must be given that can be sustained.

3.4 Only "relevant representations" can be taken into account. In order to be "relevant" a representation must fairly relate to achieving a licensing objective. If it does not, it must be discounted.

3.5 Any licensing conditions that Members may propose attaching must also relate to achieving one of the licensing objectives; be tailored to the actual premises and style of licensable activity; must be reasonably achievable by the applicant and in

his/her control.

Statement of Policy Issues

- 3.6** The following parts of the Licensing Policy are of particular importance; Part 4 (prevention of crime and disorder) & Part 6 (prevention of public nuisance).
- 3.7** The Annexes to the Policy sets out various types of model condition that could be considered.

4. OPTIONS

4.1 Members may:

- (a) Grant a premises licence as applied for subject to any mandatory conditions and the precautions specified in the operating schedule submitted.
- (b) Grant a premises licence subject to such additional conditions relating to achievement of the licensing objectives as members think fit; or
- (c) Refuse the application for a premises licence.

4.2 Should the applicant or any other party to the hearing feel aggrieved at any decision with regard to the licence or to any conditions or restrictions attached by Members they may appeal to the Magistrates Court.





I am writing to register my objection to the above application for a Late night Refreshments licence.

The application proposes that food and beverage will be sold for consumption off the between 23.00h and 04.00.

The Residents of Listers Court, who are mainly aged, are situated at around 100 m from 3B Dalesway House. They already suffer noise nuisance and antisocial behaviour at all hours of the day and night caused by the Listers Arms (Whitherspoons) This has included finding needles, bottles and broken glasses in the gardens of the residence. There are often groups of drunken youths in the grounds. You can imagine the worry that this causes them. Granting a licence would add litter to this list and would prolong the existing problem of noise and antisocial behaviour.

It is totally unacceptable to expect them to be submitted to this sort of behaviour until 4 am in the morning.

Due to ongoing problems with noise, crime and disturbance the Listers Arms was refused an extension to their licensing hours. Granting a licence for night time sales, (albeit not alcohol) in close proximity to them could enable them to re-apply for an extension to their own licensing hours.

In view of the above, I would urge the Licensing Authority to refuse the application.
