1. DISCLOSURES OF INTEREST

1. SUMMARY

The application is for the grant of a premises licence for the sale of alcohol and the provision of regulated entertainment.

2. BACKGROUND

2.1 The applicant

Mrs Christine Townend. A copy of the application is included at Appendix 1.

Ainsbury, 7 Thackley Road, Bradford, BD10 0RS.

2.4 Application

The application is for the grant of a Premises Licence. The operating schedule describes the following as the relevant licensable activities applied for:

- Sale of alcohol
- Provision of regulated entertainment (recorded music)

Hours applied for:	Sunday to Thursday	15.00 to 21.00
	Saturday & Sunday	15.00 to 22.00

2.5 Steps proposed by the applicant to address the Licensing Objectives

a) Prevention of crime and disorder will be achieved by:

I will display challenge 21 notice. A notice will also be displayed stating that drug use and violent anti-social behaviour will not be tolerated on the premises. I will have CCTV and main door access to street lighting. I will liaise with any pub watch scheme and I will be happy to take further guidance from local police on this matter. I will discourage binge drinking and promotional drink offers.

b) Public safety will be achieved by:

I will conduct ongoing health and safety and fire risk assessments as well as first aid training. I will install CCTV cameras, emergency lighting and smoke detectors. A log book will be maintained that regular checks to alarm electrical appliances are all in working order. c) Prevention of public nuisance will be achieved by;

I intend to sell alcohol within times that do not exceed normal trading hours. All deliveries and rubbish disposal will be during the day. There is no kitchen or food sold on the premises. There will be no external fans. Notices on the door will ask patrons to leave quietly and respectfully.

d) Protection of children from harm will be achieved by;

There will be no adult entertainment or gambling and a challenge 21 policy will be in place. I will comply with any conditions the authority has made, but think it would be reasonable to allow children accompanied by an adult on the premises until 6pm each evening. I think a sensible drinking approach will ensure children are not exposed to any violence or disorder.

e) General - all four licensing objectives

I am proposing to open a micro pub which sells mainly real ale from local breweries. I hope to attract discerning drinkers out for a quiet drink. I am aware of my responsibilities as the DPS and will be implementing a sensible drinking policy. I will undertake ongoing risk assessments as public safety is my main concern. I will keep noise to a minimum and liaise with my neighbours. There will be no amplified music or fruit machines.

2.6 Relevant Representations Received

Responsible Authority

In order to address the prevention of public nuisance objective, the Environmental Health Officer has requested that the following condition is placed on the licence;

- Noise from recorded music from within the licensed premises, shall not be audible in the nearest noise sensitive residential dwellings.

The applicant has agreed to the condition being placed on the licence.

The representation is attached at Appendix 2.

Individual, Body or Business

Four letters of representation have been received from a Ward Councillor and local residents, which raise concerns of noise and disturbance from regulated entertainment and patrons congregating on the pavement outside to drink and smoke. Concerns are also raised regarding criminal behaviour, disorder and antisocial behaviour and litter problems.

The representations are attached at Appendix 3.

3. OTHER CONSIDERATIONS

Legal Appraisal

- **3.1** The Licensing Act 2003 requires the Council to carry out its various licensing functions so as to promote the following four licensing objectives:
 - a) the prevention of crime and disorder
 - b) public safety
 - c) the prevention of public nuisance
 - d) the protection of children from harm
- **3.2** The Council must also have regard to the guidance issued by the Home Office under Section 182 of the Licensing Act 2003. Regard must also be taken of the Council's statement of Licensing Policy for the District.
- **3.3** Where it is decided it is necessary to depart from the statutory guidance or the Licensing Policy on the merits of a particular case; then special reasons justifying this must be given that can be sustained.
- **3.4** Only "relevant representations" can be taken into account. In order to be "relevant" a representation must fairly relate to achieving a licensing objective. If it does not, it must be discounted.
- **3.5** Any licensing conditions that Members may propose attaching must also relate to achieving one of the licensing objectives; be tailored to the actual premises and style of licensable activity; must be reasonably achievable by the applicant and in his/her control.

Statement of Policy Issues

- **3.6** The following parts of the Licensing Policy are of particular importance; Part 4, (prevention of crime and disorder) and Part 6 (prevention of public nuisance).
- **3.7** The Annexes to the Policy sets out various types of model condition that could be considered.

The applicant should also be able to examine the requirements of the fire authority. If the decision is to refuse then reasons should be given.

I am proposing to open a micro pub which sells mainly real ale from local breweries. I hope to attract discerning drinkers out for a quiet drink. I am aware of my responsibilites as the DPS and will be implementing a sensible drinking policy. I will undertake ongoing risk assessments as public safety is my main concern. I will keep noise to a minimum and liaise with my neighbours. There will be no amplified music or fruit machines.

b) The prevention of crime and disorder

I will display challenge 21 notice. A notice will also be displayed stating that drug use and violent anti-social behaviour will not be tolerated on the premises. I will have CCTV and main door access to street lighting. I will liaise with any pub watch scheme and I will be happy to take further guidance from local police on this matter. I will discourage binge drinking and promotional drink offers.

c) Public safety

I will conduct ongoing health & safety and fire risk assessments as well as first aid training. I will install CCTV cameras, emergency lighting and smoke detectors. A log book will be maintained that regular checks to alarm and electrical appliances are all in working order.

d) The prevention of public nuisance

l intend to sell alcohol within times that do not exceed normal trading hours. All deliveries and rubbish disposal will be during the day. There is no kitchen or food sold on the premises. There will be no external fans. Notices on the door will ask patrons to leave quietly and respectfully.

e) The protection of children from harm

There will be no adult entertainment or gambling and a challenge 21 policy will be in place. I will comply with any conditions the authority has made but think it would be reasonable to allow children accompanied by an adult on the premises until 6pm each evening.

I wish to object to the application for a premises licence for the sale of alcohol at **The Ainsbury 7 Thackley Road**, **Thackley, Bradford, BD10 0RS** on the grounds of the risk to the public and local residents from noise nuisance.

The Ainsbury is a former residential premise with residential properties on either side of the corner of the two terraces which form the junction between Thackley Road and Windhill Old Road.

Residents and the public will be at risk from a significant adverse impact of noise nuisance due to the noise and disturbances associated with customers visiting the site and congregating outside in close proximity to their residential properties. The applicant has given no consideration to the problems arising from people congregating on the street, not just smokers but on sunny days simple overspill from the small bar.

The applicant is currently applying for approval for internal sound-proofing to control noise emanating from the site. Sound-proofing inside will not have any effect on that noise or disturbance.

The property is located at the junction of Thackley Road and Crag Hill Road where the visibility is poor. There is no provision for off-street parking or deliveries. This will leave residents from the adverse noise nuisance impact of vehicles arriving, waiting, picking customers up or making deliveries and departing.

Given the distance of the addresses of supporters of the proposal from the site it is unlikely that they would walk to the proposal and would need to park local similarly as would members of staff as it unlikely the owner could impose walking to work as a condition of employment.

The planning application process is now subject to complaint which is being dealt with through the Council's complaint process. I would ask that the panel does not approve a licence for this business until the complaint has been heard through the complaint process.

The only way to protect local residents and the public from noise nuisance is to refuse to grant a licence for these premises. Should the panel be mined to grant the licence then I would ask that you add these three conditions to the licence:

Firstly; that there is to be no overspill of customers onto the public footway outside the property in either direction (Thackley Road or Windhill Old Road or in any of the surrounding streets).

Secondly that no seating, tables or chairs or similar are to be placed temporarily or permanently on the footpath property in either direction (Thackley Road or Windhill Old Road or in any of the surrounding streets).

Thirdly that no smoking by customers or staff shall take place outside the premises on the public footway outside the property in either direction (Thackley Road or Windhill Old Road or in the nearby residential streets in the vicinity of 7 Thackley Road.

The basis for my opposition is;

- 1. Prevention of Public Nuisance, specifically, real concerns relating to;

I should mention that I submitted comments to the Planning Department when the initial planning application was lodged. I have also raised a complaint regarding the manner in which the Planning Panel dealt with this matter.

Having owned the neighbouring property for 40 years I have witnessed and experienced many changes and developments in the immediate area. These changes have, of course, had varying degrees of impact on amenity for residents in the immediate and wider vicinity. I therefore fully understand that there has to be a balance between benefits to a community and the potential harm/loss of amenity/disturbance to local residents. However, I am sorry to say that I am not convinced that any potential benefits outweigh the potential harm on this occasion and would ask that you accept my representation:
