The initial request for this street name was Hannah Court which would be a duplicate street name in the Bradford District.

The addressing scheme had been through a consultation period of 21 days with the Local Councillors, Councillor Beverley Mullaney, Councillor Richard Dunbar and Councillor Sue Duffy. There were no comments in support or not in support received.
