1. SUMMARY

The application is for the grant of a Premises Licence for the provision of late night refreshment to take place indoors.

2. BACKGROUND

2.1 The applicant

Smashd Ltd. A copy of the application is included at Appendix 1.

2.2 The Premises

Smashd, 364 Great Horton Road, Bradford, BD7 1QJ.

2.3 Designated Premises Supervisor

Not required.

2.4 Application

The application is for the grant of a Premises Licence. The operating schedule describes the following as the relevant licensable activities applied for:-

Provision of late night refreshment to take place indoors

Hours of licensable activities:

Monday to Thursday: 23.00 to 02.30 Friday to Sunday: 23.00 to 03.30

2.5 Steps proposed by the applicant to address the Licensing Objectives

a) Prevention of crime and disorder will be achieved by;

Adequate lighting.

Roller shutters.

Visible CCTV cameras.

b) Public safety will be achieved by;

Fire exit situated at the back of the premises.

Exit situated on the ground floor (not used by the public in general but access from the main).

First aid kit. Fire extinguisher. Limited seating.





Limited indoor capacity 15.

c) Prevention of public nuisance will be achieved by;

The property has been sound & fire proof.

Double glazed windows.

Background music played at a reasonable level.

Staff clear litter inside & outside of premises.

Loading & unloading done with no limits to the main road as the back off road area is available.

Silencer on canopy to limit noise.

d) Protection of children from harm will be achieved by;

No adult entertainment.

No gaming machines.

Requirement for children to be accompanied by an adult (children under 12).

e) General – all four licensing objectives

Staff trained on licensing issues.

CCTV that capture activities on the premises and situated outside the premises.

2.6 Relevant Representations Received

Individual, Body or Business

Representations have been received from Ward Councillors, four local residents and the Bradford West Ward Officer. A Ward Councillor notes that allowing the application will contradict the planning decision. The representations raise concerns of increased noise and disturbance in a mainly residential area from customers chatting and cars being driven into the area late at night. Concerns are also raised regarding anti-social behaviour, litter problems and rodent infestations.

The representations are attached at Appendix 2.

3. OTHER CONSIDERATIONS

Legal Appraisal

- 3.1 The Licensing Act 2003 requires the Council to carry out its various licensing functions so as to promote the following four licensing objectives:
 - a) the prevention of crime and disorder
 - b) public safety
 - c) the prevention of public nuisance
 - d) the protection of children from harm
- 3.2 The Council must also have regard to the guidance issued by the Home Office





under Section 182 of the Licensing Act 2003. Regard must also be taken of the Council's statement of Licensing Policy for the District.

- 3.3 Where it is decided it is necessary to depart from the statutory guidance or the Licensing Policy on the merits of a particular case; then special reasons justifying this must be given that can be sustained.
- 3.4 Only "relevant representations" can be taken into account. In order to be "relevant" a representation must fairly relate to achieving a licensing objective. If it does not, it must be discounted.
- 3.5 Any licensing conditions that Members may propose attaching must also relate to achieving one of the licensing objectives; be tailored to the actual premises and style of licensable activity; must be reasonably achievable by the applicant and in his/her control.

Statement of Policy Issues

- 3.6 The following parts of the Licensing Policy are of particular importance; Part 4 (prevention of crime & disorder) and Part 6 (prevention of public nuisance).
- **3.7** The Annexes to the Policy sets out various types of model condition that could be considered.

Article 6 – A procedural right to a fair hearing. As refusal of the application is an option, adherence to the Panels' usual procedure of affording a hearing to the applicant is very important. The applicant should also be able to examine the requirements of the fire authority. If the decision is to refuse then reasons should be given.


