A. PROCEDURAL ITEMS

1. DISCLOSURES OF INTEREST

(Members Code of Conduct – Part 4A of the Constitution)

- (3) Members in arrears of Council Tax by more than two months must not vote in decisions on, or which might affect, budget calculations, and must disclose at the meeting that this restriction applies to them. A failure to comply with these requirements is a criminal offence under section 106 of the Local Government Finance Act 1992.
- (4) Officers must disclose interests in accordance with Council Standing Order 44.

1. SUMMARY

The application is for the grant of a premises licence for the sale of alcohol for consumption on & off the premises and the provision of regulated entertainment indoors & outdoors.

2. BACKGROUND

2.1 The applicant

Wishbone Tap Ltd. A copy of the application is included at Appendix 1.

2.2 The Premises

Wishbone Tap, 60 Low Street, Keighley, BD21 3PT.

2.3 Proposed Designated Premises Supervisor

2.4 Application

The application is for the grant of a Premises Licence. The operating schedule describes the following as the relevant licensable activities applied for:

- Sale of alcohol
- Provision of regulated entertainment

Hours of licensable activities:

Supply of Alcohol

Monday to Sunday: 11.00 to 00.00 Christmas Eve: 11.00 to 01.00 New Years Eve: 11.00 to 01.00

Performance of live music indoors & outdoors and playing of recorded music indoors

Monday to Thursday: 19.00 to 22.00 Friday & Saturday: 12.00 to 23.00 Sunday: 12.00 to 22.00

2.5 Steps proposed by the applicant to address the Licensing Objectives

a) Prevention of crime and disorder will be achieved by:

CCTV will be installed, inside and also outside at front and back of premises.

Happy to join any Pub Watch scheme or scheme run by the local police. Ensure adequate numbers of staff to oversee the site during our open hours.

b) Public safety will be achieved by:

The premises fronts onto a well-lit pedestrian area in the town centre and we will ensure good lighting at the rear of the building. We aim to provide drinks for the modern drinker, we find modern drinkers to be focused on flavour and character of drinks versus just the alcohol. We will price these modern drinks accordingly which aims and appeals to a more cultured clientele.

Fire Risk Assessments will be carried out and we will have a written health & safety policy in place.

c) Prevention of public nuisance will be achieved by;

We will ask our customers to be polite and respectful to our neighbours and neighbouring businesses. We plan to call last orders at 22.00 most evenings to give customers plenty of time to leave in an orderly manner. Refusing to serve intoxicated customers.

d) Protection of children from harm will be achieved by;

No under 18's after 18.00. Before 18.00 to be accompanied by a parent, guardian or responsible adult. CCTV is in all public areas of the premises. Ensure staff are trained to enforce the Challenge 21/25 scheme.

e) General – all four licensing objectives

We will ensure all staff members are trained and confident in their knowledge of the licensing objectives and have a good understanding of what is and what isn't permitted on the premises. All permanent full time staff will be made personal licence holders so that the required knowledge can be gained.

2.6 Relevant Representations Received

Individual, Body or Business

A representation has been received from a local business, which raises concerns of noise nuisance from regulated entertainment causing disturbance to residents in the living accommodation and also to the health care business which runs 24 hours a day.

Safety concerns for female staff are also raised with reference to the crime rate in the area and the potential for intoxicated individuals to cause nuisance.

The representation is attached at Appendix 2.

3. OTHER CONSIDERATIONS

Legal Appraisal

- 3.1 The Licensing Act 2003 requires the Council to carry out its various licensing functions so as to promote the following four licensing objectives:
 - a) the prevention of crime and disorder
 - b) public safety
 - c) the prevention of public nuisance
 - d) the protection of children from harm
- 3.2 The Council must also have regard to the guidance issued by the Home Office under Section 182 of the Licensing Act 2003. Regard must also be taken of the Council's statement of Licensing Policy for the District.
- 3.3 Where it is decided it is necessary to depart from the statutory guidance or the Licensing Policy on the merits of a particular case; then special reasons justifying this must be given that can be sustained.
- 3.4 Only "relevant representations" can be taken into account. In order to be "relevant" a representation must fairly relate to achieving a licensing objective. If it does not, it must be discounted.
- 3.5 Any licensing conditions that Members may propose attaching must also relate to achieving one of the licensing objectives; be tailored to the actual premises and style of licensable activity; must be reasonably achievable by the applicant and in his/her control.

Statement of Policy Issues

- The following parts of the Licensing Policy are of particular importance; Part 4, (prevention of crime and disorder) and Part 6 (prevention of public nuisance).
- **3.7** The Annexes to the Policy sets out various types of model condition that could be considered.

The applicant should also be able to examine the requirements of the fire authority. If the decision is to refuse then reasons should be given.

The pub on next door leads extra pressure on our staff and we the directors are more concerned their safety. 2 female staff have already expressed their concerns and informed that they refuse to work on weekends considering their safety. 1. SUMMARY

The Licensing Panel are asked to consider a personal licence following a conviction of a relevant offence by the holder of that licence.

2. BACKGROUND

2.1 Personal Licence

Personal licences are issued by the Licensing Authority where the applicant resides, and applicants must hold an accredited licensing qualification. Once granted, a personal licence remains valid unless surrendered, suspended, revoked or declared forfeit by the Courts.

A personal licence was granted to Mr Aziz Salah Abdullah on 24 July 2019. A copy of the personal licence is attached at Appendix 1.

2.2 Since 06 April 2017, a Licensing Authority which issued a Personal Licence is now able to suspend (for up to 6 months) or revoke a Personal Licence, where the Licensing Authority becomes aware that an individual holding a personal licence has been convicted of a relevant offence or a foreign offence, a foreign offence being an equivalent offence committed in any place other than England and Wales, or if the holder has been required to pay an immigration penalty. This is a discretionary power.

A list of relevant offences is attached at Appendix 2.

2.3 LA 2003 Section 128 provides that where the holder of a personal licence is charged with a relevant offence, he must, produce to the court the personal licence, or notify the court of the existence of the personal licence and the identity of the relevant licensing authority and of the reasons why he cannot produce the licence. A person commits an offence if he fails, without reasonable excuse, to comply with this section.

The Licensing Authority has been unable to obtain information from West Yorkshire Magistrates Court, as to whether Mr Abdullah disclosed to the Court that he holds a personal licence.

2.4 LA 2003 Section 132 places an obligation on the licence holder to notify the Licensing Authority of any conviction of a relevant offence. A person commits an offence if he fails, without reasonable excuse, to comply with this section.

The Licensing Authority was notified by West Yorkshire Trading Standards that the personal licence holder had been convicted of a relevant offence as defined in Schedule 4 of the Act. Mr Abdullah did not inform the Council as Licensing Authority of the relevant offence.





Details of the offence are attached at Appendix 3.

2.5 Where the Licensing Authority becomes aware that a holder of a Personal Licence has been convicted of a relevant offence or foreign offence and is considering revocation or suspension of the licence, notice must be sent to the holder of the Personal Licence inviting the Personal Licence Holder to make representations regarding the conviction within 28 days. This notice cannot be sent until after the period for lodging an appeal against the conviction for a relevant offence has passed. Where an appeal has been lodged, it must be decided and the conviction upheld in order for the Licensing Authority to exercise its powers.

The West Yorkshire Magistrates convicted Mr Abdullah of the offence of Fraudulent trading by sole trader - Fraud Act 2006 –S9(1)

Mr Abdullah pleaded guilty to the offence on 16 June 2022.

The court sentenced Mr Abdullah to 6 months custody.

A copy of the notice served on Mr Abdullah is attached at Appendix 4.

2.6 Mr Abdullah has not responded to the notice.

3. OTHER CONSIDERATIONS

Legal Appraisal

- 3.1 The Licensing Act 2003 requires the Council to carry out its various licensing functions so as to promote the following four licensing objectives:
 - a) the prevention of crime and disorder
 - b) public safety
 - c) the prevention of public nuisance
 - d) the protection of children from harm
- 3.2 The Council must also have regard to the guidance issued by the Home Office under Section 182 of the Licensing Act 2003. Regard must also be taken of the Council's statement of Licensing Policy for the District.
- 3.3 LA2003 Section 132A This section applies where a licensing authority has granted a personal licence and it becomes aware that the holder of the licence has been, at any time before or after the grant of the licence—
 - (a) convicted of any relevant offence or foreign offence, or
 - (b) required to pay an immigration penalty.

The relevant licensing authority may—

(a) suspend the licence for a period not exceeding six months, or





(b)revoke the licence.

If the relevant licensing authority is considering whether to suspend or revoke the licence, the authority must give notice to the licence holder.

The notice must invite the licence holder to make representations regarding—
(a)the relevant offence, foreign offence or immigration penalty that has caused the relevant licensing authority to issue the notice,

(b)any decision of a court under section 129 or 130 in relation to the licence, and (c)any other relevant information (including information regarding the licence holder's personal circumstances).

The licence holder may make representations to the relevant licensing authority within the period of 28 days beginning with the day the notice was issued.

Before deciding whether to suspend or revoke the licence the Licensing Authority must consider:

- a) any representations made by the licence holder
- b) any decision of a court to forfeit or suspend the personal licence of which the licensing authority is aware, or any suspension of that decision on appeal; and
- c) any other information which the authority considers relevant.

- 9.4 Should the personal licence holder feel aggrieved at any decision with regard to the licence they may appeal to the Magistrates Court. Where an appeal is made, any decision by the Licensing Authority does not have effect until the appeal is disposed of.
- **9.5** Where no appeal is made, the decision of the Licensing Authority comes into effect at the end of the period that an appeal can be made.

LICENSING ACT 2003 – Notice to consider whether to revoke or suspend a Personal Licence.

Personal Licence - 214532

I write regarding information provided by West Yorkshire Trading Standards stating that on the 16 June 2022, you were convicted of the following offence;

Fraud Act 2006 –S9(1) Fraudulent trading by sole trader.

I note that you also failed to notify the Court that you hold a personal licence.

The Licensing Act 2003, Schedule 4 sets out the relevant offences in regards to a personal licence holder. A conviction under Fraud Act 2006, is classed as a relevant offence.

Under section 132A of the Licensing Act 2003, local authorities can revoke or suspend (maximum of 6 months) a personal licence.

In light of the above conviction, the licensing authority for City of Bradford Metropolitan District Council is giving you notice that they are considering revoking or suspending your personal licence, 214532.

You have 28 days beginning from the date this notice was issued to provide representations that will be considered before a final decision is made.

Your representation can make comments in regards to the following:

- The relevant offence that caused City of Bradford Metropolitan District Council to issue this notice.

- Any decision of the court under section 129 or 130 of the Licensing Act 2003 in relation to your personal licence. Section 129 allows the court to order the forfeiture of the licence or order its suspension for a period not exceeding six months. Section 130 relates to an appeal of the decision made by the court in regard to a decision made under section 129.
- Any other relevant information. This can include information regarding personal circumstances etc.

Please provide any representation by the 11 August 2022.

Once your representation is received, a meeting of the Licensing Sub-Committee will be held where a decision will be made to revoke your personal licence, suspend your personal licence, issue a written warning or take no further action. You will be informed of the date of the hearing and be invited to attend and speak if you wish to do so, or you may instruct someone to attend and speak on your behalf.

If the Sub-Committee decide to suspend, issue a written warning, or take no further action, we are required by law to inform the Chief of Police, and ask them to provide representations on your case considering the objective of the prevention of crime and disorder. Any response received from the police will be considered, and a second hearing may take place to consider the information available (e.g. if the police object to the original decision). Should such a second hearing be appropriate, then you will be informed of the date of the hearing and be invited to attend and speak if you wish to do so, or you may instruct someone to attend and speak on your behalf.

Following the hearing and decision process outlined above, you will be notified of the final decision.

If the decision of the Sub-Committee is to revoke or suspend your licence at either of these hearings you will have the right to appeal that decision. Further information will be provided to you in the event such a decision is made.
