**Overview & Scrutiny Area:** Corporate

#### 1. SUMMARY

The application is for variation to extend permitted hours for the sale of alcohol for consumption off the premises.

#### 2.1 The applicant

#### 2.3 Designated Premises Supervisor

#### 2.4 Current Licence

The premises currently hold a Premises Licence with the following permitted hours;

Supply of Alcohol for consumption off the premises

Monday to Sunday: 06.00 to 00.00

A copy of the premises licence is included at Appendix 2.

#### 2.5 Application

The variation application has been submitted to extend permitted hours for the sale of alcohol for consumption off the premises.

Hours of licensable activities requested:

Supply of Alcohol for consumption off the premises

Monday to Sunday: 00.00 to 06.00

#### 2.6 Steps proposed by the applicant to address the Licensing Objectives

a) Prevention of crime and disorder will be achieved by;

As per pre-existing premises licence. The sale or supply of alcohol between the hours of midnight and 06.00 hours must be by way of a serving hatch only.

b) Public safety will be achieved by;

As per pre-existing premises licence.

c) Prevention of public nuisance will be achieved by;

As per pre-existing premises licence.

d) Protection of children from harm will be achieved by;

As per pre-existing premises licence.

e) General – all four licensing objectives

As per pre-existing premises licence.

#### 2.7 Relevant Representations Received

#### Individual, Body or Business

Twenty-one representations have been received including two from Ward Councillors, which raise concerns of noise from customers congregating in the area and anti-social behaviour around the shop. There are also concerns regarding criminal behaviour and criminal damage to cars and property, litter problems and broken glass in the area.

The representations are attached at Appendix 3.

#### 3. OTHER CONSIDERATIONS

#### Legal Appraisal

- **3.1** The Licensing Act 2003 requires the Council to carry out its various licensing functions so as to promote the following four licensing objectives:
  - a) the prevention of crime and disorder
  - b) public safety
  - c) the prevention of public nuisance
  - d) the protection of children from harm
- **3.2** The Council must also have regard to the guidance issued by the Home Office under Section 182 of the Licensing Act 2003. Regard must also be taken of the Council's statement of Licensing Policy for the District.
- **3.3** Where it is decided it is necessary to depart from the statutory guidance or the Licensing Policy on the merits of a particular case; then special reasons justifying this must be given that can be sustained.

- **3.4** Only "relevant representations" can be taken into account. In order to be "relevant" a representation must fairly relate to achieving a licensing objective. If it does not, it must be discounted.
- **3.5** Any licensing conditions that Members may propose attaching must also relate to achieving one of the licensing objectives; be tailored to the actual premises and style of licensable activity; must be reasonably achievable by the applicant and in his/her control.

#### **Statement of Policy Issues**

- **3.6** The following parts of the Licensing Policy are of particular importance; Part 4 (prevention of crime and disorder) and Part 6 (prevention of public nuisance).
- **3.7** The Annexes to the Policy sets out various types of model condition that could be considered.

- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
  - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
  - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
  - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
  - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
  - Recorded Music: no licence permission is required for:
  - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
  - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.

(a) 'duty' is to be construed in accordance with the Alcoholic Liquor Duties Act 1979,

(b) 'permitted price' is the price found by applying the formula 'P' equals 'D' plus ('D' times 'V'), where-

(i) P is the permitted price,

(ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and

(iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol,

(c) 'relevant person' means, in relation to premises in respect of which there is in force a premises licence-

(i) the holder of the premises licence,

(ii) the designated premises supervisor (if any) in respect of such a licence, or

(iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence,

(d) 'relevant person' means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question, and

(e) 'value added tax' means value added tax charged in accordance with the Value Added Tax Act 1994.

Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ('the first day') would be different from the permitted price on the next day ('the second day') as a result of a change to the rate of duty or value added tax.

The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

#### **Embedded Conditions**

The restrictions on permitted hours do not prohibit:

(a) During the first twenty minutes after permitted hours, the taking of alcohol from the premises, unless the alcohol is supplied or taken in an open vessel;



There are several properties close to the premises, and they will be adversely impacted if the shop is open all night for sales of alcohol (it currently closes at 10, though could presumably remain open until 12 under its existing license).

I believe that the nearby Tesco closes at 11, and assume that all the nearby stores are shut by 12.

I'm writing regarding the application from Bargain Booze, 56-61 Saltaire Road for a 24 hour license to sell alcohol.

I live just across the road at Park Street, BD18 3LL. I can see the shop from my living room window.

Unfortunately, I object to this application.

We get a fair amount of noise from the street outside, particularly on Friday and Saturday nights, partly owing to the pub across the road. We are happy to tolerate this (within reason), given the value the pub brings to the area economically and as a community hub.

But quite often the noise goes on into the early hours of the morning, in which case it is usually also louder than usual, and will often wake my 6 year old daughter, and I will occasionally go out myself and ask people politely to be quiet (or ideally go home!)

On these occasions, the noise is no longer from pub customers, as the pub is long since closed, and the people are standing in the street drinking alcohol purchased from an off license. **Please see an attached photo** which shows the state of the street the morning after such an incident. (This photo was taken on Saltaire Road opposite the car park on Exhibition Road, on the morning of Sunday October 30th 2022). You can see that these are not drinks purchased in a pub.

Saltaire has a thriving evening economy, and long may that continue. But it's a residential village popular with young families, and these two needs must be balanced. Unfortunately, some visitors to the area aren't respectful of this, and behave as if they are in a city centre. My concern is that a 24 hour alcohol supply not only enables this pattern of behaviour, it in fact legitimises it.

A 24-hour off license brings such limited value to the economy of my area, if any. And the potential risk to the well-being of residents seems to outweigh that value by some margin.

Further concerns:

- Late night traffic noise (you'd be amazed how loud people will have their car stereo on while nipping into an off license).


- The health of those local residents suffering with alcohol dependency.

I have lived at Park Street Street just across the road from bargain Booze for 20 years and have had to call the police on numerous occasions because the off licence was being robbed and broken into. The last occasion it was rammed by a car into the side of the building early in the morning waking everyone in the neighborhood.

We are presently surrounded by alcohol suppliers namely: Tesco, Nisa, Co-Op all within five minutes walk. Asda is a ten minute walk, There are also numerous places where alcohol is consumed on Bradford Road and Saltaire Road and quite frankly most residents have had enough with the influx of people not living in the area causing a disturbance.

This license will therefore increase crime and disorder, create a public nuisance and affect public safety.

I currently live at Maddocks Street and we have to take preventetive measures to minimise the disturbance from customers using this premises such as keeping windows closed until midnight. As a family within very close proximity of Bargain Booze, our objections to the extended license are as follows:


There would be a need to increase lighting for good usable cctv operation, otherwise it will be useless. Increased people in the area at unsociable hours and the noise that they can make, the proximity of the garages (20 meters away) creates a dark place (poor lighting) where I have witnessed people waiting and urinating into the bush from our backyard. This is not the sort of thing I want to see from my home. Increased litter due to the amount of people using the service, including cars stopping and accelerating away after parking on the street. We already have cars parking on the path obstructing pram access including across the Bargain Booze parking spot over the path on Maddocks Street.

Drug dealing in the very local area, a number of police reports have been made by neighbours. These will be on record with West Yorkshire Police. You may be able to access this, I'm not sure. Though there may be no direct involvement with Bargain Booze as it's been a long-standing problem however I can't see how extending alcohol licensing and installing a serving hatch is going to improve the situation moreover it will probably exacerbate it.

Alcohol can easily be purchased within the local area, Tesco (Saltaire Rd) approx. 300 meters, Fanny's ale house (opposite) with extended licensing hours, I do not see the purpose of 24 hours or the business case for it. There is also nowhere else around with this 'serving hatch' after hours booze supply in the local area, so there is absolutely no need or call for it.

I am a resident of ■ Rhodes St, Shipley BD18 3JJ and I'm writing to oppose the licensing for the sale of alcohol off the premises between 00:00 and 23:59 Monday to Sunday by way of a hatch at 59-61 Saltaire Road, Shipley BD18 3JN.

Having alcohol for sale between midnight and 6am would only attract more disorderly behaviour. With the Salt Cellar across the street and Fanny's next door, we could only expect revellers to be picking up more alcohol right on their doorstep and being even more noisy if/when they move onto the next location. On Sunday night I was treated to a group of drunk people imitating wolves as they left one of the pubs and walked down along the garages in Saltaire Road.

These garages have had an arrest in the last year from drug use and that corner has been a regular pick up site for drug users. I fear that having a point of sale for alcohol during the night would increase the number of people hanging out around the area overnight.

If alcohol is required past the Tesco, Nisa Local and Bargain Booze closing times (all located within 200m of each other on Saltaire Road) and past the two pubs closing

times, then there is the BP Spar in Shipley or the Shell on Bingley Road, both within a 10 min walk.
