#### 1. SUMMARY

This report brings the draft Forward Plan 2016-17 for the Board to amend or approve.

#### 2. BACKGROUND

The Forward Plan sets out for discussion standing items of business, items called back to the Board and proposes topics for the themed sessions of the Board.

A planned discussion at the April 6<sup>th</sup> Board meeting was deferred to an informal meeting in June, at which it was suggested that the Forward Plan should be aligned with the priorities of the West Yorkshire Sustainability and Transformation Plan.

#### 3. OTHER CONSIDERATIONS

The Draft Forward Plan for 2016-17 see Appendix 1 has duly been amended so that the proposed themes reflect the draft priorities of the West Yorkshire Sustainability and Transformation Plan. 'Prevention at Scale' has not been listed as a theme, to reflect discussion at the 20<sup>th</sup> June (informal) meeting that prevention should be considered in all reports to the Board at all meetings.

This has resulted in a doubling up of themes in two meetings in order to fit with the number of meetings planned for the Civic Year, alternatively two topics could be carried forward into 2017-18.

The proposed order can be amended for a better fit with developments in the relevant fields, but this decision should ideally be taken at the July 26<sup>th</sup> Meeting to enable a Forward Plan to be published in line with the recommendations of the November 2014 Local Government Association Peer Review.
