Christmas Eve 10.00 - 02.00 Christmas Day 10.00 - 02.00 Boxing Day 10.00 - 02.00

27th - 30th December 10.00 - 02.00

New Years Eve - 10.00 hours until the start of permitted hours the following day. 10.00 – 02.00, Friday, Saturday, Sunday and Monday of every statutory Bank Holiday weekend and Maundy Thursday.

Until 02.00 St Patricks Day, St David's Day, St George's Day, St Valentine's Day, Burns Night,

Bonfire Night (5th November)

Any other Public Holiday declared by the State (Friday, Saturday, Sunday, Monday) (Coronation, death of a Monarch, Wedding, Jubilee etc)

An additional hour when British Summertime commences.

2.7 Relevant Representations Received

A letter of representation and 21 pro-forma letters have been received from local residents regarding noise and disturbance from loud music emanating from the premises. Residents also have concerns regarding late night anti-social behaviour and being unable to contact staff at the premises.

3. OTHER CONSIDERATIONS

Legal Appraisal

- 3.1 The Licensing Act 2003 requires the Council to carry out its various licensing functions so as to promote the following four licensing objectives:
 - a) the prevention of crime and disorder
 - b) public safety
 - c) the prevention of public nuisance
 - d) the protection of children from harm
- 3.2 The Council must also have regard to the guidance issued by the Home Office under Section 182 of the Licensing Act 2003. Regard must also be taken of the Council's statement of Licensing Policy for the District.
- 3.3 Where it is decided it is necessary to depart from the statutory guidance or the Licensing Policy on the merits of a particular case; then special reasons justifying this must be given that can be sustained.
- 3.4 Only "relevant representations" can be taken into account. In order to be "relevant" a representation must fairly relate to achieving a licensing objective. If it does not, it must be discounted.
- 3.5 Any licensing conditions that Members may propose attaching must also relate to achieving one of the licensing objectives; be tailored to the actual premises and





style of licensable activity; must be reasonably achievable by the applicant and in his/her control.

Statement of Policy Issues

- 3.6 The following parts of the Licensing Policy are of particular importance; Part 4 (prevention of crime and disorder) and Part 6 (prevention of public nuisance).
- **3.7** The Annexes to the Policy sets out various types of model condition that could be considered.

4. OPTIONS

- **4.1** Members may:
 - (a) Vary a premises licence as applied for subject to any mandatory conditions and the precautions specified in the operating schedule submitted.
 - (b) Vary a premises licence in whole or in part subject to such additional conditions relating to achievement of the licensing objectives as members think fit; or
 - (c) Refuse to vary the premises licence.
- 4.2 Should the applicant or any other party to the hearing feel aggrieved at any decision with regard to the licence or to any conditions or restrictions attached by Members they may appeal to the Magistrates Court.

5. FINANCIAL & RESOURCE APPRAISAL

Article 1 First Protocol to the Convention – Right to peaceful enjoyment of possessions subject to the state's right to control the use of property in accordance

with the general interest. The Council's powers set out in the recommendations fall within the states right. A fair balance must be struck between public safety and the applicant's rights.

Article 6 – A procedural right to a fair hearing. As refusal of the application is an option, adherence to the Panels' usual procedure of affording a hearing to the applicant is very important. The applicant should also be able to examine the requirements of the fire authority. If the decision is to refuse then reasons should be given.
