

#### **Breach of Planning Control:**

Construction of an extension to the rear of the property.

#### **Circumstances:**

It was brought to the attention of the Local Planning Authority(LPA) that the owners of the above premises had constructed a rear extension for which planning permission was required but had not been granted.

The owners of the premises have taken no remedial action in respect of this matter, despite request from the LPA.

The single storey rear extension due to its height, excessive depth, poor design and materials is considered to be overbearing and cause harm to the outlook from the habitable room windows of the adjoining residential property and overbearing of their outdoor amenity space. This results in a detrimental impact on the residential amenity of the present and future occupiers of the adjoining residential property and has a detrimental impact on the street scene.

It is therefore considered to be contrary to policies D1, UR3, UDP3 of the Replacement Unitary Development Plan, Guidance within the Householder SPD and national policy contained with the National Planning Policy Framework.

The Planning Manager (Enforcement and Trees) authorised the issuing of an Enforcement Notice under delegated powers on 10th May 2017.
