1. SUMMARY

This report asks the Executive to:

- 1.1 Approve the proposals to enlarge All Saints' C of E Primary School (Ilkley) premises by increasing the capacity of the school from 315 to 420.
- 1.2 Approve the proposals to enlarge Poplars Farm Primary School premises by increasing the capacity of the school from 210 to 420.

2. BACKGROUND

- 2.1 Over the last few years there has been an increase in the pupil population within the District. Recent data however shows a slight reduction in the number of children across the district requiring places in September 2017. The numbers do increase for entry in 2018 onwards in particular as a result of new housing in parts of the District. The Council is also working towards having 5% surplus across the District to ensure that new families coming into the District can be placed in an appropriate school.
- 2.2 Using data from previously published forecasts, the Local Authority proposed to increase the Published Admission Number (PAN) of All Saints' C of E Primary School (Ilkley) from 45 to 60 and Poplars Farm Primary School from 30 to 60 for September 2018. An increase in PAN is not a change requiring statutory consultation. However for a community school, the Local Authority (as admission authority) must consult at least the governing body of the school where it proposes to increase the PAN.
- 2.3 For some schools where an increase in PAN has been proposed there will also be the need to enlarge the premises which would increase the physical or net capacity of the school. For some enlargements which are significant changes there is a requirement to publish statutory proposals. Statutory proposals are required for proposed enlargements of premises of schools where the capacity of the school is increased by both more than 30 pupils and by 200 pupils or 25% of the existing capacity, whichever is the lesser. For all enlargements less than this, publication of statutory notices is not required. Note any incremental increases in the last 5 years must be taken into account when calculating the overall size of the enlargement.
- 2.4 There is no longer a prescribed pre-publication consultation period for significant changes. However, DfE guidance states that there is strong expectation on schools and Local Authorities that they consult interested parties in developing their proposals prior to publication, as part of their duty under public law to act rationally and to take into account all relevant considerations. All responses received to such consultation must then be considered in deciding whether to publish the necessary statutory proposals.
- 2.5 If there is a proposal to increase the PAN which would involve a statutory proposal to enlarge the premises increasing the physical capacity of the school there are therefore two related consultation processes:
 - i) Consultation on the proposal to increase the PAN
 - ii) Consultation on the proposal to enlarge the premises increasing the physical capacity of the school prior to publication of statutory proposals

3. OTHER CONSIDERATIONS

CONSULTATION

3.1 All Saints

Consultation on a change to the Published Admission Number (PAN) from 45 to 60 and to enlarge the premises of All Saints' C of E Primary School (Ilkley) from 315 to 420 was carried out between 2 November 2016 and 16 December 2016. See Appendix A. A summary of the analysis of responses to the consultation is appended to this report Appendix D

- 3.1.1 The list of those consulted is shown in Appendix C. The local media publicised the consultation. Details were also placed on the Council's website and on Bradford Schools Online, Facebook and Twitter.
- 3.1.2 At its meeting on 7 February 2017 Executive approved the increase of the PAN from 45 to 60 from 1 September 2018 and authorised the publication of statutory proposals to enlarge the premises of the school by increasing the capacity from 315 to 420 from 1 September 2018.
- 3.1.3 Standalone statutory proposals were published on 27 April 2017 for the enlargement of the premises of All Saints' C of E Primary School (Ilkley) by increasing the capacity from 315 to 420 from 1 September 2018. See Appendix F.
- 3.1.4 During the representation period of 4 weeks any person or organisation could submit comments on and objections to the proposal to the Council to be taken into account by the decision maker. No responses to these statutory proposals were received.

3.2 **Poplars Farm**

Consultation on a change to the Published Admission Number (PAN) from 30 to 60 and to enlarge the premises of Poplars Farm Primary School from 210 to 420 was carried out between 2 November 2016 and 16 December 2016. See Appendix B. A summary of the analysis of responses to the consultation is appended to this report Appendix E

- 3.2.1 The list of those consulted is shown in Appendix C. The local media publicised the consultation. Details were also placed on the Council's website and on Bradford Schools Online, Facebook and Tter.
- 3.2.2 At its meeting on 7 February 2017 Executive approved the increase of the PAN from 30 to 60 from 1 September 2018 and authorised the publication of statutory proposals to enlarge the premises of the school by increasing the capacity from 210 to 420 from 1 September 2018.
- 3.2.3 Standalone statutory proposals were published on 27 April 2017 for the enlargement of the premises of Poplars Farm Primary School by increasing the capacity from 210 to 420 from 1 September 2018. See Appendix G.
- 3.2.4 During the representation period of 4 weeks any person or organisation could submit comments on and objections to the proposed to the Council to be taken into account by the decision maker.
- 3.2.5 Since the November consultation and subsequent publication of statutory notices, up to date nhs data provided by the health authority has been received. This appears to show a reduction in the number of children of all age groups across the District. Despite the overall reduction, demand for school places in the Bradford East planning area is still higher than the current capacity in the area.
- 3.2.6 Only two responses to these statutory proposals was received objecting to the proposal, however the one objection being that the students would receive less contact hours and therefore would mean a decrease in overall results and standards and concerns about

parking. The second being about access, parking and traffic already considered plus the number of children and youths who could cause littering and nuisance. See Appendix H.

3.2.6 As pointed out in the Executive Report of 7 February 2017 section 2.10.4, it is not envisaged that the school will be required to teach in classes larger than 30.

4. OPTIONS

4.1 Considering the results of the consultations, the Executive can decide to:

4.2 All Saints' C of E Primary School (Ilkley)

a) Approve the stand alone proposal to enlarge the premises of All Saints' C of E Primary School (Ilkley) by increasing the capacity of the school premises from 315 to 420 from 1 September 2018 (subject to the grant of planning permission).

4.3 **OR**

b) Reject the proposal to enlarge the premises of All Saints' C of E Primary School (Ilkley) .(subject to the grant of planning permission).

4.4 4.6 **Poplars Farm Primary School**

a) Approve the stand alone proposal to enlarge the premises of Poplars Farm Primary School by increasing the capacity of the school premises from 210 to 420 from 1 September 2018.

OR

b) Reject the proposal to enlarge the premises of Poplars Farm Primary School .

5. FINANCIAL & RESOURCE APPRAISAL

- 5.1 Schools receive funding through the Fair Funding Formula which allocates funding to schools based on the number of pupils attending the school.
- 5.2. Basic Needs Funding would be used for expansion of the primary schools subject to approval and responses to the publication of Statutory Notices.
- 5.3 The estimated cost for the enlargement of All Saints' C of E Primary School currently stands at £2.1 million.
- 5.4 The estimated cost for the enlargement of Poplars Farm Primary School current stands at £3.6 million.

6 RISK MANAGEMENT

6.1 There are no significant risks arising out of the implementation of the proposed recommendations.

7. LEGAL APPRAISAL

The Local Authority has a duty to ensure there are sufficient school places in the District.

- 7.1 Statutory proposals are required for proposed enlargements of premises of schools where the capacity of the school is increased by both more than 30 pupils and by 200 pupils or 25% of the existing capacity, whichever is the lesser.
- 7.2 There is no longer a prescribed pre-publication consultation period for significant changes. However, statutory DfE guidance states that there is strong expectation on schools and Local Authorities that they consult interested parties in developing their proposals prior to

publication as part of their duty to act rationally and to take into account all relevant considerations. All responses received to such consultation must be considered in deciding whether to publish the necessary statutory proposals on the basis proposed.

- 7.3 At its meeting on 7 February 2017 Executive approved the publication of statutory proposals to enlarge the the premises of the schools by increasing their net capacities. Statutory proposals were published on 27 April 2017 with a four week Representation Period during which period any person or organisation could submit comments on or objections to the proposals to the Council to be taken into account by the decision maker. These will be considered by the Executive in its capacity as decision-maker when it determines the proposals at the end of the Representation Period. Excecutive can decide to reject, approve, approve with modifications, or approve subject to certain conditions e.g. granting of planning permission.
- 7.4 The following factors need to be considered in deciding whether or not to approve Statutory Proposals. The Executive should:-
 - be satisfied that: appropriate consultation and representation period has been carried out
 - all comments and objections received must be considered by the Executive
 - consider the quality and diversity of schools in the relevant areas
 - consider the demand for new school places
 - in assessing demand consider proposal admission arrangements
 - have regard to the Public Sector Equality Duty
 - consider impact on community cohesion
 - be satisfied that travel and accessibility has been properly taken in to account
 - be satisfied that any land, premises or capital required to implement the proposal will be available
 - consider if the schools will be able to fulfil the legal requirement that suitable outdoor space can be provided in order to enable physical education is provided to pupils in accordance with the school curriculum; and that pupils play outside. The provision may be fulfilled by access to suitable facilities off-site

8. OTHER IMPLICATIONS

8.1 EQUALITY & DIVERSITY

The Local Authority's admissions policy and admission criteria must not discriminate directly or indirectly against any group or individual. Equalities Impact Assessment was completed on 26 May 2017 (see Appendix H)

8.2 SUSTAINABILITY IMPLICATIONS

Any buildings works undertaken as part of these proposals will have an impact on sustainability in the district. The Local Authority will aim to ensure that development is undertaken in a sustainable way which minimises the future impact of the Local Authority's carbon footprint.

8.3 **GREENHOUSE GAS EMISSIONS IMPACTS**

The proposals would not impact on gas emissions. If children are able to attend their local schools this could lead to a reduction in emissions.

8.4 **COMMUNITY SAFETY IMPLICATIONS**

Concerns have been raised in relation to traffic and parking issues. The Local Authority will work with both Schools to try and mitigate any adverse impact on traffic and parking.

8.5 HUMAN RIGHTS ACT

There are no direct Human Rights implications arising from this report.

8.6 TRADE UNION

Trade unions have been informed of the proposals. The proposed enlargement of the schools may lead to an increase in staffing levels.

8.7 WARD IMPLICATIONS

Ward Councillors have been consulted about the proposed changes to the Schools in their wards

The total number of reception places available is currently 345, the actual number of first preferences for schools in this area for admission in 2016 was 321. However there do not this year appear to be any children applying from the new housing development in Menston compared with last year.

Ashlands, Burley Oaks and Menston Primary schools have already expanded to help meet the demand for places.

However these figures will not include children of families who may move into the new housing developments in this area. Families moving into the District are not always included in the information provided by the Health Authority as they may not register with GPs or Health Centres immediately they arrive particularly for the younger ages.

The school is on a sufficiently large site to allow modifications to be made to the buildings to increase its' capacity and for additional car parking spaces to be created. The Local Authority would work closely with the school to ensure that educational requirements continue to be met and for least disruption to be caused to the pupils and staff.

There would be no changes to admission arrangements for the school other than increasing the number of reception children allocated each year to 60 from September 2018.

The total number of reception places available is currently 330, the actual number of first preferences for schools in this area for admission in 2016 was 359. There have been particular pressure on Poplars Farm due to the new housing developments in the Canal Road area.

Fagley and St Clare's have already increased their PANs to help meet the demand for places in this area and a number of children have been admitted above PANs via the appeals process in some cases meaning larger class sizes.

Summary of responses to consultation on All Saints' C of E Primary School (Ilkley) expansion

Consultation was open between 2 November 2016 and 16 December 2016.

A total of 47 responses were received , one on 19 December which has been included. Where provided, these were mainly from local people living in the LS29 9 area of the District but also included Menston, Bingley, Heaton in Bradford and LS21 which is part of the Leeds District.

Summary of those agreeing with the proposal:

- Very good school with space to expand.
- Popular well performing school.
- Seems to be the obvious primary school in Ilkley to expand, the additional places would serve the community and cater for future increases in demand.
- The desire to respond to local community needs and the increasing population.
- Recent developments in the curriculum means there is a move to teach in actual year groups rather than mixed age range classes, the move to 2 form entry would aid this.

Summary of those against the proposal

- Traffic congestion. (concerns raised by those who agree or disagree)
- Parking and inadequate provision of drop off points. (concerns raised by those who agree or disagree), particularly commuter parking.
- Lack of space/facilities, existing building not safe to take more children.
- Loss of outdoor playing area as the outside space is limited.
- Not convinced additional places are needed.
- Alternative schools should be expanded.
- Disruption.

Summary of responses to consultation on Poplars Farm Primary school expansion

Statutory proposal for a prescribed alteration

Proposal to Enlarge the Premises of All Saints CE Primary School Ilkley

School and Local Authority details:

All Saints CE Primary School, Easby Drive, Ilkley LS29 9BE. This is a voluntary controlled school.

Local Authority - City of Bradford Metropolitan District Council, City Hall, Bradford BD1 1HY

Description of alteration:

The proposal is that the school should be enlarged to increase the capacity of the school premises from 1 September 2018. The proposal is to expand the school to 2 forms of entry to admit 60 children per age group.

The current capacity of the school is 315 pupils and the proposed increased capacity will be 420 pupils (ie 7 year groups of 60 pupils). The current number of pupils registered at the school is 321 which is above the school's measured net capacity due to the additional number of pupils admitted as a result of admission appeals.

The current admission number for the school is 45 pupils and the proposed admission number is 60 pupils. They will enter the reception year in September 2018 (aged four on 31 August 2018) and each following year until all age groups can admit 60 pupils.

No new or additional site is required for this change. Some additional building and/or remodelling of existing buildings will be required. This will be phased by agreement with the school, and be subject to the normal planning permission process.

Evidence of demand:

There are currently 345 reception places in the Wharfe Valley Primary School planning area with a total of 2415 places across all year groups. The planning area includes Ilkley, Addingham, Burley and Menston. All Saints CE Primary School is situated in Ilkley where the total number of reception places is currently 165 and the total number of places is currently 1155. The total number of pupils currently attending primary schools in Ilkley is 1185.

Forecasts using Health Authority data and demographic trends predict that the demand for reception school places will continue to increase over the next few years. All other schools in this area are already at capacity.

Consultation:

The Local Authority consulted interested parties and the consultation process started on 2 November 2016 and closed on 16 December 2016. A summary of the responses to the consultation is attached.

Objectives:

The objective of the proposal is to create additional capacity to accommodate the increasing demand for primary school places in the district caused by the growing local population.

The proposal would build on the good standards for teaching and learning already in place at the school and provide additional local places for local children without having any negative impact on other schools, academies and educational institutions in the area. This would also

increase parental choice in the area.

Implementation and any proposed stages for implementation:

Statutory proposal for a prescribed alteration

Proposal to Enlarge the Premises of Poplars Farm Primary School

School and Local Authority details:

Poplars Farm Primary School, Poplars Park Road, Bradford BD2 1LQ. This is a community school.

Local Authority - City of Bradford Metropolitan District Council, City Hall, Bradford BD1 1HY

Description of alteration:

The proposal is that the school should be enlarged to increase the capacity of the school premises from 1 September 2018. The proposal is to expand the school to 2 forms of entry to admit 60 children per age group.

The current capacity of the school is 210 pupils and the proposed increased capacity will be 420 pupils (ie 7 year groups of 60 pupils). The current number of pupils registered at the school is 213.

The current admission number for the school is 30 pupils and the proposed admission number is 60 pupils. They will enter the reception year in September 2018 (aged four on 31 August 2018) and each following year until all age groups can admit 60 pupils.

No new or additional site is required for this change. Some additional building and/or remodelling of existing buildings will be required. This will be phased by agreement with the school, and be subject to the normal planning permission process.

Evidence of demand:

There are currently 330 reception places in the North East 2 Primary School planning area with a total of 2301 places across all year groups. The total number of pupils currently attending the primary schools in this area is 2304.

Forecasts using Health Authority data and demographic trends predict that the demand for reception school places will continue to increase over the next few years. All other schools in this area are already at capacity.

Consultation:

The Local Authority consulted interested parties and the consultation process started on 2 November 2016 and closed on 16 December 2016. A summary of the responses to the consultation is attached.

Response to Poplars Farm Statutory Proposals.

Firstly, Poplars farm primary is one of the last remaining good standard primary schools in Bradford and the BD2 area. Increasing the size will only drop standards as this has been proven in the past with other schools. Higher class numbers will only result in students receiving less contact hours and therfore a decrease in overall results and standards.

My secondary concern is in regard to the traffic congestion already causing major problems on Poplars park Road. There is a major build up of vehicles at school times which is causing problems for residents and parents. Selfish drivers are causing dangerous conditions as they regularly park on yellow lines and zig zag lines outside the school.

By expanding the school the traffic situation will only get worse and cause more problems for residents and parents and in turn the school and council. I firmly believe increasing the school size will have a detrimental effect on traffic around already small roads.

Finally, I would like to advise that an increase on school size has financial implications also. With current budget cuts this will no doubt leave the school in a far worse position.

I believe expanding the school will cause un-necessary issues and therefore I am truly against this. Good schools like Poplars farm need to be saved from a drop in education standards by expanding them un-necessarily. Please take this into account when making a final decision.

I am a parent and local resident to Poplars Farm school and I wish to object to the proposal in expanding the school due to the following reasons:

- There is insufficient parking facilities and the school's travel plan has not indicated in any improvements to the mode of transport to the school. Despite allowing for further parking restrictions, this will only bring congestion to the residential area further away from the school. Parents will continue to bring children by car and doubling the capacity will almost have immediate adverse effect to the disruption caused by traffic.
- 2. The school access and egress is via the same road which requires all vehicles entering Poplars Farm Road to turn around and exit. There is no suitable provisions for this manoeuvre except a mini-roundabout which does not have sufficient swept paths for normal sized cars and situated on a gradient. One of the entries to the roundabout has frequently speeding vehicles as there are no traffic calming measures downstream.
- 3. The footways have insufficient width for the safe passage of mass pedestrians. There is a lack of maintenance on the overgrown vegetation on the verges which already reduces the footway width. I have raised this issue before with the council and the hazardous situation exists to this day.
- 4. No suitable pedestrian crossing provisions within Poplars Farm Road.

- 5. The highway alignment of the Poplars Farm Road causes severe intervisibility with crossing pedestrians and on-coming traffic combined with narrow lane.
- 6. Access to King's Road will possibly require part-time signals which would increase journey time and reliability for the wider road network.
- 7. The school is situated on a higher level overseeing the residential area. The sound levels of children during the breaks and lunch time is echoed which currently is not a nuisance but may again be exacerbated by doubling the capacity.
- 8. A larger school may attract further littering, an area for youths to congregate and potential trespassing violations which is not welcomed to a generally peaceful community.
