Item 8: SHIPLEY AREA NEIGHBOURHOOD POLICING TEAM ACTIVITY TO ADDRESS THE "SAFER COMMUNITIES" PRIORITIES WITHIN THE SHIPLEY CONSTITUENCY WARD PLANS FOR 2016/2018

Peter Allison: I am pleased to see the Speed Watch initiatives in Wilsden. Whilst realising that resources are limited would it be possible to provide more PCSOs for the Bingley Rural Ward?

Inspector Deacon: We have only had 1 new PCSO for Shipley this year and have 15 in total for the Area – 3 of which are allocated to Bingley Rural. We can swap PCSO around where required.

Peter Allison: Have you thought about using Parish Councils as co-ordinating groups for Neighbourhood Watch, especially those who have a Contact Point?

Inspector Deacon: The Neighbourhood Watch co-ordinator has considered this and will be contacting the Parish Councils in due course.

Sergeant Brearley: Contact Points are making a come-back.

### Item 9: PARKS & GREEN SPACES SERVICE ANNUAL REPORT

## **Presenting Officer: Ian Wood**

Pete Chambers: I would like to echo what Cllr Davies has said about consulting with the community with regards to 106 money. The Big Belly bins in Roberts Park are great, the handles were a problem at first but the foot pedals are an improvement. Bags are often left at the side of the bins but there are no signs on display to indicate where this can be reported to.

Ian Wood: We can maybe speak with Ian Dobson about using the notice board in Roberts Park to display a sign. I need to feed back the comments about consultation on 106 money.

Peter Allison: In paragraph 2.2.2 of the report Wilsden Park is not mentioned and Greenwood Park is actually in Bradford West. Who spent the 106 money from the Crack Lane development without consulting with us and where was it spent? We need to know.

Ian Wood: I can look into this and feed back to members.

Cllr Riaz: The money has not been spent yet and is held in a different account.

Joe Ashton: Over the last 10 years Baildon Town Council has been putting in seed money but this has now started to accrue. We have done a survey of play grounds in the town and have produced a report. There is a lack of co-ordination – for example we were not made aware that the playground at Roberts Park was about to be refurbished – it is not a watertight system.

lan Wood: We perhaps need to look at presenting a separate report for SIL and 106 monies and play areas.

# Item 10: CLEANER AND GREENER STREETS AND NEIGHBOURHOODS IN SHIPLEY – DEVOLUTION TO AREA COMMITTEE

#### **Presenting Officer: Damian Fisher**

Gianfranco Sabelli: Are there any plans to tackle chewing gum outside pubs and clubs?

Damian Fisher: We could try putting up gum boards but this is a very difficult issue to tackle. The new enforcement officers in the city centre have issued some fines for chewing gum.

Gianfranco Sabelli: Could you surcharge pubs and clubs?

Damian Fisher: We could look at this.

Gianfranco Sabelli: Could you discourage stores from selling cheap chewing gum?

Damian Fisher: This would be difficult.

Gianfranco Sabelli: Are you responsible for enforcing communal recycling bins?

Damian Fisher: No, Waste Management.

In terms of recycling may be trialling some new Big Belly recycling bins.

Gianfranco Sabelli: Could you remind people about their responsibilities with regards to

fly-tipping in the information that goes out with Council Tax bills?

Damian Fisher: This is something we could certainly look into.

Pete Chambers: Are the back alleys in Saltaire adopted or un-adopted?

Damian Fisher: We would need to look into this.
