Background information


1. The petitioners have requested:

"We the undersigned residents of Little Horton and surrounding areas request Bradford Council to act on our concerns relating to the absence of a formal crossing facility at the junction of Little Horton Lane and Melbourne Place. Many people including children and the elderly cross at this very busy junction to attend local places of worship, children's nurseries, community centres and three large schools. Crossing at this junction is very dangerous and we feel this is an accident waiting to happen. We urgently demand that the council take immediate action before a serious incident occurs."

- 2. Little Horton Lane is a busy route into the city centre that is subject to a 30mph speed limit.
- 3. There are two existing puffin crossings on this section of Little Horton Lane, at Howard Street (125m) and Woodville Terrace (200m).
- 4. There have been 4 recorded collisions on Little Horton Lane on the section between (and including) the two existing pedestrian crossing facilities in the last 5 years. These resulted in 7 casualties of which 2 were pedestrians.
- 5. Subject to a detailed survey and design process, the options for the provision of a crossing facility at this location include:
 - Pedestrian refuge island
 - Zebra crossing
 - Puffin Crossing
- 6. Pedestrian surveys have been commissioned and the results will determine whether or not a formal crossing facility would be appropriate. If this proves to be the case, a puffin rather than a zebra crossing would be recommended (to avoid a mixture of control methods given the two existing nearby facilities).

Recommendations

- 7. That, subject to the result of the pedestrian surveys, an appropriate item be added to the list of schemes awaiting funding from the Safer Roads budget.
- 8. That the lead petitioner be informed accordingly.
