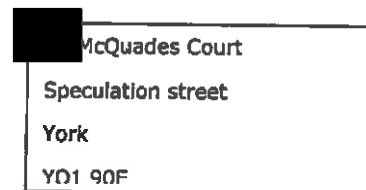


Appendix 2



To Whom it may concern,

I am writing to you to express my grievances regarding the proposed bar due to open on West Lane, Thornton.

I am a frequent visitor of the Thornton area and believe that the proposed premises licence, with the current recommended conditions, will be problematic. I worry that my elderly parents who live in this area may suffer consequences.

I deem it relevant to consider that there is already three licensed pubs serving alcohol in close proximities. I firstly ask you to consider the impact that another premises may have on Anti-Social behaviour in the area.

Secondly, I genuinely believe that the dynamics and immediacies of this property will encourage drinking on the causeway. The causeway is parallel to a busy corner junction, a junction that encompasses a tactile crossing. It is logical to believe that engagement with alcohol on this area will be problematic and disruptive to a busy road.

Thirdly, I hold the understanding that the proposed conditions are 11am until 2am. I ask that you consider the effects of this extensive duration with regards to a 14 hour time period and the effects alcohol consumption could have within this interval. I ask that you not only consider these effects regarding the individual, but also the local residents as Thornton is a heavily residential area.

Finally, I would like to highlight the disquiets concerning the older person's home that is approximately 25 yards from the bar. I ask you to consider the vulnerabilities that older people withhold, and the effects that loud noises and anti-social behaviour will cause to those with already deaerating health.

To conclude, I ask that you re-consider the proposed conditional license. I ask that from a risk management perspective all the above elements are analysed, subsequently I hope you will work towards reducing the consumption of alcohol in the village. I request that to decrease alcohol related Anti-social behaviour, the proposed conditions do NOT allow outside drinking, and the conditional time could be earlier, say 11pm. I would like to reiterate how this is a risk management issue, and I, as a frequent visitor, would not like to reap the consequences of a 2am curfew.

I write today in reference to the application made by Jane Jackson, in respect of the premises at number 1 west Lane Thornton Bradford BD13. For the sale of alcohol, & regulated Entertainment, & refreshment,

I have lived in Thornton for over 50 years at number 26 west lane BD13 3HX and have just recently moved to Clayton although visit Thornton almost every day, and throughout my living history have sadly been appraised of and been witness to a number of road traffic accidents at the bottom of west lane involving the most vulnerable in society the elderly and small children, In more recent years the local authority has constructed a tactile crossing just outside of the door of the proposed licenced premises, whereby all the pedestrian traffic wishing to enter the village from Thornton road have to use, although the crossing can only be considered to be an improvement and reduce tragic accidents accruing this still remains a very dangerous crossing point.

My concern is that patrons of the licence premises will ultimately spill out on the pavement outside plied with alcohol could prove to be intimidating to pedestrians particularly the elderly and the very young, I believe in some cases pedestrians rather than walk the gauntlet of inebriated patrons of the licence premises, would choose to take more dangerous alternative route, crossing over Kipping Lane and then walking along to Market street and then crossing back.

I therefore object in the strongest terms to this licence been granted on the grounds of public safety. and would hope common sense will prevail. Should this licence be granted and a child be killed or injured as a result of this it should be on your conscience.
