As you can see from the photograph, the shop is in the middle of a row of seven terrace houses. This is a residential row of terrace houses, with people that have young children, work shifts etc. You can also see all residents park considerately infront of their own houses, with no other places to park The proposed opening hours of shop, which is to be a newsagent/off license is -

MON - THU 08.00 am - 20.00pm

FRI - 08.00 am - 21.00pm

SAT - 09.00am - 21.00pm

SUN - 08.00am - 20.00pm.

This shop will cause major disruption to the life of all residents in the terrace houses. There will be noise from the shop 7 days a week from morning until night. This will be from, newspapers & stock being delivered, the door of the shop opening and closing by customers, the main issue will be customers parking infront of resident houses to use the shop. It is hard to appreciate the lack of parking on this section of Huddersfield Road unless you live here. Imagine bringing your young children home from school, unloading you food shopping, having to unload you worktools, elderly people having to walk 100 yards to their house in all weathers, because they can't park infront of their own house, because of the shops customers cars. Young children, infact all residents being kept awake from the noise created by the shop, it's customers and deliveries. Everyone of the residents feels strongly it is inappropriate and unfair for this shop to open as a grocer off licence, especially selling alcohol. I would also like to point out, the terraces are old, and the walls are paper thin, noise travels very easily. The shop has been used mainly as a sandwich shop, and recently a hairdressers. These kind of shops were not such a problem as, they opened after most residents had gone to work and, closed before they came home. This resulted in no parking or noise problems. An all week, all day and night grocer/off license is totally inappropriate for this shop. Please consider the residents, and refuse permission for use of this shop as a grocer/off license in this row of residential terraces. It will make like very difficult. Thank you.

Dear Sir / Madam.

With regard to the above application, I would like to formally register this email as evidence that the license should not be granted based on the following.

The terrace of which 650 Huddersfield Road is in the centre off, is a residential terrace with a number of young neighbours with families and older neighbours.

The granting of a license to allow a newsagents and off license would create a number of issues for neighbours and residents especially due to the early and late night opening times that have been requested. (Sunday to Thurs 08.00-20.00 and Fri / Sat 0800 - 21.00) Noise pollution would increase due to the unsociable trading hours and this would have a knock on effect for younger children whose bedrooms are facing huddersfield road for both getting to sleep and also waking up early. Litter may also become an issue, as there are no public litter bins in the area.

The sale of alcohol may also increase the likely hood that younger drinkers / teenagers may gather outside and sit on residents walls creating noise and also the possibility of intimidating behaviour towards residents. The shop has been broken into a number of times while it was a hairdressers and the stocking of alcohol and cigarettes may also be targeted by local criminals and burglars. A hairdressers located on the next terrace down from 650 has been broken into at least 3 or 4 times recently.

Value to properties would also likely suffer as who would want to buy a house close to a shop open all hours 7 days a week. Most shops trading alcohol during unsocial hours are not located in the middle of a residential row of terrace houses.

However, by far the biggest concern for neighbours and residents should the license be granted is parking. All the occupants on the row have cars and everyone parks with the upmost respect for their neighbours. If a license was granted to change the current hairdressers at 650 Huddersfield Road into a Newsagents / Off license, it would cause parking chaos, due to the lack of space. (Please see attached photographs highlighting the lack of space when all residents are home from work).

Previous business that have run from 650 Huddersfield Road have been as a Sandwich shop and Hair dressers. Parking in these cases was never an issue, because residents would have left for work before the businesses opened, and the businesses were closed before tea time as neighbours were coming home from work.

If a license was granted neighbours and residents would no longer be able to park outside their homes and would have to park a hundred or so yards down or up the road, causing problems for residents who live in this areas. Again, for young families, and older families, carrying shopping from a distance is not easy and none of the houses on the terrace have any off road parking. We are wholly reliant on parking outside the row.

Please also note there is a local newsagents, off license and Asda that sells alcohol and newspapers located on Towngate in Wyke village less than a 5 minute walk away from the terrace. Locals would continue to use these premises as they are closer, which leaves passing traffic driving up and down Huddersfield road as possible customers, again adding to the noise pollution and parking chaos.

Asda in the village is a prime example of this and they have now employed the services of a security guard to try and alleviate some of the problem.
