Bradford City Centre Parking Review

Bradford Council is proposing to implement amendments to on-street parking in the city centre as agreed as part of the 2019/21 budget.

The amendments are as follows:

- The extension of on-street charging hours from 8.00am to midnight all days.
- The increase of on-street charges from 70p to £1 per hour between the hours of 8.00a.m to 6.00p.m. all days.
- A standard charge of £1 per stay between 6.00pm and midnight all days.
- A Maximum stay period of 2 hours will still apply between 8.00am and 6.00pm all days.

ISSUE: Following agreement by Full Council of the 2019/21 budget, it is proposed to make amendments to the parking charges and charging hours for on-street pay and display bays within Bradford city centre, with the changes to be introduced by the start of the 2020 calendar year.

The proposals are to extend on-street daily parking charging hours from 8a.m to midnight Monday – Sunday, with a charge of £1 per hour (2 hour maximum stay) between 8a.m and 6p.m and a flat rate charge of £1 between the hours of 6p.m and midnight.

PROPOSAL: To consult on amendments to the parking charges and charging hours for on street pay and display bays within Bradford city centre. Following consultation, a Traffic Regulation Order to be prepared and advertised. Should no objections be received, then the proposed amendments be implemented. If any objections received cannot be resolved then the matter be referred to the Portfolio Holder - Place for resolution.

SUPPORTING INFORMATION: The amendments to the parking charges and charging hours for on-street parking within Bradford city centre will continue to create a turnover of parking spaces for shoppers and other visitors.

In the context of the night time economy, introducing a £1.00 evening charge when compared to the cost of a meal etc is unlikely to deter visitors.

The increase of parking charges and extension of charging hours are in line with schemes in other neighbouring local authorities, with Bradford continuing to remain cheaper than neighbouring authorities.

REPRESENTATIONS: Any objections received to the advertisement would initially be reviewed to see if there were ways to overcome the objections raised. Remaining objections would be presented to the Portfolio Holder - Place for resolution.

OTHER CONSIDERATIONS: None.

DETAILED ESTIMATE: Detailed estimate not yet available, but costs will include new sign plates, upgraded software for pay and display machines and for preparing and advertising the Traffic Regulation Order. The costs will be absorbed within the Parking Services budget.
