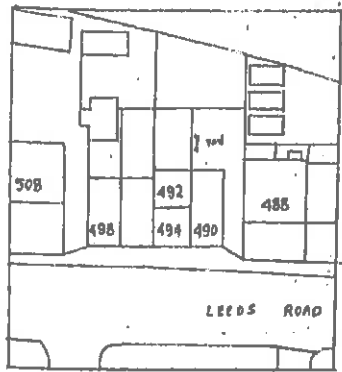

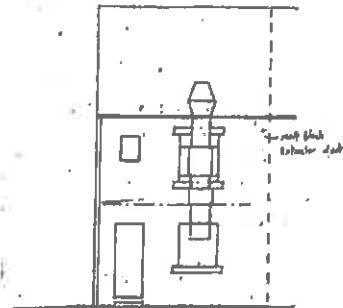

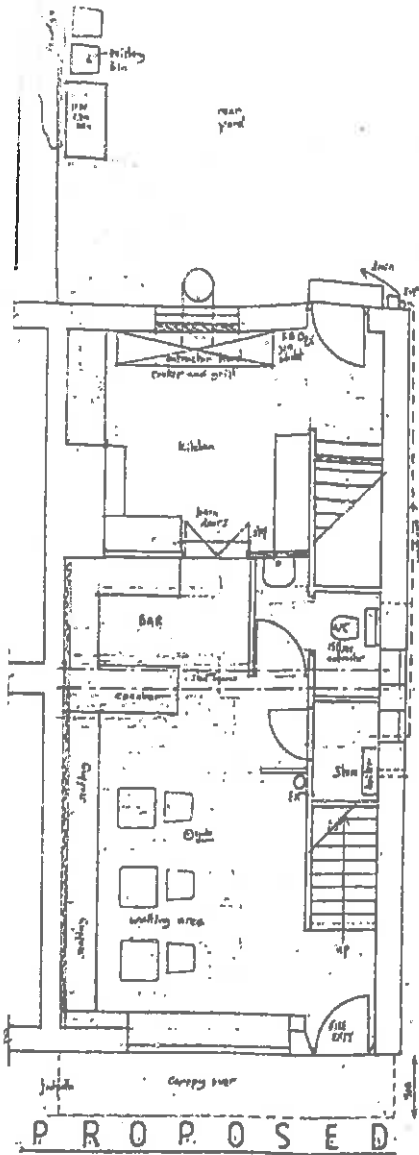

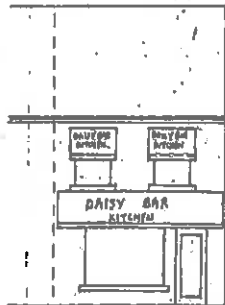
SITE PLAN 1:500
