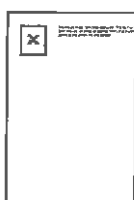

With reference to the above, I write to inform you that I have received a representation to the application from the West Yorkshire Police .

In order to address the prevention of crime and disorder objective, the police have requested that the following conditions are placed on the licence;

1. CCTV will be provided in the form of a recordable system, capable of providing pictures of evidential quality in all lighting conditions. Cameras shall encompass all ingress and egress to the

premises and all areas where the sale/supply of alcohol occurs. Equipment must be maintained in good working order, be correctly time and date stamped, be kept for a period of 28 days and be available to responsible authorities on request.

2. All staff, including temporary staff, to be fully trained in the Licensing Objectives and be able to demonstrate a working knowledge. All training to be documented and this is to be made available for inspection by Responsible Authorities. Refresher training to be completed every 12 months from initial training.

Please inform me in writing, within 7 days of the date of this email, if your client agrees to the above or wishes to amend the application.

If I do not hear from you I will assume that your client does not wish to amend the application, or have these conditions attached to the Premises Licence and the matter will be referred to Members of the Licensing Panel for their consideration. Further details regarding this will be forwarded to you, if a meeting is required.
