

To Bradford Licensing

We the undersigned, wish to make a representation re the 4 licensing Objectives in relation to the application for a new premises licence at 54-60 Sunbridge Road, BD1 2AB

- 1) The Prevention of Crime and Disorder, The number of people with live Entertainment and the situation of the premises we feel will attract the misuse of Drugs, also it is wildly publicized that this application although new is to move a premises from Barry Street, which has been renowned for being involved in violence and fighting breaking out on the Street outside of the premises, the new building is said to hold 600 people, and will be a nightmare when the premises close, causing criminal damage to nearby businesses and local residents property
- 2) Public Safety, the premises is to operate over two floors, and will involve a large amount of entertainment, it will be very hard to ensure safety inside the premises, and also outside as the premises are on a busy Junction, one part being one way, and double yellow lines along both roads. It will not be safe for taxis to pick up or drop off fares and will cause danger to members of the public due to large numbers both arriving and leaving the premises. It would need a very heavy presence of door staff, on both floors and outside the premises to keep control of people waiting to enter, door staff will need to be of both sexes in order to carry out drug and weapon searches. We don't believe the applicant will fulfil his duties to ensure safety.
- 3) The prevention of Public Nuisance, we cannot see this condition not being broken, noise from people entering and leaving, noise from entertainment, the premises have a lot of windows is the applicant going to sound proof the premises so that local residents and other businesses will not be disturbed up to 6.00am, the business being transferred has a bad reputation, we the local businesses and residents do not want Public Nuisance every day and this is what we will get if this application is approved.
- 4) The Protection of Children from harm. Although a compulsory age check will need to be in place, we do not believe it will be carried out, and the risk of underage drinkers is too great amongst 600 customers, we also not it is to open through the day, it will need a strong policy regarding children during the daytime, will door security be in place.

On a point of policy, we do not feel only one notice displayed has not given everyone the opportunity to object, this is displayed on Kirkgate, but nothing on Sunbridge Road which is the address of the application. we believe in the legislation it needed more than one notice, also legislation states the application must be displayed on Blue notices, this is one notice on white and does not fulfil the legality of the application, and should start again with proper notices correctly displayed on the right coloured paper.
